Enumerators of the 1820 census were asked to include the following categories in the census: name of head of household, number of free white males and females in age categories: 0 to 10, 10 to 16, 16 to 18, 16 to 26, 26 to 45, 45 and older; number of other free persons except Indians not taxed; number of slaves; and town or district and county of residence. Additionally, the 1820 census for the first time asked the number of free white males 16 to 18; number of persons to be naturalized; number engaged in agriculture, commercial, or manufacture; number of "colored" persons (sometimes in age categories); and number of other persons except Indians. The categories allowed Congress to determine persons residing in the United States for collection of taxes and the appropriation of seats in the House of Representatives. Most entries are arranged in the order of visitation, but some have been rearranged to appear in alphabetical order by initial letter of the surname. Manufacturing schedules are scattered among the 1820 population schedules.

For the first time enumerators of the 1850 census were instructed to record the names of every person in the household. Added to this, enumerators were presented with printed instructions, which account for the greater degree of accuracy compared with earlier censuses. Enumerators were asked to include the following categories in the census: name; age as of the census day; sex; color; birthplace; occupation; value of real estate; whether married within the previous year; whether deaf, dumb, blind, or insane; whether a pauper; whether able to read or speak English; and whether the person attended school within the previous year. No relationships were shown between members of a household. The categories allowed Congress to determine persons residing in the United States for collection of taxes and the appropriation of seats in the House of Representatives.

SMITH COUNTY, TENNESSEE – Golman Dohono/Donaho

**G. D. Alexander**, merchant, was born in Smith County, in June, 1849, and is one of nine children of J. L. and Sarah D. [Donaho] Alexander. The father, Scotch in origin, born in Smith County in 1818, has been a physician near Dixon Springs for forty-six years, and is also a farmer, possessing about 500 acres of the Cumberland River bottom lands, one of the finest farms in the county. The mother, French in ancestry, was born in Sumner [now Trousdale] County in 1829. Educated chiefly at Dixon Springs, our subject began merchandising at nineteen years of age in Smith County, continuing about three and a half years. For five years then he was employed by Jos. T. Thompkins & Co., dry goods, Louisville, Ky., and then before engaging in his present business at Dixon Springs, he spent four years on his father's farm. In December, 1885, he married Bettie, daughter of Jas. and Clarissa [Bravard] Crenshaw, and born in what is now Trousdale County, in 1863. Mr. Alexander is a Democrat, and his wife is a member of the Christian Church.

William Walton, original proprietor of the site of Carthage, settled, according to best information, on the north side of the Cumberland, opposite the mouth of Caney Fork in 1787. He is said to have been the first settler in the territory now composing Smith County. Daniel Burford, **Richard Alexander**, Tilman Dixon, William Saunders and Peter Turney were among the first settlers in the vicinity of Dixon Springs.

**The best agricultural lands being in the vicinity of Dixon Springs, that locality soon became the most thickly settled one in the county.**

**Smith County was organized in accordance with an act of the General Assembly of the State, passed October 26, 1799**, providing “That a new county be established by the name of Smith, to be contained within the following described bounds: Beginning on the south bank of Cumberland River, at the south end of the eastern boundary of **Sumner County**; thence north with the said eastern boundary to the northern boundary of the State, and with the said boundary east to where it is intersected by the Cherokee boundary, run and marked agreeably to the treaty of Holston; thence with that boundary to the Caney Fork of Cumberland River; thence with said fork, according to its meanders, to the mouth thereof; thence down the south bank of Cumberland River, according to its meanders, to the beginning.” **According to this description Smith County originally contained a portion of what is now Trousdale, DeKalb, Putnam, Jackson, Clay and the greater part of Macon Counties.** By an act passed November 6, 1801, the county was changed in size by attaching to it a large portion of Wilson County, lying south of the Cumberland River and west of Caney Fork, and by cutting off a portion on the east side to constitute the county of Jackson. And by a subsequent act of the same session of the Legislature Smith County was extended southward to the line between Tennessee and Alabama—thus causing the county to embrace a strip of territory extending from the northern to the southern boundary of the State. In 1805 an act was passed to reduce the county to its constitutional limits of 625 square miles, still allowing its northern boundary to reach the Kentucky line. And by an act passed January 18, 1842, the northern portion of Smith County became a part of Macon County in its formation. And in 1870 a tract in the northwestern part of the county was cut off to form a part of Trousdale County. And thus by these and other acts of the Legislature Smith County has been reduced to its present limits, embracing about 360 square miles. **In accordance with the act of creation the first bench of justices of the peace for Smith County, consisting of Garrett Fitzgerald, Wm. Alexander, James Gwinn, Tilman Dixon, Thomas Harrison, James Hibbetts, Peter Turney and Wm. Walton, met at the house of Tilman Dixon, near Dixon**

Enumerators of the 1870 census were instructed to record the names of every person in the household. Added to this, enumerators were presented with printed instructions, which account for the greater degree of accuracy compared with earlier censuses. Enumerators were asked to include the following categories in the census: name; age at last birthday (if a child was under one year of age, months of age were to be stated as fractions, such as 1/12); sex; color; profession; occupation or trade of every male and female; value of real estate; place of birth; whether mother and father were of foreign birth; whether born or married within the year and the month; those who could not read; those who could not write; whether deaf, dumb, blind, or insane or “idiotic”. No relationships were shown between members of a household. The categories allowed Congress to determine persons residing in the United States for collection of taxes and the appropriation of seats in the House of Representatives.

**Dona Anderson md John Oliver "Doc" Leftwich , born 22 July 1881 – d. 1956.** Dona was his second wife. They had 3 children Wm Clarence, b. 14 Mar 1917 md Willie T. Boatman, Clyde Cecil b. 6 Mar 1919 md Eutherie Nixon, Betty Jo, b. 18 Jan 1921 md Alfred Bush. John Oliver Leftwich died 21 Nov 1956. **His first wife was Annie Moss, his 3rd wife was Elizabeth P. “Lizzie” Moss**, b. 1903 – d. 1983. He's buried beside her in Crest Lawn Cemetery, Putnam Co., TN. John O. has other children listed in his OB, but am not sure if some could belong to the other 2 wives.

**ERATH, TEXAS.** Erath was on Farm Road 1637 six miles northwest of downtown Waco in north central McLennan County. It was founded before 1860 and named for George Bernard Erath.<sup>9v</sup> By 1880 the settlement had a gristmill and a general store. At its peak, it also had two churches, a school, two cotton gins, and a blacksmith's shop. Erath had a post office from 1896 to 1907, when mail for the community was rerouted through Waco. The Erath school was consolidated with several others in 1917 to form the China Spring district. A few scattered houses marked the community's location on county highway maps in the 1940s. The population of Erath was reported at fifteen in 1900, forty-seven in 1911, twenty-four in 1931, and fifty in 1949 and from the 1960s through the mid-1980s. By the end of the 1980s, much of the area had been annexed by the city of Waco.

**Reuben Alexander Family written & compiled by Louis H. Gill:**

Reuben/Reubin – b. 1794, NC – d. 1855, TN married about 1817, Elizabeth Johnson – b. 1802, VA – d. 1850, TN. Reuben was 23 and Elizabeth was 15 when they got married. They had their first child a son, Thomas “Tom” Alexander about 1818. They had children every couple of years until at least 1848 when they had at least 14 children, which showed up in the 1820, 1830, 1840 & 1850 US census records – recorded in the 16<sup>th</sup> District of Smith Co., TN (later DeKalb Co., TN). In the 1854-55 Poll Tax Record for Putnam County, TN at it's inception, Reubin is listed as owning 100 acres & no slaves: Tax .64 ½ cents. In the 1820 census he had 1 male slave 14-26 yrs. old & none in 1830 or thereafter. In 1850 census his land is valued at \$300.00. The family story relates that his son James A. “Jim” Alexander later owned this farm, which probably included the land where I was born (*Louis Huston Gill, born on Wolf Creek, DeKalb Co., TN*). The DeKalb County & Putnam County line ran through this farm and it was in Smith County, TN until 1850. This farm was located southwest of Silver Point, TN which is on I-40 about 15 miles southwest of Cookeville, TN on Wolf Creek.

When my Ggrandmother, Michael Martelia “Mica” Elizabeth Alexander, b. 26 June 1842, Wolf Crrek, TN, was about 4 years old and playing in a fence corner by her home, her two older brothers came and picked her up and said that they were going to Texas to fight in the war. She never again saw the one called Captain Thomas “Tom” Alexander. Thomas was killed fighting in the Mexican War and was buried on the Rio-Grande, TX. At a later date General Sam Houston showed her two brothers, Joseph & Richard Alexander the grave. Joseph & Richard Alexander settled in Texas and lived there the rest of their lives. My Aunt Audra Camilla Anderson Denny who md Virgil Timothy Denny said that Joseph “Joe” lived near Dallas, Texas and did very well and had 2 daughters, Fannie & Wincie who were very pretty.

In the 1860- census Michael was 17 yrs. old living with her sister, Martha J. Alexander who was married to Robert S. Alcorn Sr. & his family. Living near her was her future husband, Riley Anderson. Riley Anderson was living with the family of Garland Bartlett. Michael Alexander made several trips to TX to see her brothers Joseph “Joe” & Richard “Rich”, as died her son Lewis Monroe Anderson, grandfather of Lewis Huston Gill. Lewis Monroe Anderson brought a farm near Dallas, TX but his wife, Matilda Isabelle Wallace wouldn't leave TN.

Michael's sister Louisa was already married to his Uncle Thomas Shirley Anderson Jr. Nancy B. 31, was living in DeKalb Co. with her grandfather John Johnson, 85 - b. ca. 1775, PA -d. ca. 1860, DeKalb Co., TN who md Mary (Stockard/Reece) Johnson - b. ca. 1785 - d. ca. 1850. John's personal property value was \$200.00. Reuben Alexander doesn't appear in the 1860 census we can presume he died.

The 1850 census of Smith Co., TN shows by film and book a Richard Alexander 80 born in NC with a \$10,000 estate living with James L. Alexander and family. Reuben is 56 yrs. old at this time, so it is of all probability that this Richard Alexander is his father.

The 1860 census shows Elizabeth Alexander and 2 of her children, Lewis D. Alexander & Francis Alexander Russell. This is probably the same farm that they lived at in 1850, owned by Reuben B. Alexander.

Cabarrus Co., NC record shows marriage bond 6 May 1794 of Reuben Alexander to Mary Garrison. Hezekiah Alexander, bondsman. Richard Alexander could have gone by the nickname of "Reuben".

Lewis D. Alexander went to South America or Klondike on a ship and was never heard of again.

Since Joseph & Richard Alexander are not listed in the 1860 census of TN they probably settled in TX which was being heavily settled at this time after the Mexican War had ended.

On page 680 of the "Book of Jared: by Eleanor Hall dated 16 June 1828 it shows **R. B. Alexander** as one of the singers of an invitation in honor of Andrew Jackson. I believe at 18 yrs. of age he is still in NC.

James Raulston was a colonel in the Revolutionary War. He was in the Battle of New Orleans. Born 16 June 1778, md 8 January 1802 in Jefferson Co., TN to Jane Simmons. He died 7 August 1844 in Jackson Co., AL. He was at one time State Senator of Alabama. He received the following interesting invitation in June 1828:

"The Pleasure of your company is respectfully solicited to a ball to be given at Captain Daffy's in Hartsville on the 5<sup>th</sup> of July in honor of our distinguished fellow citizen General Andrew Jackson.

The county of Smith is bounded north by Trousdale and Macon Counties, east by Jackson and Putnam, south by DeKalb, and west by Wilson. It lies mostly in the central basin, and is drained by the Cumberland River, which flows through it from east to west, and so divides it as to leave about three-fourths of its area on the south side, and the other fourth on the north side. The tributaries flowing into the Cumberland from the north are Peyton Creek and Defeated Creek, and other smaller streams. The principal one flowing into it from the south is Caney Fork, which is navigable for small vessels about forty miles from its mouth, which is just above the town of Carthage. The spurs of the Highland Rim extend far into the county from the north and east, thus making that part lying north of the Cumberland and east of Caney Fork extremely hilly and uneven. The balance of the county has a more even surface. The streams have broad valleys, and the "the soil of the county, with the exception of the caps of the ridges, rests everywhere on limestone belonging to the Nashville and Lebanon formations, but principally the former. The tops of the ridges present the siliceous rocks of the highlands, being the sub-carboniferous. Immediately below these siliceous rocks, and separating them from the limestone, is the black shale formation."\* ["Resources of Tennessee."] The lands having a limestone soil are rich and productive, and those on the highlands produce an excellent quality of tobacco, but the yield is light. The timber is similar to that of Trousdale County.

William Walton, original proprietor of the site of Carthage, settled, according to best information, on the north side of the Cumberland, opposite the mouth of Caney Fork in 1787. He is said to have been the first settler in the territory now composing Smith County. **Daniel Burford, Richard Alexander, Tilman Dixon, William Saunders and Peter Turney were among the first settlers in the vicinity of Dixon Springs.** Peter Turney was the father of the noted lawyer, Hopkins L. Turney, and grandfather of Judge Peter Turney, now of the supreme bench of the State. The best agricultural lands being in the vicinity of Dixon Springs, that locality soon became the most thickly settled one in the county. Micajah Duke was an early settler in what is now the Second District; David Apple in the Eight; William McDonald in the Eleventh; Armstead Flippen in the Thirteenth; William Goodall, and James Hodges, with his son Richard, and Arthur S. Hogan in the Fourteenth; and Zachariah Ford in the Fifteenth. Other early settlers were David Cochran, John Baker, Thomas Dies, George T. Wright and also all persons hereinafter mentioned in connection with the organization of the county. "The grandfather of S. M. Fite, with his family, and two other men, with their families, made the first settlement on Smith Fork, fifteen miles south of the Cumberland River. The first night after camping Mr. Fite had family worship, no doubt the first Christian worship ever made in the vast region.\* ["Resources of Tennessee.]" When the first settlers appeared in Smith County, they found the territory inhabited with Indians, and many kinds of wild animals, such as bears, wolves, panthers, wild-cats, deer, etc. Wild game was also abundant, and those hardy pioneers, during their struggles to subdue the forest and establish civilization in a vast wilderness, often supplied their families with meat secured by means of their rifles. Bear meat, venison and wild fowl were then common articles of food. The Indians were here about ten years after the first settlers located, and during this time the pioneers, no doubt, had many encounters with them; the history of which, unfortunately, has not been preserved. One incident which occurred in this county before it was settled, between citizens of Sumner County and the Indians, may be related here. "In February, 1786, John Peyton (father of the late Hon. Bailie Peyton); Ephraim Peyton, his twin brother; Thomas Peyton, another brother; Squire Grant and John Frazer were out hunting and surveying. They encamped on an island in Defeated Creek, near where Capt. C. N. West now resides. On Sunday night they sat up late playing cards, when they were attacked by the Indians. Four out of the five were wounded—all except Ephraim Peyton. They separated and fled leaving their horses instruments. The Indian party was commanded by Hanging Maw. All made their escape and survived, and the next year John Peyton sent word to Hanging Maw to return the stolen horses, to which the chief replied, 'that the horses were his, that he (Peyton) had run away like a coward and left them, and as for his 'land-stealer,' the compass, he had broken that against a tree.'" \* ["Reminiscences of Gen. William Hall."] Robert Smith and Lucy Gordon were the first couple married in Smith county, and Richard Hodges and Delilah Risen the second. The latter were married by Arthur S. Hogan, Esq, in 1803.

Dixon Springs, February 15, 1812: To Brigadier General James Winchester

Sir,

**We the undersigned, most of whom served in the late revolutionary war**, have for year past, seen, with deep concern our national rights violated and outraged to an enormous extent, by the great belligerents of Europe, and we have seen at the same time, a disposition manifested, in every act of our government, to obtain, in an amicable and conciliatory manner, redress for those abuses and to prevent a continuance thereof. To this end, negotiation as it respects one of those powers (Great Britain) has been exhausted in vain. That proud and unprincipled nation, instead of attending to and removing our just causes of complaint, have continued to multiply our grievances, and add insult to injury. In this state of things, longer forbearance would be unpardonable: and we rejoice to see that congress has determined or a different course of measure which promises to cause our rights to be respected in future, and in pursuance of which we conceive war to be inevitable. In ;that events it is probable that the whole strength may be require to ensure success; and that the active part of our force may be occasionally called to distant service, which. Afford to the disaffected, (if any there should be among us) an opportunity of doing much injury to the defenseless. Therefore for the purpose of defending the property of our younger brethren, while they are fighting our battles abroad, and to oppress and put down any combination which may manifest itself inimical to our government we have embodied into a company under the command of Maj. Tilmon Dixon, to be denominated the Smith County Revolutionary Volunteers; and in that way and for the purpose aforesaid, do through you, Sir, tender our services to our country. In doing this we feel a pride in offering ourselves a second time on the "altar of liberty." Although with the fatigues of the war, and the wear of many years since our bodily powers are much impaired, yet our zeal for our county's good is not abated. We have a greater degree of confidence that our services will be well directed, when we remember that we are to act under your command. Yes, sir, to be commanded by one who participated in the toils by which our rights were procured, and who knows how to appreciate the services of the man of that day, inspires us with renewed vigor.

In reviewing the scenes through which we have passed and anticipating those which may remain to be unfolded there are sensations produced in us, more easily conceived of, than expressed. With a consoling hope and belief that our sons are zealous to maintain, at every hazard those blessings which we with others obtained, at the expense of so much blood and treasure, toil and suffering, and that this is best of heavens gifts to earth may be perpetuated to the latest posterity is our most fervent prayer. And should it be the purpose of him who rules the destiny of this land, to spare us to see our beloved country safely and honorably delivered from her present difficulties and the olive branch once more spreading over all our borders, we will then retreat to our respective quarters, and lay our wearied heads on the pillow of rest, and our gray hairs will go down to the grave in peace. We cannot willingly conclude this address without declaring our high confidence in the public functionaries of our country, we believe that they have done every thing that human wisdom could devise and moral virtue approve, to maintain our rights and save the country from the calamities of wars but finding from experience that every effort to accomplish those desirable ends, has failed of success, their having assumed a higher and more dignified attitude meets our approbation; and in the prosecution of which we pledge ourselves to support them, at the hazard of our lives, our property and our sacred honor.

We are dear General, with sentiments of due respect and high consideration your friends and brother soldiers.

Located just off Campbellsville Pike, about nine miles south of Columbia. It is just behind the old Reece's Chapel building that is not being used, at present, as a church meeting house. On the gatepost at the entrance is a plaque inscribed with the following: "Hark from the tombs

-- a doleful sound. My ears attend the cry; Ye living men come view the ground, where you must shortly lie. --1825." This data might be the date when the gateposts were erected, or the cemetery dedicated since the date on the earliest tombstone is earlier. 1814.

#### Genealogical Notes:

**ALEXANDER, Charles:** is thought to have been interred here but there is no stone to confirm this theory. It is fairly evident, however, that many of the older stones and box tombs that once marked grave sites in this cemetery have decayed or been destroyed in past generations. The subject of this item was born 4 January 1755 in North Carolina and served in the Revolutionary Army at various times from 1777 to 1781. he remained in Mecklenburg Co. until 1814 when he moved to Tennessee. At the time he applied for a pension, in 1834, he was living in Mary Co., TN. It is not known when he died but it was between 1830 and 1840 as he did not then appear on the 1840 Census of Pensioners.

**ALEXANDER, William,** native of Cecil Co., MD, was born 30 January 1745 into the home of Daniel & Prudence Alexander. At about the age of five, his parents took him to Mecklenburg Co., NC where they resided in an area that later became Cabarrus Co. During the Revolutionary War he served as a Lt. in the North Carolina line. For this service he received a land grant from the state of NC in 1790 and shortly thereafter moved to Sumner Co., TN. By 1807 he had migrated to Maury Co., TN. In the matter of religion the family was Presbyterian and were members of Ebenezer (Reese’s) Presbyterian Church. William married Esther/Easter Brown about 1770 and they had ten children. He died 31 May 1820.

#### Historical Notes:

The history of Ebenezer Presbyterian Church had its beginnings in Scotland, passed through Mecklenburg County in North Carolina and crossed the mountains into Tennessee as early as the 1790’s. The love of liberty ran so deeply in the veins of these pioneers that many of them took up arms during the Revolution and fought to drive the British from American shores. As a reward for their efforts, the state of North Carolina awarded many of these veterans areas of land in its western counties. Although it was not legally permitted to settle in the area south of Duck River until 1805-1806, it is certain that a few hardy souls risked both Indian and government to carve out a homestead in the new territory.

By 1805 the families of John Matthews, John Baldrige, William Henderson, James Hannah and others were living in the area of Tombigby (Little Bigby) Creek, near the old Trace, used by Indians from Alabama on hunting expeditions into Tennessee region. These pioneers, staunch in the traditions of their faith, provided a meeting house for the preaching of the Gospel along with shelters to house their families. Ebenezer Church was certainly one of the very first churches to be organized in the area. We are not sure when the official organization took place but the date 1805 is the one that someone burned into the cover of the first book of church minutes.

**Land for a more permanent building was donated to the church trustees by Revolutionary veteran James Reese.** This structure, in the shape of a cross, was built just west of where the cemetery is now located. This old log building burned in 1885 and a new one was erected, the present one, on the opposite side of the cemetery, which is closer to Campbellsville Pike. This church continued to function up to the 1950's but then, due to a declining membership, was disbanded. It is still maintained by an association formed to provide for the preservation of the cemetery.

**REESE, James**, born in Pennsylvania on 7 September 1745, moved to Anson Co., NC about 1753. the family lived in a section of the county that later became Cabarrus Co. **His father, David Reese, signed the famous Mecklenburg Declaration of Independence.** James served as Captain in the NC Militia and was also Tax Collector for his county. He was married to Elizabeth Brevard while still in the Old North State and in 1788 migrated to Sumner Co., TN. There he was active in public life and were charter members of the Shiloh Presbyterian Church. In 1793 he received a grant of 5,000 acres of land in what was to become Maury Co. and removed to this property soon after it was opened to settlers in 1806. He donated two acres of land for the building of a meeting house and cemetery. This became Ebenezer Presbyterian Church. He died on 17 November 1828 and his wife followed on 27 August 1831. They are both buried here in the cemetery, the land for which he had donated. It is not known whether or not their graves were marked with stones, but today only a new government military marker indicates the probably final resting place of this old soldier.

Pg. 143: NORTH CAROLINA MARRIAGE BONDS (1741-1868).

North Carolina marriage bonds were statement of intent for couples who planned to wed. The prospective groom took out a bond from the clerk of the court in the county where the bride had her usual residence as surety that there was no legal obstacle to the proposed marriage. One or more bondsmen signed the bond with the groom to guarantee the bond fee should the marriage prove illegal.

The North Carolina Division of Archives and History has on file the marriage bonds in two indexes, one by groom and one by bride's surname. After 1851 a marriage certificate was sometimes filed with the bond and the information also appears in the abstract.

**DUST COVER BACK PAGE:** This book is aimed at genealogists with Texas roots, genealogists in search of missing ancestors (perhaps they did "Go to Texas"), and also readers interested in Texas and local history.

The *Telegraph and Texas Register*, was born at the same time as the Texas Revolution, chronicling the momentous events of that conflict for its "Texian" subscribers. In the days of the new Republic of Texas, it emerged as the Texian national newspaper. Its pages were filled with news of murders, fatal encounters with Indians and Mexicans, unusual deaths, marriages, probate proceedings, and ordinary events of the new Republic. The gleanings of genealogical information document thousands of events that can often be found nowhere else. This information will provide family and local historians with important source material. It will also assist researchers who have been hampered by the loss and destruction of county records, as well as the absence of 1830 and 1840 Texas censuses. Finally, this volume helps to document elusive folks who sought to avoid either creditors or the law by "going to Texas."

The index has 10,000 references to individuals and a place name index with references to hundreds of towns, cities, counties, forts and frontier settlements (2,000 references). The book also includes a separate index to slave names.

Kevin Ladd has served as director of the Wallisville Heritage Park, a genealogy research center in Chambers County, Texas, since 1981. He is also chairman of the Liberty County Historical Commission and a longtime member of the Texas State Historical Association, the East Texas Historical Association, and other such organizations. He is the author of two books on Chamber County history.

## **INTRODUCTION:**

The *Telegraph and Texas Register*, was born on October 10, 1835, in the midst of the developing Texas Revolution. It was the first, Texas Newspaper to achieve any measure of success and quickly became the official journal of the new Republic of Texas.

Founded in San Felipe de Austin, its first editors were Gail Borden Jr., Thomas H. Borden, and Joseph Baker. The advance of Mexican soldiers under the command of Antonio Lopez de Santa Anna prompted the editors to flee after publication of their march 24, 1836 issue, and

Baker left the firm to join the army. The editors next moved to Harrisburg in April, when it was seized by the Mexican forces. The printing press was tossed into Buffalo Bayou. Another press was obtained and publication was resumed at Columbia on August 2, 1836. So long as the government remained in Columbia, the *Telegraph* remained there as well. It moved to the new capital, Houston, in April 1837.

The newspaper changed owners, with Thomas H. Borden selling his interest to Frances Moore, Jr. on March 9, 1837. Gail Borden Jr. sold his interest to Jacob W. Cruger on June 9. Moore operated the editorial end, while Cruger took the financial management side of it. The paper operated under this format until 1851, at which time Cruger sold all of his interest to Moore.

The *Telegraph* eventually had any number of competitors, but no one quite challenged it as the national paper of the Republic of Texas.

The pages from which these genealogical abstracts have been gleaned are rife with error and mangled spellings. I have not attempted to correct such mistakes, save for a few instances where correct names are added in brackets. Kevin Ladd, Director, Wallisville Heritage Park, P. O. Pg. 7: INTRODUCTION:

Sumner County, Tennessee was formed in 1786, ten full years before Tennessee became a state in 1796. It was originally a part of North Carolina. Later, it became a part of *The Territory South of the River Ohio*. With the exception of a few tax lists, most of Sumner County's court records are intact. The records, which date from 1796, include wills, lawsuits, court transcripts, settlements, inventories, guardianships, depositions, deeds and other papers relating to the daily business of the county. Years ago, these original documents were moved from the county courthouse to the Tennessee State Library and Archives in Nashville for preservation. Although preserved, these records were not catalogued, indexed or available to the public. The court transcripts contain all of the fascinating details of each case – a gold mine of information for the genealogist and historian! It was my determination that these records be made available to the public.

A client and Sumner County Commissioner L. H. "Dink" Newman, was instrumental, along with the noted Sumner County historian, Walter Durham, in obtaining permission from County Executive Bethel Brown to transfer the records to Sumner County for processing. Marylin Bell Hughes, a staff member at the Tennessee State Library, volunteered to serve as project coordinator and Dr. Tom Turley, another staff member, was most helpful in the latter stages of the project. Work began in July of 1984 and was completed in November of 1986.

Procedure to obtain copies of documents: Once an entry of interest is located, note the name, the number, and the category of indexed record – Wills, Estates, Lawsuits or Miscellaneous. These four categories have been microfilmed and are available for research at both the Sumner County Archives in Gallatin, Tennessee and the Tennessee State Library and Archives in Nashville, Tennessee. There are approximately 180 reels of sixteen millimeter microfilm in the entire collection.

In 1986 the loose records project was completed, under less than ideal conditions and microfilmed by the Tennessee State Library and Archives. In 1990 the Sumner County Archives received a state grant to employ an archivist to administer the preservation and storage of the original records. The records were examined in great detail and numerous errors were found and corrections made. Some errors were due to computer overload and resulted in the deletion of many surnames beginning with B and M from the published index.

Over the years, additional loose records have been added to the collection. This particular edition includes 90 original wills dated as early as 1789 that were recently located when court offices were moved to the new administration building. This process will continue in the years to come, but in far lesser numbers. Case numbers higher than the following have been added to the collection since the microfilming in the four categories of records:

Wills #797 Estates #4176 Miscellaneous #302 Lawsuits #13827

All of the errata and addenda have been compiled into one index for easier use by the researcher and have been cross indexed. If other than a lawsuit, a category is shown and that category must be conveyed to the staff when requesting copies of the material.

In most cases The Tennessee State Library and Archives does not have access to information contained in this Errata and Addenda, because they have only the original microfilms before the errors were found. It will be necessary to consult the original records at the Sumner County Archives. To the Honorable the General Assembly of the State of Tennessee:

The petition of the Subscribers, Inhabitants of the late Indian boundary North West of Cumberland Mountain respectfully Sheweth: That they have settled in a fertile tract of country which they suppose to be chiefly vacant and inappropriate or held by fraudulent warrants which must be void in themselves, they therefore hope that you in your wisdom and justice would pass a law to secure each settler in their respective improvement or at least give them the preference to secure the same to themselves. And as the great extent of said settlement renders it indispensably necessary to form new counties – they take the liberty to suggest the following plans as most proper to begin-at the south east corner of Smith County running east until it strikes where the extreme height of Cumberland Mountain thence southwardly along the same to where the Indian boundary may cross the same, thence west with the same to a point from whence as due north course will strike the beginning, - Also, that in your wisdom would lay off and establish another new country on the south side of Smith and Wilson counties and reduce Jackson County to constitutional limits and beginning where the Cumberland River enters the State, running south to a point from whence a due west course will strike the south east corner of Smith County, North with the same to the Northern boundary of the State, and east side of said county and attach all settlements north east of the wilderness road to the last mentioned new county without which they will be left in a state of anarchy. And, lastly, that you would lay off and establish New District east of Smith and Wilson Counties as the docket of the Superior Court of note cannot recover judgment in less than three years and from the late great increase of population and extension of our frontier settlements we may be certain the number of suits will increase, which renders a new District still more indispensable.

Your petitioners as in duty bound shall every pray & c.

Note: According to a letter written by a Faye Johnson Bowman to a cousin Louis Huston Gill: Faye Bowman writes: Mr. Carmack Key of Carthage, TN told me about the Deed Book M reference. **Mr. Key states “this is the Goose Creek John Johnson.”**

**Faye Bowman found several leads on the Johnson family that could tie in:**

Cherokee Agency Pass Book (29 July 1801 – 28 October 1804) shows a John Johnson (along with Daniel, Joshua and William) in the “passes issued to travelers desiring to go thru, settle in, or trade in the Cherokee Country.” I have often wondered if these might be some of the early Johnson settlers in Tennessee who originally came from North Carolina.

In Westerfield, Thomas W. Kentucky Genealogy and Biography V. 5, p. 182 there is mention of a Joseph Johnson, b. 1784 in VA; came to TN. “when young” and d. Clarksville, TN 1864. He md Nancy Brown (b. 1792 in NC). They had 11 children including Samuel (the youngest) b. 1853 in Wilson Co., TN. I would certainly like to make this Joseph a brother of John (b. PA) and thus an uncle of my Joseph. So far I haven't found anyone searching this Joseph and Nancy line.

Hannah Thorton, John Holly, William Evins, William Blakely, **John Johnson**, Felix Thornton, Josiah Harper, .....were present.
