

# *Descendants of Samuel Morrow*

## *Generation No. 1*

1. SAMUEL<sup>1</sup> MORROW was born in MD, and died May 13, 1796 in Spartanburg Dist, SC.

Notes for SAMUEL MORROW:

!A Samuel Morrow came from Maryland to Chester District, SC around 1765. A land grant of 100 acres on the south fork of Fishing Creek, Craven Dist., SC (Oct 10 1765) offers proof of this in his son's (Samuel, Jr.) pension application he stated "and the fall of the year (1779) before Charleston was taken my parents moved to this District Spartanburg". Even though he didn't name his parents, circumstantial evidence points that these two men were father and son. On Oct 16th 1784 Mr. Samuel Morrow Sen'r was issued 49L-2s-10pence for 281 days Militia duty in 1780 as per acc't audited. He sold his acc't to John McCreary 19 Feb 1785 in Camden District.

On the 2nd Nov 1789 Samuel Morrow was granted 180 acres of land in the 96th District, SC. In the 1790 U.S. Census of the 96th District, Spartanburg Co., SC there is a Samuel Morrow household with 1 male above 16 years, 0 under 16 years, females 0, slaves 3. This shows he was living alone with 3 slaves.

The Will of Samuel Morrow, Sr., Spartanburg Dist, SC (Box 19 Pkg 16) made 9th Feb 1796, rec. 18 July 1796; "Want my estate personal and real be sold, negroes all together as its my desire that they not be separated. Settle my debts and give remaining part to Robert Elder to be enjoyed by him".

Executors: Geo Bruton and Wm. Smith. Wit: Abraham Humbrée, Lee Clark and Thomas Thornton.

(Note: It is believed that Robert Elder COULD be his grandson).

Also included in Box 19 Pkg 16 is Capt. Samuel Morrow (Samuel, Jr.) bought more than any one else at the sale - 319 lbs worth - naming some: 3 negroes, 1 tract of land with crops, oats, etc. cattle of all kinds, hogs, a stallion, cooking utensils, spoons, etc.

Deed Book M, p. 342, Spartanburg, SC. "Jan 5, 1811 Whereas Samuel Morrow late of said county and state deceased, on 9th day Feb 1796 in his will the said Samuel Morrow directed his Executors to sell his the said Samuel Morrows whole estate, real and personal and whereas the said Samuel Morrow did on the 13th of May 1796 depart this life and on the 18th day of July 1796 the Executors were qualified and on the 10th day of Aug 1796 expose the land of the said estate for sale at which time Samuel Morrow, Jr. bid off the same at the sum of 61L the plantation or tract of land whereon the said Samuel Morrow lived and did contain 180 acres, situated and lying in said District on Popular branch of Dutchman Creek". Sold by the Exrs: Wm. Smith and Geo. Brewton. Wit: William N. Morrow and Isaac Smith.

Deed Book R, p. 52, Spartanburg, SC. "On 16th Dec 1817 Samuel Morrow (b 1760 MD sometimes called Samuel Jr. or Capt. Samuel or Major Samuel) sold to his oldest son John Morrow 'all the tract or parcel of land which was conveyed to me by Wm. Smith and Geo. Brewton, Exrs of Samuel Morrow, Sr., deceased the conveyance bearing date 5 Jan 1811, and the original grant being granted to the above Samuel Morrow, dec'd by his Excellency Charles Pinkney bearing date 1789, situated on the Popular branch of Dutchman Creek-180 acres". Wit: David and Robert Morrow. (Source: Book "Morrow Cousins")

!Referred to as "Old Samuel" in book "Morrows and Related Families".

May have been married three or more times. None of his wives names are known. Some of his descendants are traced in the books "Morrow Cousins" and "Morrows and Related Families".

### *Generation No. 2*

2. GEORGE<sup>2</sup> MORROW (*SAMUEL*<sup>1</sup>) was born Abt. 1742 in PA/MD, and died Bef. April 06, 1790 in 96th District, Abbeville, SC. He married (1) MARY CALHOUN. He married (2) MARY MECKLIN. She died Bef. August 12, 1822 in Abbeville, SC.

Notes for GEORGE MORROW:

!George was born in the Maryland/Pennsylvania disputed area where several of the Morrow families had settled. About the year 1764 he moved his young family to Orange County, NC (near the Cape Fear River according to his son Hugh). He and some of his Morrow relatives became involved with The Regulators and he followed a group led by Jacob Mattock (a Quaker), to Wrightsborough, St. Paul Parish, GA (Circa 1766).

He moved his family to Abbeville District, SC, just before the Revolutionary War (1776). Because of trouble with the Tories and Indians, he took his family to the Tyger River area in SC during the last years of the war. Shortly after the Revolutionary War was over, about 1787, he moved back to the Abbeville District and lived there the remainder of his life. (Source: Morrow's and Related Families by J.T. Morrow, pg. 42).

!Wrightsborough Township, GA was settled in 1767 by some forty families of Orange County, NC, led by Quakers Joseph Maddock and Jonathan Sell. Many of the Quaker families in the migration had moved as a group from New Castle (in Delaware, but then under the jurisdiction of Pennsylvania) and Chester County, PA to NC in 1754-1755. The town of Wrightsborough, GA, the administrative center of the township was laid out in 1769-1770. Wrightsborough Township was in St. Paul Parish (after 1777 Richmond County) and is today in Columbia County (created 1790), Warren County (created 1793), and McDuffie County (created 1870). The town of Wrightsborough was near present-day Thomson. Almost every settler who lived in the township has been identified as a Quaker, when, in fact, the Friends were a minority there from a very early date. A petition dated February 7, 1769 requesting lands be laid out for 60 families including 350 acres for James Morrow (Identity unknown as of Feb 1992) and 300 acres for George Morrow. (Note: This would indicate that George was requesting land for himself (200 acs.) and two other people (50 acs. each). This would

indicate he had a wife and one child as of this date, or possibly just himself and two children. On February 3, 1807 the "town lots" of 50 acres each were laid out and James Morrow is listed as a holder of lot #55. This would indicate that James did not move to SC about 1774 when George apparently moved to Abbeville in that State. By 1805 all of the Quakers had left

Wrightsborough and migrated to Ohio. (Source: Quaker Records in Georgia by Robert Scott Davis, Jr. GEN 975.8 D268, Clayton Library). This source "corroborates" information from Hugh Morrow's Revolutionary War Pension application about the movements of his father's family. Hugh was an older half brother to George. One "interesting" aspect appears to be that George Morrow may have been a "sympathizer" of the Quakers and that the reason the group left Orange County, NC was not that they were "supporting" the Regulator movement but more likely they were "persona non grata" because of their "pacifist" beliefs. This did not stop George from contributing his services to the Revolutionary cause.

!WILL: Abbeville County, SC. Will signed March 10, 1790, probated April 6, 1790 (which means he died during this one month period). Lists wife Mary and children: Hugh Morrow (was to have 100 a. of land, but must stay with his mother and help her take care of the other children.); Mary Ann Morrow; James Morrow; Margaret Morrow; George M. Morrow; and Jane. Executors: Wife, Mary Morrow; Wm Hutton and Ebenezer Pettigrew. Witnesses: William Deal; William Beall (or Wm. Deall) and Jane Foster. (Source: "Five Morrow Men with some descendants, pub. 1975 by Naomi Morrow Hailey, pg. (232).) WAM NOTE: Ebenezer Pettigrew, William Deal Sr., and William Deal Jr., were all immediate neighbors, within 9 houses of John and Hugh Morrow on the 1790 U.S. Census for Abbeville, SC. I "speculate" that John Morrow had already received his inheritance and therefore is not mentioned in the will.

!WAM NOTE: Research in early 2004 indicates there was a Daniel MORROW b. abt 1704 in Lunenburg, VA and wife Margaret STUART b. abt 1707 in Prince Edward Co., VA. Among their 8 children were a James b. abt 1729. COULD HE BE THE James who was in Wrightstown, GA with George MORROW circa 1767. He would have been abt 48 years of age at that time. He could be a cousin to George MORROW b. abt 1742. (ALL SPECULATION NEEDS TO BE RESEARCHED.)

!Mary Mecklin Morrow was the second wife of George Morrow. In her will dated 12 January 1819 she named her sons George Mecklin Morrow and James Morrow as executors. James Morrow, executor, and to have lands bought of John Dale and by lands of grant to James Anderson. George Mecklin Morrow, the land given to him that I bought from James Williams. She further named her daughter Margaret Brown and a granddaughter Elizabeth Brown. Witnesses: Patrick Calhoun, James Hutton and Enos Crawford.

!WAM NOTE: I believe her father was Hugh Mecklin who lived in the Bufalo Church section of Guilford County, NC. (Needs further research).

!PROBATE: At the sale of the items from her estate (1822, date too difficult to read), the following individuals made purchases. Names appear in order of purchases: James M. CRAWFORD (3 items); Daniel BROWN (4 items); James MORROW (3 items); Robert MARTAIN (7 items); Robert CRAWFORD (2 items); Nathaniel CAMERON; George M. MORROW (11 items); Benjamin FURMAN(?) (2 items); Simon BAIRD or BEARD (2 items); James ALEXANDER (5 items); \_\_\_\_\_ VERNON. Xeroxed copy of document has several "blotches" which blank out names of individuals who made several purchases. WAM NOTE: James and George M. MORROW were Mary's sons and WAM believes that Daniel BROWN is the husband of Mary's daughter Margaret. Needs additional research.

- ii. GEORGE MECKLIN MORROW, b. Abt. 1772, GA; d. May 11, 1877, Tippah, MS; m. UNKN.

Notes for GEORGE MECKLIN MORROW:  
!BIRTH: Estimated from tombstone which indicates he lived to be 105.

!In the will of his mother dated Jan 12, 1819 and probated Aug 12, 1822 in Abbeville Co., SC, George is left "the land given to him that I bought from James Williams". George Mecklin Morrow lived with his daughter Vinecie and her husband John Magill. This family moved from SC to Madison Co., FL about 1852. In 1861 the Magill's and George moved from FL to MS and settled in the Graham Community located in North East Union Co. (the area may have been Tippah County at the time, need to check). John Magill enlisted in the C.S.A. Army on Aug 1, 1862 at Ripley, MS. His post office was Ellistown in Pontotoc, Co. It appears as though George lived with this family for the remainder of his life (at least 23 years). (Source: History of Union Co., MS, Clayton Library, GEN 976.2 H 673 VI.)

3.       iii. JAMES MORROW, b. Abt. 1774, SC; d. Rockdale, Randolph, AL.

*Generation No. 3*

**3.** JAMES<sup>3</sup> MORROW (*GEORGE*<sup>2</sup>, *SAMUEL*<sup>1</sup>) was born Abt. 1774 in SC, and died in Rockdale, Randolph, AL. He married CATHERINE Bef. 1816. She was born 1783 in SC, and died in Randolph Co., AL.

Notes for JAMES MORROW:

!THERE IS NO DOCUMENTARY EVIDENCE OF FATHER/SON RELATION BETWEEN GEORGE AND JAMES MORROW, SAME IS TRUE FOR MOST OF THE CHILDREN OF JAMES MORROW.

!James' father had moved the family from NC to the Maddock Settlement in St. Paul Parish (later Richmond Co. (1777); Columbia Co. (1790); Warren Co. (1793); and McDuffie Co. (1870)), GA during the "Regulator Troubles" in the 1760's. The family moved to the Abbeville District of SC shortly before the Revolutionary War (1776). James was born about 1774 in either SC or GA. The family lived near the Tyger River in SC during the Revolutionary War and returned to Abbeville after the war. James married a woman from SC and settled there. He was probably still in Abbeville on 12 Jan 1819 when he and his brother George Mecklin Morrow were made executors of their mother's will. James was "to have lands bought of John Dale and by lands of grant to James Anderson".

After the birth of his second child (1817) and probably after the settlement of his mother's estate 12 Aug 1822, he moved his family back to Wilkes County, GA where many of the Morrow families lived. By 1830 he was living in Jackson County, GA and in 1850 was in Randolph County, AL where he died.

Source: Shelby Gerald Morrow (1990). I believe Shelby "constructed" the family of James Morrow from the 1850 and 1860 U.S. Census of Randolph Co., AL. The location of the Maddock Settlement was taken from "Quaker Records in Georgia" by Robert Scott Davis, Jr.

!CENSUS: 1800, Abbeville, SC shows a James Morrow (age 16/26); Female (age 16/26) (probably his wife) and two females (under age 10). WAM Note: If this is "our" James (who would have been 26 years old in 1800) this would indicate to me he may have married twice since the wife in this census, if Catherine of later records, would have been 16 years of age and already had two daughters. This is possible but highly improbable.

!CENSUS: 1850, Rockdale, Randolph Co., AL shows James Morrow (age 76); farmer living in Beat #8 with his wife Catherine (age 67); Benjamin Morrow (son, age 25); Emily Morrow (daughter, age 23). According to the Census they were all born in SC. (NOTE: Family tradition indicates otherwise).

!WAM Note: I believe we may be "missing a generation" of Morrow's. If James had the children listed he would have been 43 years of age when his first child was born and 54 when the last was born and his wife Catherine would have been age 33 when their first child was born. Since the 1800 Census shows James and wife with two daughters under 10 years of age, James was either married twice or we are missing the first two daughters in our family group, or we may not have the correct James Morrow. I believe it is possible that another of the Morrow men on 1850 Randolph Co., AL census (possibly John, age 54 with wife age 35 and five children in Beat 17) could have had by an earlier wife, the children attributed to James. Research continues.

!UPDATE: As of Dec 1996 the "speculation" is that "OUR" James Morrow was the son of a William and Ruth Morrow who lived in the Spartanburg District of SC in the late 1700's. This William Morrow is believed to be a son of "Old Samuel Morrow" and a younger brother of George Morrow who is currently shown as the father of James in WAM's family records. A James Morrow has been located on the

1830 U.S. Census for Habersham County, GA and this man had a large family which would correspond with the Morrow's in Randolph Co., AL in the 1850's. Also on the same page of this Census is located a James CHITWOOD and family and there is a Richard and Daniel Chitwood's in the county which would explain where and when Ephriam Morrow may have met and married Caroline Chitwood. A James and William Morrow both owned land (paid taxes) in Franklin Co., GA 1818-1820 (Habersham was formed partially from land taken from Franklin Co.) At this time WAM believes "strongly" that we have located the correct James Morrow in GA although there are other men with the same name in GA at the same time period. (The foregoing information was developed by Shelby Gerald Morrow during 1995-1996 and much of the information has been verified by WAM.) The 1827 GA Gold Lottery shows that James; Richard and Daniel CHITWOOD were still in Habersham Co., GA. There are NO James or William MORROW listings ANYWHERE in GA on the 1827 GA Gold Lottery. Where were they in 1827? (Research continues). By the late 1830's there are a Robert and William MORROW in Benton Co., AL purchasing land in Randolph Co., AL. Is this the same William who was in GA earlier? There are a Robert and William MORROW in Wilkes Co., GA (tax and land deeds) in the 1790's. (This is getting into the area of the Maddox Settlement of Jacob MADDIX and his "Regulators" prior to the Revolutionary War. Jacob MADDIX's wife was a Sarah MORROW.

!WAM NOTE: During 2003 WAM participated in a Y-DNA test for male MORROW's via the internet. The first five individuals tested did NOT match as sharing a common ancestor which was a "very disappointing" result since at least one of the individuals in the test claims ancestry from Robert MORROW, one of the oldest sons of "Old Samuel" MORROW chronicled in J.T. Morros's book "Morrow and Allied Families". WAM had "speculated" that we were also from the line of "Old Samuel" but the DNA test indicates this is probably not the case. I don't know how well the line back to Robert MORROW is documented.

!DEATH: After 1860. 1860 Census of Rockdale (Northern District), AL shows Catherine Morrow (age 70 ; born SC) living with Emily Morrow (age 32 ; born GA) and Mary Morrow (age 11; born AL). Lived in dwelling next to Hugh and Sarah Morrow (believed to be her oldest son). According to earlier records, Catherine should have been 77 years of age in 1860.

!NOTE: According to listing of Mount Prospect Baptist Church Cemetery (Ophelia Cemetery), Twp. 19, Range 10, Sec. 33, Randolph County, AL, "UNMARKED: (Catherine Morrow, born 1785, died 187\_) (Mother of Ephriam Morrow)." This is from an internet file compiled by Marilyn M. Girardi.

!LAND: On 1 Jan 1859 Hugh Morrow of Randolph Co., AL was issued two land Patents as follows: (1): The North West quarter of the South East fractional quarter of Section Thirty-Three in Township Nineteen of Range Two, in the district of lands formerly subject to sale at Lebanon, now Centre, Alabama, containing forty acres and thirteen hundredths of an acre. (2): The North East quarter of the South West quarter and

fractional C. of fractional Section Thirty-Three in Township Nineteen of Range Ten East, in the District of lands formerly subject to sale at Lebanon now Centre, Cabama, containing Seventy-seven acres and ninety hundredths of an acre. Documents numbered 19541 and 19832. On 1 July 1861, Hugh Morrow of Randolph Co., AL was issued a land Patent as follows: the South West quarter of the South West quarter of Section Thirty-three in Township Nineteen of Range Ten, in the District of lands subject to sale at Centre, Alabama, containing forty acres and thirteen hundredths of an acre. Document no. 21634. (WAM has copies of these land patents from the BLM website on the internet.)

!CENSUS: 1860 Census shows Hugh (age 45; born SC), his wife Sarah C. (age 36; born GA), son Arthur (age 16), daughter Nancy (age 12) and daughter Esther (age 6). Living in the next dwelling were Catherine Morrow (his mother), Emily Morrow (his sister) and Mary Morrow (age 11, relationship unknown). (Note: Need to do further research on the Hugh Morrow's family, look for death record and burial).

vi. NATHANIAL MORROW, b. Abt. 1825, GA; d. Tippah, MS; m. MARY J., Bef. 1848, Tippah, Mississippi.

Notes for NATHANIAL MORROW:

!Known as "Nathan". Nathan and his wife Mary were living in Tippah County, Mississippi with their two oldest children in 1850. Shortly thereafter they moved to Alabama. We do not know where, at this time, we do know that he wasn't in Randolph County where his parents were. It was told to Shelby Gerald Morrow by Mrs. Annie Mae (Vancanon) Morrow that they were living in Cardova, Alabama in Walker County, although they could not be located in the 1860, 1870 or 1880 census records.

!When the Civil War broke out Nathan and his brother (Epham) joined the Confederate Army. It is not known where he served, although if he went to North Carolina where Epham did, there would have been two Nathan Morrrows there and it would almost be impossible to tell who was who. When Nathan came home he rode up to the house on a horse and called his daughter Tine to come out but he wouldn't let anyone else near him. Everyone wanted to see him, but no one knew what was wrong with him or what was going on. Some thought that he was hurt. When Tine got to him and his horse he told her to get some soap and a change of clothes. It was finally discovered what was wrong, Nathan had body lice. It was probably a great relief when they found out what the problem was. Around the late 1880's Mary J. Morrow died in Cardova, Alabama. It was said that Nathan and all the children were out in the field and little Dugie made a mess. Nathan told one of the girls to take him in the house for his mother to change him. When she got in the house she found her mother dead. After the death of Mary, Nathan his brother Epham and all their children loaded up a wagon train and headed northwest to Alcorn County, Mississippi and settled in Hatchie, which is in the southwest portion of the county. They said it was really something to see, all these people coming at one time. When they came the women would tell witty stories about a Pat and John Morrow who lived in Ireland. Most of the family around this time could not read or write and the ones that could did keep records but all were lost or destroyed so information has been hard to find. (Source: Shelby Gerald Morrow).

!THERE IS NO DOCUMENTARY PROOF OF THE FATHER/SON RELATIONSHIP OF JAMES AND EPHRIAM MORROW. The "probable relationship" is based on the fact that James and Ephriam lived in the Rockdale area of Randolph County, AL in 1850 and the fact that Ephriam moved his family circa late 1870's to Northeast MS which is where Hugh Morrow (a half brother to James) and George Mec klin Morrow (a full brother of James) had located in the 1860's. These facts are a "strong indication" that the James Morrow in Rockdale, AL was the father or perhaps grandfather to most of the Morrow's in Randolph, Co., AL in the 1850's. (Research continues.)

!Known as "Epham". Epham Morrow and his family lived in Tippah County, Mississippi around 1847 and this is where their oldest son was born. (In June of 1847, Nathaniel MORROW (Ephriam's brother) purchased land in Tippah Co., MS. Before November of 1848 they were in Randolph County, Alabama where the remainder of the children were born. By 1860 Epham was farming on about 80 acres of land and his wife Caroline was at home weaving and taking care of their six children. When the Civil War broke out, Epham joined the Confederate Army where he served as a Sergeant in the 9th Alabama Cavalry (Malone's). A service record for a sergeant E.P. Morrow indicates he was captured on 24 December 1863 near Knoxville after his unit had participated in the battle of Chickamagua in September. He was sent to a POW facility at Camp Chase, OH (outside of Columbus) and there is no further record of his military service. There is a story told by Sarah (Lillie) Louinger Killough Morrow (Brunness's wife) that Epham made a vow with a friend in the army that if either man got killed the other would take care of his family. As the story goes, Epham's friend was killed. Although there was quite a bit of heartache involved, Epham took the man's wife in. By the 1900 census in Tippah County, Mississippi we find there is a woman living with Epham named Sarah Ragan. Epham's wife Caroline lived with her son Andrew Jackson Morrow. (NOTE: Need to research RAGAN family. If there was a "relationship" between Epham and Sarah Ragan's husband (cousins perhaps) it would lend great support to this story. Research indicates a Thomas RAGAN purchased land adjoining Ephriam's in 1860 so they were definitely "next door neighbors" if not kin. Research continues). (THE WAR RECORD OF EPHRIAM L. MORROW IS APPARENTLY NOT THE RECORD FOR THE E.P. MORROW INDICATED ABOVE. THIS INDIVIDUAL WAS APPARENTLY AN EDWARD MORROW.)

!LAND: On 1 February 1860 there were two "land grants" issued to Ephriam L. Morrow of Randolph County, AL. The grants were numbered 21623 and 21743. The first reads "...for the North West quarter of the North East quarter of Section twenty three in Township Nineteen, of Range ten, in the District of Lands subject to sale at Centre, Alabama, containing thirty nine acres and ninety six hundredths of an acre. The second reads "...for the North East quarter of the North East quarter of Section twenty three, in Township Nineteen, of Range 10, in the District of Lands subject to sale at Centre, Alabama, containing thirty nine acres, and ninety six hundredths of an acre." James Buchanan was President of the United States at this time. This land contains the NE 1/4 & NE 1/4 of Sec 23; Range 10 in Randolph County, AL with a combined acreage of just under 80 acres as reported in Shelby Gerald Morrow's "original research" on our branch of the Morrow Family. (WAM obtained copies of these land patents from the Bureau of Land Management site on the internet.) NEED TO RESEARCH IF THIS LAND WAS SOLD, OR IF IT MIGHT HAVE BEEN LOST FOR TAXES DURING THE CIVIL WAR.

On the 1880 U.S. Census for Putnam County he is shown living in the 11th District which was the Rock Spring Area. I am informed by Mrs. Hazel Carlen Bates of Buffalo Valley, TN that James and his family "probably" lived on the Denny Farm in Rock Spring during this period. The Census shows James Morrow and family and W.B. Carlen, his mother and two daughters in the same household.

The 1900 U.S. Census shows the family living in the 17th Civil District which was Boma. James and Emily's daughter Cora died in 1905, their son Stephen "Nat" in 1909, son William "Thomas" in 1911 plus a young daughter Gad died young (probably before 1900 since she is not on the Census). The Morrow's "took in" the children of William Thomas when his wife died in 1912. James' grandson Bruness Morrow often said his brothers and sister raised themselves. Artie Leah Meriwether, a granddaughter of James, wrote this line about him. "Our grandfather left Mississippi, I understood during the Civil War, as a young boy and came this way (Cookeville, Tennessee) and settled and married Emily Eudora Carlen, the daughter of William Bernard and Sarah Holladay Carlen. Emily died on 24 Nov 1918 and was buried in Salem Cemetery, Putnam County, Tennessee." Hazel Carlen Bates recalls "Uncle" James Morrow coming to visit with her family for periods of two to three weeks. (I assume this is after Emily died in 1918). WAM has a "Morrow Family Photo" which according to Lena Moore Paris was taken on Grandpa Morrow's birthday. Since Emily is not present I assume the picture was taken after 1918 although Emily did have an "extended illness" prior to her passing. In the picture I estimate Lena to be 12 years of age which would make the date of the picture 1923 which would have been James's 75th birthday. Lena Moore Paris says that prior to James's return to Mississippi, her mother Callie "used to look after him". James died in 1937 one day after his 89th birthday at the County Farm, Corinth, Alcorn County, Mississippi where he had returned to be near his brother. He was buried in the Antioch #1 Cemetery, 8 Mi. S.W. of Corinth where his father Epham was possibly buried. The Antioch Baptist Church #1 burned sometime in the 1970's (according to Mrs. Junie Robinson Ross of Prentiss County, MS). WAM visited the cemetery in Aug 1994 and with the help of a diagram prepared by Shelby Gerald Morrow using information from Junie Ross we were able to locate head and foot "field stones" for James and his brother Andrew Jackson Morrow and Tine Morrow (Andrew's wife). James had lived with Andrew and Tine prior to moving to the County Farm where he died. (WAM took photo of field stones). James and Emily's family bible (extract) indicates James was born in N.C. but most census records and death certificate indicate he was born in Alabama.

Lena Moore Paris says that Grandpa and Grandma Morrow lived in a 2 ro om shack  
with a "lean too" third room and that every room contained beds. Sh e claims  
that the property was owned by James Roscoe Morrow and was purchase d as a place for his parents to live. In  
May 1994 WAM visited and ph otographed the  
area where this home was located. From the above three census entrie s it is  
"obvious" that the Morrow's moved frequently, a "strong" family trait.

!NOTE: Why did James leave his family in Corinth, MS and go to Cookev ille, TN? Perhaps a study of the  
MOORE family would shed some ligh t on this. There was a Thomas P. Moore who was executor of the wil l of

He was known as "Lon". As a young man, Lon and his brother Thomas went to California to work in the shipyards. When he returned to Tennessee he purchased a 64 acre farm on St. Mary's Road, Rock Springs, just down the road from the Denny Farm. He paid \$3,700 for the farm and later sold it for the same amount to Mr. Kenneth Pullum. Kenneth used to cut "Unc's" hair and was a friend of "Unc." and "Sac" (Lon and Lassie Morrow). An interesting story related to WAM by Hazel Carlen Bates goes as follows.

"Unc." did his

banking in Cookeville (bank was run by the Carlen's who were kin). One day the bank "returned for insufficient funds" a small check which Unc. had written. Unc. asked Kenneth Pullum to drive him into Cookeville to the bank. When they arrived Unc began to "read the riot act" to the bankers. He had about \$1,500 in their bank and demanded it be given to him in cash. At first they tried to talk him out of closing his account, then they said they would give him a cashier's check. He said "I put in cash and I want my money in cash". They finally gave him his money in cash which he stuck in all of the pockets of his overalls. When they left the bank he asked Kenneth to drive him to Carthage in Smith County where he put his money in the bank and conducted his banking business there for the remainder of his life. Kenneth said he was "scared to death" that someone might "hold them up" with all of this money in cash but fortunately the transaction was completed without incident. J.T. Askew, Silver Point, TN tells of playing baseball when he was a boy and Lon Morrow (approx age 75) played center field. Another story related to WAM by Mrs. Maurine Patton of Cookeville (Dec 1993) to the effect that Lon's wife was having his suit "remade" into a dress by a local seamstress. Supposedly she inquired if the "old thread" could be salvaged and reused, an indication of how "frugal" this couple was.

Kenneth Pullum told WAM that Unc and Sac sold their farm and for a while lived with some of Sac's relatives on a nearby farm. They both

later moved to a "retirement home" in Carthage where they both died.

Uncle Lon and Aunt Lass raised James MORROW one of the children of William Thomas Morrow.

According to family stories, "Jimmy" left as soon as he was old enough to get along on his own, an indication he might not have had an "ideal childhood". Jimmy Morrow went to Detroit and some of his descendants live in Illinois.

BURIED: Lon and his wife Lassie are buried at the Faith Chapel, Rock Spring Cemetery, Putnam County, TN. WAM photographed their headstone in May 1994.

WAM NOTE: I have a picture of an individual in military uniform (supposedly Uncle Lon). He would have been 21 years of age and single in Feb 1898 when the Spanish American War started but he was enumerated with the John S. Denny family on the 1900 U.S. Census of District 11, Putnam Co., TN, so if he was in the military for the War, he was home by 1900. (Requires additional research.)

Also a member of American Legion Post 46 in Cookeville which would indicate he served in the U.S. armed forces. He died at the Veterans Hospital in Murfreesboro following an illness of several weeks. Died at age 60. His wife survived him as did his brother Lon Morrow of Buffalo Valley, two sisters, Mrs. Callie Moore and Miss Mae Morrow of Cookeville. (Source: Newspaper obituary, undated, provided by Aunt Arlie from Lena Paris.) He and his wife Minnie had one child which died at birth. WAM believes Roscoe may have worked for Dupont in Nashville proved by a workers ID badge with Roscoe's picture on it and back inscribed, "Du Pont Engineering Company, Old Hickory Works, Nashville, Tenn." This badge was sent to WAM by Lena Moore Paris in June 1993. WAM also has a photo of Roscoe Morrow in a military uniform so he may have served during the Spanish American War (1898?, needs more research.)

BURIED: Funeral services held at the Baxter Methodist Church, Rev. J.S. Haris officiated. Burial was in the family cemetery, two miles west of Baxter, near Ensor. WAM visited and photographed this cemetery in May 1994. It was so "overgrown" that you cannot enter the "walled area" where there were 2 headstones visible. It appears to me as though Roscoe, Minnie and their son are the only ones buried there. This cemetery is located on Dyer Ridge (Road Name) in a plowed field, on the left side as you face from the road.

William Arnold Morrow (WAM), NOTE: Lena Moore Paris says Uncle Roscoe purchased a house in the Salem

Community in which his parents lived (circa 1910). WAM discovered land records for this transaction at the Putnam County Courthouse and xeroxed same.

Notes for STEPHEN HOLLADAY MORROW:

!Was known as "Nat". Stephen was killed at age 23 by two brothers named "Moss" who were brother-in-laws to Thomas Morrow, Stephen's brother. Following is a quote from a letter written by J.T. Askew of Silver Point, TN on 10-31-89. "I was raised in Buffalo Valley and remember my mother telling me about Oscar Moss killing Lon Morrow's brother at the west end of the Caney Fork River railroad bridge. We lived at the East end of the bridge. The bridge is one mile West of Buffalo Valley. I always thought they said it was Matt Morrow but I see it was Stephen Morrow. I was born in 1919 so that was nine years later. By the time I could remember anything I played with Oscar Moss's son Sam. Oscar was already out of prison for the murder. There was a stave and header mill (saw mill) for years at the West end of the bridge. I used to go over and play where the

mill was located. He re is the account as my mother told me: At the end of the work day M orrow was coming up out of the sawdust pit or lower part of working p lace and the two Moss brothers were waiting. Edger said to Oscar "Wh y don't you do what you said you was going to do" or maybe "Are you g oing to do what you said you was going to do." So Oscar killed Morro w. They carried Morrow to his house close by and laid him on a bed o r couch. He was already dead and his little boy came in and said t o him "Come on daddy and lets eat, we got chicken for supper." Ver y sad.

!Item from Putnam County Herald of Thursday Aug 12, 1909. Vol. VII I No. 32

"Nate Morrow of near Cookeville was shot and killed by Oscar Moss a t the Welch stave mill near Caney Fork Wednesday evening of last week . The murder resulted from a quarrel over a trifiling matter durin g the day. Moss escaped and has not been arrested as yet. His broth er who was present was arrested, brought here and placed under bond . Morrow was about 25 years of age leaves a wife and two children."

!Item from Gainesboro Sentinel, Saturday, August 14, 1909. "Nathanie l Morrow, with his wife and one child lived neighbors of two brothers , Oscar and Edgar Moss, near Caney Fork, a small railroad station bet ween Buffalo Valley and Lancaster. Trouble arose over a potato patc h and a misunderstanding which ultimately resulted in Morrow's death , arose. Some days ago, while Morrow was away from home, his wife wa s cursed and abused by the Moss boys, an account of which she told he r husband. Morrow worked at the Spoke factory near Caney Fork and ac cording to the story of Abe Ford, manager of the mill, he was at wor k yesterday afternoon when the two Moss boys passed on the railroad g oing west. Morrow remarked to Ford that he would go ask them why the y abused his wife and in the course of a conversation which followed , hot words passed between the Mosses and the Morrow. The latter wen t back to the mill and asked Ford for his gun, but the request was re fused, and he was told to go back to work, which he did, leaving th e Moss brothers standing where he had left them. He continued

his work until the 5:30 whistle blew, then started to leave. In th e meantime, the Moss brothers had waited outside and as soon as Morro w stepped out Oscar opened fire with a revolver. Four bullets struc k him, and death was almost instantaneous. He was shot in the hip, i n the abdomen, and twice in the back. He died without making a state ment. The Moss boys immediately left, and up to the present time hav e not been arrested, although officers are in search of them.

Nathaniel Morrow was the son of James Morrow of this city and was a n upright, honest, hard working man. He leaves a wife and one little child. Hi s remains will be buried at Buffalo Valley. Oscar Moss, who did the shooting, is a young man, possibly not over t wenty years of age. He has been in court before, and has a reputatio n for being boisterous. And thus is the brand of Cain forever stamped upon his b row. Whatever may be the decree of the jury, the result of yesterday's tra gedy is one soul sent into eternity and the lives of two young men wrecked fo rever."

WAM Note: The above was originally printed in the Cookeville Press a nd "reprinted" in the Gainesboro Sentinel. This information was provide d in a letter from Christine Spivey Jones of Cookeville, TN on April 9, 1994.

!Item from Putnam County Herald, 26 May 1910. "Edger Moss was convic ted in criminal court Monday on a charge of manslaughter and sentenced to fi ve years in the penitentiary. His brother Oscar is now serving a ten yar sent ence.

They were charged with killing Nate Morrow near Buffalo Valley abou t a year ago." This information provided by Betty Goolsby Doyle when I visite d with her at her mother's home in Cookeville, TN in May 1994.

!BIRTH/DEATH: From Bible records of Mr. and Mrs. James L. Morrow in p ossession of Mrs. Callie Moore and Records of Emily Eudora Carlen Mor row given July 22, 1928 per "Draper Families in America". Lena Moor e Paris says Aunt Mae had the Morrow Family Bible and took it with he re wherever she went.

!BURIED: Buried on the Ray Denny Farm in Rock Springs, Putnam County , TN. WAM visited and photographed the spot in May 1994. The location wa s provided by Mrs. Hazel Carlen Bates whose father James T. Carlen had told he r where Nat Morrow was buried. Hazel is related to us by marriage . She called James Lindsey Morrow "Uncle James". I believe the Denny Farm has been in t he same family for at least three generations.

!WAM NOTE: There has always been "speculation" about the circumstanc es

surrounding Stephen's death. Need to research criminal court records at Cookeville, TN. I tried unsuccessfully on a visit to Cookeville in May 1994 but was unable to gain access to any records due to the county offices being in the process of moving into the new Justice Center and the fact that Court was in session.

Notes for LUCY E. GOOLSBY:

!Possibly named for her Aunt Lucinda Goolsby. Lucy was raised in a home with a stepmother and from what WAM has been able to gather, this was not a very "happy situation". In 1909, Lucy, her husband Stephen and her two children were living near the West End of the Caney Fork Railroad Bridge in Buffalo Valley. In 1910, Lucy and her three children were enumerated in the household of her father and her stepmother. Four years after the death of her husband Stephen, Lucy's three children were sent to an orphanage in Nashville, TN., circa 1913. Her father was raising a second family but I do not know why the Morrow or Goolsby grandparents would not take Lucy and her children in. Lucy later married a man named John Blaylock and they lived in Monterey, TN where John taught in the local college. According to Arlie Morrow Devault (Aunt Arlie), her mother came to the Belfort's home in Nashville when she was in her early teens and took her to where she was staying for a visit (in Nashville). During the day Arlie and her mother "had words" because her mother was always complaining about her childhood and life but did not seem to care how her children felt about their situation, i.e. being put in an orphanage and "foster homes". During this visit, Lucy told Arlie that she had left the three children with Grandpa Morrow and had gone to Monterey to work (circa 1913). When she got her first paycheck 30 days later Lucy returned to Cookeville and her children were gone. Supposedly the Morrrows would not tell Lucy where the children had been sent. (WAM note: there is no way to verify this story). Arlie left that day and returned to the Belfort home. A short time later the Belfort's talked Arlie and Arnold her brother into going for an extended visit with Lucy and her husband John in Monterey. During this visit of several weeks, Lucy and Arnold had an "explosive" disagreement and Arnold and Arlie left. This was the last time Arlie saw her mother. (Source: Memories of Arlie Morrow Devault during personal interview Aug 1994).

Lucy and John Blaylock moved to West Gate (outside of West Palm Beach, FL) circa 1924 where they lived at 1203 Wabasso Ave. John's brother James lived with them. John Blaylock "appears" to have died during the September 16, 1928 hurricane which struck the Palm Beach Area and killed between 2,000 and 2,400 people. Lucy married James Blaylock after the death of his brother John. She made numerous attempts throughout the years to contact her son William Arnold Morrow, usually by sending letters or telegrams that she was extremely ill. The only time he responded by visiting, they had a "big fight" because she had contacted him under false pretenses and also said unkind things about his wife. (Source: Recollections of Anna Mildred Wilson Morrow and Lorene Morrow Murray.)

Lucy also tried to visit her son Ernest Morrow Marlin when he was about 17 years of age but he went off into the woods "hunting" and refused to see her. (Source: Letter from Margaret Marlin Philpot, 6 Feb 1993). (WAM Note: From these "stories" it is obvious that Lucy Morrow's children had "hard feelings" towards her, justified or not, and Lucy must have been a very "argumentative" type person.)

!BIRTH/DEATH: Dates from Certificate of Death from State of Florida (File No. 5540; Registrar's No. 274). WAM has certified copy of death certificate.

!MARRIAGE: Second marriage recorded in Marriage Records of Cumberland County, TN, 0765, J.S. Garrison, bondsman and O.B. Rector, Minister. (Source: Letter from Bettie Goolsby Doyle, 14 Nov 1994). (WAM NOTE: It is interesting to see that Lucy used her maiden name for this event).

!OBITUARY: MRS. LUCY BLAYLOCK. Miss Blaylock, 65, a 29 year resident of 1203 Wabasso Ave., West

Palm Beach, died at her home Tuesday afternoon after a long illness. Survivors include the husband, James A. Blaylock. Arrangements will be announced later by Mizell-Simon-Faville Hibiscus Chapel. (Source: The Palm Beach Post, Wednesday, Feb 9, 1995). MRS. LUCY BLAYLOCK. Funeral services for Mrs. Blaylock, 65, a 29 year resident of the area who died Tuesday, will be held at 2 pm Friday at Mizell-Simon-Faville Hibiscus Chapel with West Side Baptist Church pastor, the Rev. Luzene Lamerson, officiating. Burial will follow in Hillcrest. (Source: The Palm Beach Post, Thursday, Feb 19, 1995). (WAM has copies of both newspaper items).

!BURIAL: WAM, his wife Shirley and his sisters Lorene Morrow Murray and Virginia Morrow Ramsze visited the Hillcrest Cemetery in West Palm Beach in November 1995. Lucy's burial lot was identified and located. There is NO MARKER at the gravesite for Lucy or her second husband James Blaylock who is buried next to her. Photo's were taken by WAM.

Notes for ARLIE MYRTLE MORROW:

!Has always been known as "Arlie". (In Morrow Family Bible she is listed as "Artie Myrtle"). She was raised by a family named "Belford" in Nashville, Tennessee but was never adopted. Family "lore" has it that Arlie was "very wild" as a young adult. She obtained a Practical Nursing Certificate in 1948 (WAM has this). During the Second World War until about 1956 she "lived with" Rosewell J. Heiner. She once referred to him as "The Dutchman, the love of my life". They "traveled" quite a bit in conjunction with Heiner's occupation, a steamfitter. They lived in Washington State for a while and Arlie later lived in East Saint Louis, IL. After the death of "The Dutchman" she married Seldon Devault but to my knowledge she never had any children. She was "supposedly" a Registered Nurse but WAM has not found documentation for this. At one time she worked at St. Vincent Sanatorium in Saint Louis. After marrying Seldon Devault, she lived at 2751 San Diego in Normandy, just outside of Saint Louis. Her husband died in 1977 and she continued to live at that address until her death. The last several years of her life she "took in boarders" primarily from the University of Missouri at Saint Louis as a means to supplement her income and to have someone living in the house beside herself.

"Our" branch of the Morrow Family "reestablished contact" with Aunt Arlie in about 1972 through correspondence between WAM and Lena Moore Paris of Cookeville, TN (Arlie's first cousin). Aunt Arlie visited the home of Lorene and Danny Murray in Manasquan and Lorene and Danny traveled to Saint Louis on several occasions to visit Aunt Arlie. They became quite "close" and eventually Aunt Arlie assigned "Power of Attorney" to Lorene Morrow Murray. Aunt Arlie had kept in contact with other members of "our branch of the Morrow Clan" which led to WAM contacting and meeting Shelby Gerald Morrow who had done a great deal of research on our Morrow Family History. Aunt Arlie is the source of much of our "Goolsby Family" information.

Aunt Arlie enjoyed "relatively good health" until April 1998 when her health began to deteriorate. She entered the Baptist Hospital in Saint Louis in early May supposedly for "tests" and died on Saturday May 11, 1998 of pneumonia. (WAM has copy of death certificate).

Notes for EARNEST MORROW:

!BIRTH: 5 April 1910 according to Margaret Ann Marlin Philpot. 11 April 1910 according to family bible transcribed in "Draper Families in America , pg. 208".

!He was placed in an orphanage with his brother and sister when he was 3 years old. He was adopted by two spinster sisters named Fanne Mae MARLIN and Mary Lee (Molly) MARLIN and he carried that name throughout his life. They lived at Thompson Station, TN in a small farm house with their father. They had promised their mother that they would take care of him when she died. Earnest knew him as Grandpa and was very close to him.

They had cows, chickens and did light farming and sewing. He was treated very well - spoiled even! They attended the Baptist Church regularly and in the 1940's he was a Deacon in the North End Baptist Church in Nashville. He went to school in Thompson Station and went to Branhan-Hughes Military Academy in Franklin for his high school years and graduated there in 1928/29. He worked after that at the Boys Training School in Nashville. He wanted to go to college to study history but could not afford it. He was very interested in American History all his life. He met Louise Trudel at the Training School where she was employed as a registered nurse. They were married at the YMCA in Nashville, TN on April 5, 1935. (WAM Note: the days it appears he considered his birthday). He worked for the Baptist Sunday School Board in Nashville until he was drafted into the Navy. (Date unknown). He served at Norfolk, VA. He was honorably discharged at Ft Eustis, VA on 27 Dec 1944. He then worked for the Railway Postal Service. He moved to Atlanta when he got a government job at the Federal Prison in Atlanta in 1947 where he worked until he retired. In 1973 his home at 802 McConough Boulevard in Atlanta was destroyed by a tornado and a lot of family records were lost. He had adult onset diabetes in his last years and had a series of several strokes and was partially paralyzed when he suffered the heart attack that killed him in 1978.

!FAMILY TRADITION: His children always thought their grandmother's name was Lucy WHITE. They never saw her at all. Lucy came to Thompson Station, TN to see Earnest when he was 17 years old and he would not see her and went hunting in the woods to avoid her. As far as is known he never saw her in his adult life. Earnest's children always thought his father was killed accidentally on a railway bridge.

She was born April 21, 1907 in Trenton, Mercer, NJ, and died February 05, 1993 in Hudson, Pinellas, FL.

Notes for WILLIAM ARNOLD MORROW:

!Was known as "Arnold" to his relatives in Tennessee. Was known as "Bill" in New Jersey. His father was killed when he was 3 years old. He and his sister and brother were put in the "Roeser Orphanage" in Nashville. He attended school through the Sixth Grade. Arnold was put into various "foster homes" but would always run away (undoubtedly due to bad treatment). He ran away from the orphanage and joined the U.S. Marines at age 16 or 17 in Atlanta, GA, and after "Boot Training" at Parris Island, SC was stationed at Norfolk, VA; Haiti and the Naval Air Station, Lakehurst, NJ. While there he met Anna Mildred Wilson and after his discharge from the Marines they were married. Prior to their marriage he told his future wife that ALL of his family was dead. After they married he told her he had a sister living in Tennessee. Between 1929 and they made a "couple" of trips to Tennessee and Mississippi to visit his sister and aunts and uncles in Tennessee and his grandfather, Aunt Mae and cousin Bruner Morrow in Mississippi. According to Lorene Morrow Murray, he would always visit with a Ward Family in Baxter, TN during these visits. The Ward's were supposedly close with Stephen H. Morrow and his wife Lucy Goolsby (Bill's parents). The apparent reason for this relationship is that Minerva Alexander a daughter of Belle Dyer by her first husband, was married to G. Fate Ward of Baxter. This means that Minerva Alexander Ward and Lucy Goolsby Morrow were step sisters and therefore "kin". He worked as a "potter" and was a very accomplished artisan although he never worked for the same employer more than five years. Most of his adult life was spent in Trenton, Manasquan, and Mt. Holly, NJ although he worked for a brief time in Easton, Pa. He never owned a home and usually moved annually. He died of cancer of the prostate gland at age 53.

Notes for ANNA MILDRED WILSON:

!It is very interesting to note that both sets of her grandparents, Isaac Newton Wilson and Sarah Maria Higgins and John Henry Hann and Christie Titus were married within four months of each other in the same church by the same minister. Both men shown as residents of New Market, NJ. This was in Feb and May of 1878, twenty-nine years before Mildred was born. WAM speculates if they were married in the same church and lived in the same town, they probably knew each other.

!Was known as "Mildred or Mickey". After leaving high school (11th grade) in Trenton, NJ she worked for the Bell Telephone Company as a switchboard operator. She married and after having her four children she went to work as a dispatcher for the Yellow Cab Company in Trenton, NJ during the Second World War. In 1951 she separated from her husband, moved from Camden back to Trenton NJ and worked as a switchboard operator for Dunham's Department Store until she took early retirement at age 62 to care for her invalid mother in her final illness. After the death of Jack Ramsze (her daughter Virginia's husband), she moved to Tucson, AZ with Virginia and her family. After living there about 14 years she "took turns" living with her children between Manasquan, NJ; Houston, TX; and Hudson, FL. During her retirement Mildred did a lot of needlework and crocheting giving her handiwork to her children and twenty-two grandchildren. In about 1989, her son Melvin bought two houses in Hudson, FL and her daughter Lorene also bought a home there. These homes were within about 3 blocks of one another and Mel's second house was provided as a place for Mildred to live. She lived there on her own until mid 1992 when she was hospitalized on several occasions and had to move in with Mel and his wife Carol for the last six months of her life. Prior to her death she had expressed a desire to be

cremated. This was done at the time of her death but no "formal services" were conducted until Aug 1993 when her remains were buried in the same plot with her mother at the Greenwood Cemetery in Trenton, NJ. This was done in conjunction with the "2nd Sallie's Reunion" which was first held in 1988 as a gathering of the descendants of Sarah Cray Hann.

Mildred's ancestors have been in NJ for about 300 years. (Source: Personal recollections of WAM).

!Known as "Jack". He was killed in a one car accident one night while returning from work at his 2nd job.

Notes for MASTER CHIEF WILLIAM ARNOLD JR. MORROW:

!Born and raised in Trenton, NJ. As a child the family moved almost yearly although many of the moves were just from one house to another in Trenton. He started school at the Klockner Road Elementary near the old NJ State Fairground (now a shopping center). The family moved to Manasquan, NJ where he attended 1st grade at Manasquan Elementary. 2nd grade was back to Trenton to attend Slackwood Elementary and 3rd grade was completed at Jefferson Elementary in Trenton. 4th and part of 5th grade he attended Gregory Elementary and finished 5th through 8th grades at Manasquan Elementary. He attended Manasquan High

until the beginning of his sophomore year when the family moved to Camden, NJ where the sophomore year was completed at Woodrow Wilson High. Back to Trenton for the 11th and 12th grade where he graduated in 1953 from Trenton Central High. He worked 2 years at the Union Bag and Paper Company, starting as an office boy and progressing into the Shipping and Planning Departments. He had joined the U.S. Naval Reserve during his Junior year in high school and went on active duty with the Naval Reserve in July 1955. He was stationed at the Naval Air Station, Lakehurst, NJ from 1955 to 1960 when he took a release to inactive duty to work for the U.S. Post Office. His Post Office "career" came to an end when he had to deliver mail (including a supermarket circular to every stop on the route) during a hurricane. He went back on active duty with the Naval Reserve and served (again at NAS Lakehurst) until 1964 when he again left active duty to pursue a new career with the Prudential Life Insurance Company. This try at "civilian life" lasted for 5 months before he decided it was time to "get back in the Navy". In order to hold his rating as a Chief Petty Officer he had to accept an assignment at the Navy Department Headquarters in Washington, D.C. (located in Alexandria, VA). After 2 years there the family was transferred to the Fourth Naval District Headquarters at the Philadelphia Naval Shipyard. After being promoted to Senior Chief Petty Officer he was transferred back to Washington after just 19 months in Philadelphia. He served from 1969 to Jan 1974 as the TAR Enlisted Detailer at the Bureau of Naval Personnel. He was promoted to Master Chief Yeoman and was transferred for his final tour of duty to the Naval Reserve Readiness Command, Houston, Texas. He retired in September 1975 after 20 years of active duty and a total of 22 years service in the Naval Reserve.

He started a second career working for a small Oil and Gas Exploration Company called National Exploration Company. The company changed its name on several occasions and while a part of Anglo Energy Company the company declared bankruptcy (circa 1983). While working here he got involved with data processing and progressed from computer operator to RPGII programmer. Over a 30 year period he attended "off and on" various colleges and universities and accumulated about 36 semester hours (a little over a year). From 1983 on he worked mainly as an "independent contractor" working in office administration; personnel income tax preparation and finally back with the remnants of NEC (now called KCS Resources) in the Land Department setting up a computerized lease records system.

For over 20 years he pursued the hobby of pigeon racing and in 1991-1994 served as 5th Vice President of the American Racing Pigeon Union.

About 1989 he became interested in family history and did much research on his mother's ancestry and during 1994 started working on his father's side.

After several years he joined the Southland Corporation "Seven Eleven" and became the Regional Gasoline Manager for the Northeast section of the country. After 15 years with Southland the company had a "reduction in force" and he went to work for the "Dollar General" store chain and moved to Hudson, FL. After a few years he went to work as a Regional Manager for the "Cash America" pawn shop chain.
