Apparently Garland "Gallant" Anderson died late 1866. On January 4, 1867, Thomas A. Anderson deeded 45 acres in Dist. 9 of Putnam Co., TN to his brother Riley W. Anderson. Thomas and Riley were sons of Garland Anderson. This land was bounded by Garland's land in Buffalo Valley, Putnam Co., TN. Deed book states that Sarah Anderson, w/o Garland Anderson is deceased.

Family tradition states the Thomas A. Anderson built a home within sight of Silver Point, Putnam Co., TN on another farm. Riley W. Anderson's son, Louis Monroe Anderson purchased this farm after the death of his Uncle Thomas A. Anderson, about 1909 and he lived there. This house burnt down about 1960. Thomas A. Anderson's oldest son, named Riley was born in 1866 in all probability it was in this house. Riley W. Anderson lived a few miles away in a large two story log house where he was first buried, later his remains and tombstone were moved to Smellage Cemetery, Boma, Putnam Co., TN. Louis Monroe Anderson was born in this log house. On January 4, 1867 neither Thomas nor Riley were living in Buffalo Valley, but instead near Boma & Silver Point in Dist. 11. Although each of them owned land in Buffalo Valley, Putnam Co., TN, they didn't live there after they got married or at least not for long. According to family tradition the Anderson's moved out of Buffalo Valley and away from Indian Creek to the higher ground because people were getting sick from the fever, which they associated with Indian Creek. They thought the creek caused the fever. Riley W. Anderson and two of his daughters died of the flux.

*In the fall of 1885 there was a flux epidemic in Mine Lick Creek area of Putnam Co., TN. Riley, his daughters; Judian "Tiny" & Mary Jane became ill and died*

After Thomas Shirley Anderson's death, Garland and his brother and sisters made affidavit as to what they had received from their father during his lifetime. Garland's affidavit reads:

Gainesboro, TN 21<sup>st</sup> day of May 1860 – Garland Anderson, age 51 years swore:

**Question:** "You will state what money and property you received from your father in his lifetime by way of advancement to the best of your recollection and date of such advancement.

**Answer:** "I got from my father thirty dollars of money that belonged to my mother or came from her father's estate and gave him my note for same. I afterwards handed him back the money. I got a note on Alfred and Byrd S. Jones for twenty-eight or thirty dollars on which note I collected about twenty-two dollars. I never got my note back. My father paid for Edward Anderson, Joshua Bartlett and myself fifty dollars which I understand was an advancement to us, one third to each of us and was paid on land. I got a nag when I left my father worth perhaps 35 or 40 dollars. The horse that Paul Anderson spoke of in his disposition was given to my son Thomas by his grandfather Thomas Anderson now dec'd"

**Question:** "you will state what property or money if any Edward Anderson received from his father in his lifetime by way of advancement."

**Answer:** "I think Edward Anderson received one horse worth about one hundred dollars. I think he got one cow worth seven dollars over and above what the other children got. He had the use of a Negro named Al near three years which would have been at the time for at least \$80.00 per year. I understood that Edward paid \$80.00 toward the hire of said Negro and afterwards borrowed back \$40.00 of it. Edward told me this and so did my father. If Edward ever paid anything else toward the hire of said Negro I don't know it.

**Question:** "You will state what amount if any in property, money – debts paid or in way your father may have advanced to R.P. Mahany and wife in his lifetime. Say what your father may have said to you about this."

**Answer:** "I heard my father say that he had given my sister Fanny Reynolds forty dollars in cash. I heard my father say that he had expended between two and three hundred dollars in going to Missouri and moving R.P. Mahany and his wife back to this country but I don't know this of my own knowledge. He said he went after them of his own accord. If they sent for him I don't know it."

**Question:** "Say what your father advanced to his son William J. Anderson in money or property in his lifetime."

**Answer:** "I think at the time William was 20 years old he got 27 ½ dollars in cash. William also got a horse and saddle worth about fifty dollars. I understood from my father that he gave William thirty dollars of money that came by my mother. I did not see it."

"In obedience to a decree herein pronounced at last term of this court, the clerk and master reports that he had taken an account of the advancements made by Thomas Anderson in his lifetime to his children, the complainants and defendants, which report is as follows: July, 1860

Apparently Garland's fathers estate was not settled before August 1861 because the following record was found:

"The clerk and master of the Chancery Court of Jackson County at Gainesboro will pay to Paul Anderson the sum of \$500 our of my distributive share of the land and negroes of the estate of Thomas Anderson, deceased, sold by decree of the said county court for distribution among his heirs and this shall be my receipt and voucher to him for that amount of said funds to me by him distributed.

Louis Huston Gill, s/o Preston Gill and Addie Anderson gives this following information: "Garland was born at Blackburns Fork on Roaring River, a tributary of the Cumberland River, near Gainesboro in Jackson County, Tennessee. He and his brothers Thomas Anderson Jr. and Edward and their sister Annie Bartlett and her husband, went to Buffalo Valley about 1838. They had enough gold to buy land. I was told that Garland and Thomas, Jr. built their houses within sight of each other. I believe that Thomas' house later became known as the Doc. Scott Farmer house. Garland's house was destroyed by fire about 1950. It was a large two story house. His grandson, Louis Anderson and Louis' family lived there until about 1892. Garland liked to hunt and camp out on a hill top behind his home beneath two large chestnut trees where he asked to be buried. He said that was as close to heaven as he would ever get. He is buried there.



Thomas Anderson died about 1901 in the front room of this house. Lewis Monroe possibly passed away here in the same room. This house burnt down 1960.

Lewis Monroe Anderson's House. Built just after the Civil War by Tom A. Anderson, brother of Riley W. Anderson, Uncle of Lewis Monroe Anderson, son of Riley W. Anderson. Boma, Putnam Co., TN

Thomas Anderson was the son of Garland "Gallant" Anderson. It appears that Thomas Anderson joined the Northern Army near the end of the Civil War. Since his brother Riley Anderson served in the Southern Army there were probably some hard feelings between them.

After the Civil War, Thomas built a house just to the east and within sight of Silver Point located in Putnam Co., TN. This was on the Anderson Road near present I-40 Interstate Highway. He married Mary A. "Dump" Carr and they had several children at this home. The oldest son Riley was killed in a run-away wagon type accident as a youth. Thomas died in west room of this house. A few hundred feet east of this house and across the road from an old barn, Thomas, his wife, and their son Riley were buried next to the road in unmarked graves.

About 1909 Louis Monroe Anderson, s/o Riley Anderson & Micheal Elizabeth Alexander purchased the house and farm that belonged to Thomas Anderson. Louis Monroe Anderson lived on this farm and died on this farm 10 December 1935, possibly in the same room of the house that Thomas Anderson died in. The house remained in Louis Anderson's' family until after the death of his wife, Matilda Isabelle (Wallace) Anderson. The old house burned down in 1960.

The following is a portion of the first day's minutes of the next succeeding July 1842 Term of the Circuit Court of Putnam County: "July Term 1842." "Be it remembered that at a Court of Pleas began and held at the White Plains in and for the County of Putnam in the State of Tennessee, on the Second Monday, it being the 11<sup>th</sup> day of July in the year of Our Lord One Thousand Eight Hundred and Forty-Two. Present the Honorable **Abraham Caruthers**, one of the Judges of the Circuit Courts of the State of Tennessee and assigned to hold the Courts of the Fourth Judicial Circuit in said State; who took his seat, ordered said Court to be opened and proceeded to dispatch the business thereof."

“**James Bartlett**, the Sheriff of Putnam County, returned into Court the State’s Writ of Venire Facias to him directed, executed upon **Henry W. Sadler, Lawrence Byrne, McClellan Jones, Elijah Carr, David Patton, Abraham Ditty, John B. Pointer, John Choate, John Terry, Robert Peek, Rufus Finley, Augustine Lee, Robert Officer, John Bohannon, Benjamin F. Wroe, William K. Drallford, Henry S. McDaniel, William R. Vance, Garland Anderson and John Rodgers**, all good and lawful men of said County of Putnam, and also returns that he has by virtue of said Writ summoned **Isaac A. Huddleston and John L. Huddleston** to attend this Court as Constables.”
