



Deed – Josiah Bartlett & Mary Bartlett to Tim (Timothy) Denny

Know all men by these presents that we Josiah Bartlett and wife Mary Bartlett for the consideration of the sum of sixty-one dollars and sixty cents have this day bargained and sold and do hereby transfer and convey unto Tim Denny his heirs and assigns forever a certain track or parcel of land situate lying and being in the state of Tennessee County of Putnam and Civil District No. 11 on the waters of Indian Creek of Caney Fork River containing by survey four and nine sixteenths acres by the same more or less and bounded as follows. To wit beginning at a stone in Tim Denny's line it being the northeast corner of Robert Filmore Maxwell's land. Running thence north 20 poles to a buckeye thence east 72 poles to a kinoak thornbean thence south 76 degrees west seventy four poles to the beginning to have and to hold the above described track of land to the said Tim Denny and his and assigns forever we do covenant and bind ourselves our heirs and representatives to warrant and forever defend the title to said land and every part thereof against the lawful claims of all persons whomsoever set our hands whereof we have hereto set our hands and seals this twenty fifth day of September 1894.
