- Pg. 36. February the third Satureday and 18<sup>th</sup> day 1837. The Church met and after worship proceded to business, brother, **Joel Henley** chosen moderator of Spring Creek Church.
- Pg. 37. July the third Satureday & 15<sup>th</sup> day 1837. The church met and after worship appointed brother Benjamin Stewart moderator and proceeded to business. Appointed brethren **Elder Joel Henly**, Benjamin Mehany & Danl M. Morgan deligates to association.

Church met at Spring Creek and after worship proceeded to business, first; read and received a letter to send to the Assosiation; second; opined a dore for reception of members, and on Sabbath; Brother **Nimrod Hendly** and Sister Arrette Terry came forrod and relatted the work of grace on their heart, and on Monday ware baptised; for which the Church gladly receved them in ful fellow-ship; third; agreed to change the latter to represent two more members. S.H. Matheney (Clk) Elder **Joel Hendly** (Mod)

Nimrod Hendly is the s/o Joel Hendly. Nimrod Hendly was probably baptized by his father.
