To all to whom these presents shall come, Greeting:

KNOW YE, That In consideration of Military Service performed by **Moses Newsom** to the State of North Carolina warrant No 18603 dated the 2nd day of January 1790 for 640 acres and entered on the 31st day of August 1807 by No 235 as his accepted claim.

There is granted by the said state of Tennessee, unto **William Jarred** assignee of the said warrant by survey bearing date the 1st day of May 1808 lying in the first District of Jackson County in the sixth Section third range and bounded as follows to wit Beginning at a cherry tree at a point eight hundred and thirty eight poles south of a place on the north boundary line of said section which place is two hundred and sixty Eight poles east of the \_\_\_\_\_ and six hundred and ninety two poles west of the north east corner of said section thence running east eighty five poles to two sugartrees and hickory thence west eighty five poles to a beech and ash thence south eighty five poles to the Beginning.

With the hereditaments and appertenances. To have and to hold the said tract or parcel of Land, with its appertenances to the said **William Jarred** and his heirs forever. In witness whereof, **William Carroll** Governor of the state of Tennessee, hath hereunto set his hand, and caused the great seal of the state to be affixed, at Murfreesborough on the 11th day of December in the year of our Lord one thousand eight hundred and twenty two and of the Independence of the United States, the forty seventh

There is granted by the said State of Tennessee, unto **John Boyd**.

A certain tract or parcel of land containing One hundred and Thirty Seven Acres by survey bearing the date the 24th day of March 1826 lying in said county in the Rock Springs Valley the waters of the Caney fork and Bounded as follows to wit Beginning at an elm ash and Sugartree Runs thence South Sixty four poles to a stake in **Joseph Jareds** field and in the north Boundary line of **James Raulston** 1000 acre tract thence east One hundred and five poles to a White Oak Said Raulstons north east corner thence south with his line 91 poles to a large White Oak thence east 98 poles to two Sugartrees on the top of

Know ye, That for and in consideration of the sum of twelve and one half cents per acre, paid into the office of the Entry-taker of Jackson county, and entered on the 28th day of June 1824, pursuant to the provisions of an Act of the General Assembly of said state, passed on the 22nd day of November, 1823 by No. 156.

There is granted by the said State of Tennessee, unto **Joseph Jared** A certain tract or parcel of land, containing fifty acres by survey bearing date the 23rd day of March 1825, lying in said county, in the Rock Spring Valley the waters of the Caney fork and bounded as follows to wit Beginning at a stake in his field on South West Corner of **John Boyds** 137 acre tract and in the north boundary line of **James Raulston**, 1000 acre tract Running thence north one hundred poles to a elm and Buckeye thence West 80 poles crossing the pond Spring Road to a dogwood and Mulberry on the West Side of a hill thence South one hundred poles to an ash Sapling and two Ironwood saplings in the north boundary line of said **Raulstons** tract thence West with his line eighty poles to the Beginning.

papers on the 9<sup>th</sup> day of January 1830 there is Granted by the said State of Tennessee unto **Joseph Jared** and **William Jared** a certain tract or parcel of land containing six hundred and forty acres by Survey bearing date the 29<sup>th</sup> day of March 1838 Lying in said County on the waters of Indian Creek of Caney fork Beginning at an Elm north west corner of a tract of one hundred acres entered by **William Jarred Dec'd** Running thence East with said tract one hundred and thirty eight poles to a white walnut corner of said tract thence south with said tract one hundred and twelve poles to a stake four bushes Buckeye and Hornbeam pointers in the north boundary line of **Harmon Youngs** tract thence East with said line crossing a road and the north fork of **Youngs** Creek of Indian Creek at 70 poles crossing a small branch of said Creek at 356 poles in all four hundred and Seventy two poles to two Double Lynns on the bank of said **Youngs** fork above **Daniel Malones** House thence north crossing said fork at twenty poles and crossing a road from **Youngs** Mill at 188 poles crossing the north fork of Indian at 374 poles passing the top of the Hill near **Ellisons** field in all four hundred and Eighty two poles to a large poplar beech and Elm on the north side of a point of a Ridge thence west crossing **Shaws** Hollow crossing the road at **John Whitefields** crossing a branch below **George Newmans** at 514 poles in all 610 poles to a stake thence south crossing the north fork of Indian Creek in all 370 poles to the Beginning including and excluding Eleven hundred acres of prior claims – With the Hereditaments and appertenances to have and to hold the said tract or parcel of Land with its appertenances to the said **Joseph Jared** and **William Jared** and their heirs forever In Witness whereof **Newton Cannon** Governor of the State of Tennessee has hereunto set his hand and caused the Great Seal of the State to be affixed at Nashville on the 2<sup>nd</sup> day of September 1839 and 64 Year of our Independence.
