Mrs. Mary Elizabeth Jared Passes Away:

The Putnam County Herald, TN– 17 December 1925

In the death of Mrs. Mary Elizabeth Huddleston Jared, which occurred Tuesday, December 15<sup>th</sup>, Putnam County, TN lost one of its most beloved women. Her death occurred at the home of her daughter, Mrs. S. H. McDonald at Elmwood.

Mrs. Jared was born near Gentry, in this county on July 6, 1845, where she lived with her parents until her marriage to W. J. Jared, July 27, 1866. To this union were born eight children, two dying in infancy.

Mrs. Jared was converted and united with the Methodist church in girlhood and lived each day a life of service to her Master and the church. She was always ready and willing to serve the community in which she made her home and many were the visits made to the sick and unfortunate.

Surviving her are three daughters, Mrs. S. A. Ditty, of Baxter, TN(*Florilla Jared md Sam Ditty*); Mrs. (Susan) “Susie” Jared Foster, Cookeville, TN (*md Charlie Foster*) ; Mrs. S.H. McDonald, Elmwood, TN (*Vallee Jared md Haskell McDonald*); and three sons, Frank Jared, Denison, TX, Lee Jared, Baxter, TN; Beersheba “Bersh” Jared, Cookeville, TN (*md 9 August 1908, Mary Myrtle Jones*); and several grandchildren and great-grandchildren.

Funeral services were conducted at the Cookeville Methodist church by Dr. H. M. Jarvis, presiding Elder of the Cookeville district, assisted by Rev. Dow Ensor. Interment in the Cookeville cemetery beside the husband of her youth who preceded her to the grave six years ago.

**Estate of James Beersheba Jared, Deceased, Opal Jared Gay Administratrix,  
 In the Probate Court for Putnam Co., TN**

**PETITION:**

COMES NOW Opal Jared Gay, individually and as admistratrix of the estate of James Beersheba Jared, and would show unto the Court:

I.

That the petitioner herein is the only child and heir at law of James Beersheba Jared, and that the said James Beersheba Jared died intestate and was, at the time of his death, a single person, being the widower of Mary Myrtle Jared, deceased. Therefore, your petitioner avers that she is the only person entitled to receive any of the property of the decedent by interstate distribution or succession.

II.

Petitioner avers that statutory notice to creditors was duly published in the Putnam County Herald commencing on November 4, 1965. The record in this cause discloses that only one claim, by The Putnam County Herald, for \$4.70, has been filed to the date of the filing of this petition. It is the petitioner's belief that there will not be other claims

filed in this cause; however, she will seek a report of the Clerk on the date that this matter comes on to be finally heard. Notice has been posted on the date of the filing of this petition that this petitioner will seek to have this petition approved as her final settlement at 9:00 a.m. on the 9<sup>th</sup> day of August, 1966, which will be a date after the expiration of the statutory nine-month period in which creditors are entitled to file claims.

Attached to this petition and filed herewith as Exhibit "A" is a receipt for the payment of said claim in full. A proper inheritance tax return has been filed with the State of Tennessee, and attached hereto and filed as Exhibit "B" to this petition is a RECEIPT from the State of Tennessee acknowledging full payment of inheritance tax upon this estate. Petitioner avers that the Court cost in this cause, including the charge for the filing of this petition and a final order in this cause amounts to \$9.65, and attached to this petition and filed herewith as Exhibit "C" is a receipt for full payment of the same.

### III.

That, accordingly, your petitioner avers that she has fully discharged her duties as administratrix in this cause, having paid all creditors who have proper claims against the estate, and having paid the inheritance tax due to the State of Tennessee. Therefore, this petitioner prays that this petition be treated as the final settlement of the estate of James Beersheba Jared, deceased, by Opal Jared Gay, as the administratrix of said estate, and that an order be entered in this cause approving the same as such, discharging her and her bondsmen in the cause.
