**1874 Putnam County School District**

Upper Cumberland Genealogical Association, Cookeville, TN  
Vol. 7, No. 4 – pp. 98 – 105

The following is taken from a book found in the Putnam County Trustee’s office, entitled “Record of Co. Supt.” In 1873 Putnam County was divided into 16 school districts, and three commissioners were elected for each district. By September 1874 “the population of the children from 6 to 18 entitled to go to school in the county amounted 3535”, and the county was laid off into 38 school districts. Spelling as written in original document.

District No. 1

Beginning at James Welches Sr. including him, thence to Nancy Byeres, thence to **Arena Thompsons** including her, thence to Joshua Whites including him, thence with the Cookeville road to M.N. Scarlets so as to include him, thence to Eligah Judds including him, thence to Joel Gabberts including him, thence to Edward Ramseys including the farm he lives on, thence to John Murrays, thence to Joseph Caruthers including them, thence with the Rock Island road to the Robert Burton old place including it, thence to Kiziah Vicks including her, thence west to the old Fisk road, thence South with said road to Henry Cannons (Col), thence Westward with the old Walton road to the beginning including all on said road. Site or location for Schoolhouse at or near Cookeville.

District No. 2

Beginning at the said James Welches Sr. running thence Eastward with the old Walton road and with the North boundary line of District No. 1 to the Old Fisk road, thence Northward with said Fisk road to Peyton Pearsons, thence to Absalum Willims including them, thence to Curtis Dowels, thence to Nathan Bartletts, thence to Loving Harps including them, thence a direct line to where the Cookeville and Spring Creek road crosses the County line, thence Westward with the county line opposite Wm. Beans, so as to include him, thence to Eligia Wassoms, so as to include him, thence a direct line to **Wesley Bullingtons** including him, thence to the beginning. Site or location for Schoolhouse at or near Smyrna Schoolhouse.

District No. 3

Beginning at Robert Burton’s old place, running thence Eastward with the old Walton road to Isaac Buck’s old place, at the foot of Cumberland Mountain, thence Southwards to the top of the Mountain, thence with the extreme top of the same to Thos. Pointers including him, thence to Wm. H. Barnes including him, thence with the foot of the mountain to Robert Peoks Jr. including him, to **John L Huddleston** including him, thence to John Sligers including him, thence to John Pharises including him, thence to Polly Moore including her, thence Northward with the Cookeville road to Joel Gabberts thence with District line No. 1 to the beginning. Site or location for Schoolhouse at or near Salem.

#### District No. 4

Beginning at Joshua Whites running thence a direct line to long John Carrs including him, thence to W.P. Stones, thence to David Bradfords including them, thence to W.L. Ray including him, then to John Wests, thence to John Pharrises thence with the line of Dists. No. 3 & 1 to the beginning. Site or location for Schoolhouse at or near Lee Seminary.

#### District No. 5

Beginning on the County line opposite Wm. Beans, the same being the Northwest corner of Dist. No. 2 Running thence with the line between Jackson and Putnam Countys to Reben Whitsons including him, thence up the West prong of Blackburn's fork with its meanders to the Gainesboro and Sparta road, thence with said road to Buffalo Valley road, thence Eastward with said road to Joshua Whites, thence with District line No. 1 & 2 to the beginning including Nancy Byers. Site of location for house at or near Postoak.

#### District No. 6

Beginning on the county line near Ruben Whitsons it being the Northwest corner of District No. 5, running w, with the line between Jackson and Putnam Counties to the James Goolsby old place including that, thence up the West prong of Martins Creek to the Walton road to the widow Allison including all on said Creek thence with the Sparta road to **John Allison** and including him, thence with the old road leading to **R. F. Cook's** old place, thence with the Cookeville road to the Sparta and Gainesboro road, thence with District line No. 5 to the beginning Site or location for school-house at or near Bloomington.

#### District No. 7

Beginning at Joshua Whites, running Westwards with the Buffalo Valley road to the Sparta and Gainesboro road, including all on said road, thence Southwards with the divide between Can Creek and Mine Lick to the J. H. Witt place including it, thence Eastwards to Wm. Fugissas including him, thence Eastwards so as to include all of the Cammells to the Ridge road, thence a direct line to the Washington Burgess old place, then a direct line to W. L. Rays, thence with District Line No. 4, to the beginning. Site or location for Schoolhouse at or near **W. H. Gentrys**.

#### District No. 8

Beginning where the Buffalo Valley and Gainesboro and Sparta Road crosses, the same being the corner of District No. 5, 6, 7, thence Westwards with District line No. 6, to the Widow Allisons, including that place, thence Southwards with Thomas', thence a direct line to Sarah McCaleb's, thence with the road to Elmores Mill, thence a direct line to Robert Taylors, including him, thence to Joseph Pattens, including him, thence to **Joseph Allison's** (Mine Lick) thence to the Witt place the South West corner of District No. 7, thence Northward with said District line to the beginning. Site or location for Schoolhouse at or near Amon Medley's.

#### District No. 9

Beginning at the Widow Goolsby's, the N.W. corner of District No. 6, and on the line between Jackson and Putnam Counties, running thence Westwards with said line to Luke Gillum thence a direct line to Simpson Marlows including him, thence up the McBroom branch to its fork, above Anthony McBroom's, including all on said branch, thence up the right hand prong to Wm. McBroom's, thence with the Ridge Road leading

to S. B. McDearman's on the Walton road, thence Northward with the line of District No. 6, to the beginning. Site or location for Schoolhouse at or near Wm. Rogers.

#### District No. 10

Beginning on the county line near Luke Gillum's the Northwest corner of District No. 9, running thence with said line to near the Widow Pates on Martin's Creek including her, thence up a branch to Milton Stanton's, thence up the branch to Dill Stanton's including all on said branch, thence with the road leading to Caroline Rowland's on the Walton road including C. P. Herd, also including said Rowland, thence up said road to the corner of District No. 9, including all on said road, thence with the line of said District to the beginning. Site or location for Schoolhouse at or near Sydney Stanton's.

#### District No. 11

Beginning on the County line near the widow Pate's, the N.W. Corner of District No. 10, running West with said line to the Smith County line, thence Southward with said line to the Walton road, excluding John Watts, thence with said road Eastward to Caroline Rowland's the S. W. corner of District No. 10, excluding all on said road, thence with the line of said District to the beginning. Site or location for Schoolhouse at or near Joseph Bockman's.

#### District No. 12

Beginning where the Walton road crosses the line between Smith and Putnam Counties, running Southward with the same to the mouth of Rock Spring Valley, thence with the dividing ridge between Rock Spring Valley and Indian Creek near **James Pullums**, thence Southwards to **Henry Bartlett's**, thence Northward to the top of the ridge including all of the **Medleys**, thence with the top of said ridge to **Samuel Jared's**, thence a direct line to W. Q. Hughes' on the Walton road, thence West with said road to the beginning including all on said road and also **John Watts**. Site or location for Schoolhouse at or near the fork of Rock Spring, near and below **Elisebith Maddux**.

#### District No. 13

Beginning on the County line and on the Corner of District No. 12, at the mouth of Rock Spring Valley, running thence up the river Caney Fork to the DeKalb County line, thence Southward with said line to near Robert Smith's including him, thence Eastwardly to George Jones' thence to R. B. Waller's, including them, thence the same direction to Jessie McGuffee's, including him, thence Northwards with the dividing ridge between Buffalo Valley and Indian Creek, to **Henry Bartlett's**, including him, thence Northwards to the top of the ridge between Indian Creek and Rock Spring Valley near **James Pullum's**, thence down said ridge with the line of District No. 12, to the beginning. Site or location for Schoolhouse at or near **Joshua Bartlett's**.

#### District No. 14

Beginning at Caroline Rowlands on the Walton Road the corner of Districts No. 10 & 11, running thence with the Walton Road with the District line No. 11, to W. Q. Hughes' excluding all on said Road, thence Southwestwards with the District line No. 12, to **Henry Bartlett's**, thence Southwards with line of District No. 13, to Jesse McGuffee's, then Northeastward with the old Road leading to Young's old mill place, thence Eastward with the dividing Ridge between **Jared's Fork** and **Young's Fork** of Indian Creek to **Zebidee Carr's**, thence Northward to the widow Robinson's, thence with the Ridge Road Northward to the beginning. Site or location for Schoolhouse at or near **Peter Young's**.

#### District No. 15

Beginning at **Young's** old mill place on Indian Creek in the S. E. boundary of District No. 14, running thence Southwards with said District line to **Jessee McGuffee's**, thence Eastward to **McDanel Wallaces**, thence continuing Eastward to **Eligia Carr's**, thence a Northward direction to the widow **Smellege's** thence Westwardly with the Ridge Road leading from said Smelleges to **Zebidee Carr's**, thence Southwestward with the line of District No. 14, to the beginning. Site or location for Schoolhouse at or near **Mosses Whitehead's**.

#### District No. 16

Beginning at Jessee McGuffee's, running thence Southwards with District line No. 13, to the line between DeKalb and Putnam Countries, near Robert Smiths, thence Eastward with said line to **Casleton Henley's** old place, thence Northward to Absalum Parner's including him, thence the same direction to **Silas Anderson's** including him, thence a direct line to James Holley's, including him, thence a direct line to Eligia Carr's, including him, thence Westward with the line of the 15<sup>th</sup> District to the beginning. Site or location for Schoolhouse at or near the fork of the creek near **W. N. Gentry's**.

#### District No. 17

Beginning at the widow Allison's on the Walton Road, the corner of Districts No. 6, 8, & 9, running thence Westward with the line of Districts No. 9 & 10, Caroline Rowlands, including Richard Allison, Rufus Bruce and Wm. Young, thence southwards with District line No. 14 to Zebidee Carr's, thence Southwards to the widow Smellege's, thence Northwards a direct line to Dias Lee's, thence a direct line to Robert Aron's, thence a direct line to the fork of Indian Creek below Joseph Thomas', thence with the District line No. 8, to the beginning. Site or location for Schoolhouse at or near the fork of the creek new **W.N. Gentry's**.

#### District No. 18

Beginning at the fork of the creek below Joseph Thomas', the corner of District No. 8, running thence Southwestward with District line No. 17, to the widow Smellege's, including Robert Aron and Dias Lee, thence with the line of District No. 15, to Eligia Carr's, thence with the line of District No. 16, to **Silas Anderson's**, thence a direct line to Bryants mill, thence a direct line to the Town Branch where the road crosses the same below Presley Bussell's, thence Eastward to the said Bussell's, thence a direct line to the Witt place, thence Northward with District line No. 8, to the beginning. Site or location for Schoolhouse at or near Wm. Brazells on Mine Lick Creek.

#### District No. 19

Beginning at the County line between DeKalb and Putnam Counties near **Chapleton Henely's** old place the Southeast corner of District No. 16, running thence South eastwards with said County line to Dry Creek, thence a direct line to Thos. Lafever's crock kill, Thence to Walker Matins excluding him, thence to Joseph Sherrell's including him, thence to Wm. Hickey's including him, thence to A.R. Massey's including him thence a direct line to Wm. H. Allison's, thence to Presley Bussell's so as to include Alexander Jaco, thence down the Town Branch to the line of District No. 18, thence Southeastwards with the same to Bryant's mill on Mine lick, thence to **Silas Anderson's** on the line of District No. 16, thence with the same to the beginning. Site or location for Schoolhouse at or near Jacob Bear's.

#### District No. 20

Beginning on Dry Creek where the line between DeKalb and Putnam Counties crossed the same running thence South East with said line to the White County line, and with the same to William's Mill on the Falling Watter, thence down said Falling Watter to the Low Gap between said Falling Water and Cane Creek so as to include John Sherrell, thence to Joseph Sherrells; thence with District Line No. 19, to the beginning. Site or location for Schoolhouse at or near the Vison old place on Falling Watter.

#### District No. 21

Beginning at the County Line between White and Putnam near William's Mill; running thence up the Falling Water and with said County Line to Zenath Nicholas' said line to the Witt place; thence with District Line No. 7, thence Westward with said line to the Witt place; thence with District Line No. 18, to Pressley Bussles; thence Southward with District Line No. 19, to the District Line No. 20; thence with said line up the River to the beginning. Site or Location for Schoolhouse at or near Boiling Springs.

#### District No. 22

Beginning on the North East corner District No. 1, on the Old Walton Road, at the Robert Berton old Place, running thence Eastward with said Walton Road to the top of the mountain where the Road leading to Rockhold Place leaves the said Walton Road, thence Northward with the top of the first Mountain to W.E. Martin's including all on the West Side of said Mountain; thence Westward to Prier Roberson's; Thence to J. H. Murphreys, thence to T. C. Webbs; thence to Samuel Welche's; thence to Joseph Peak's Spring; thence down said Spring branch to Bear Creek; thence to William Gilloms; thence to Simeon Phillips; thence a direct line to Peyton Pearson's on the Old Fisk Road; thence South with said Road to District Line No. 15 thence Eastward with said line to the beginning. Site or Location for schoolhouse at or near Oakhill.

#### District No. 23

Beginning at Peyton Pearson's on the old Fisk Road it being the North East corner of District No. 2; running thence westward with District Line No. 2 to where the Road leading from Cookeville to the Mouth of Spring Creek cross the line between Jackson & Putnam Counties the same being the N. W. corner of said District No. 2 Running thence Northwards with said County line opposite Jack Ballard's; thence Eastwards to the said Ballards including him; thence to the Spradly Place including that; thence a direct line to E. W. Teme's including him, thence to J. N. Harps including him; then to J. M. Thasher's including him; thence to the Mouth of Louis More's Spring Brach including him; thence up Bear Creek to the mouth of Joseph Peaks Spring Brach; thence Westwards with the District Line No. 22 to the beginning including all on said line. Site or Location for Schoolhouse at or near Bangom.

#### District No. 24

Beginning at the mouth of Lewis More's Spring Brach on Bear Creek, running thence Westward with District Line No. 23 to the County Line between Jackson and Putnam the same being the corner of District No. 23; thence Northward with said line to the Overton County Line; thence with said line to the Mouth of Bear Creek; thence up said creek to the beginning. Site or location for school house at or near Sarah Terrys or Larkin Merit's.

#### District No. 25

Beginning at the mouth of Bear Creek, running thence up said Creek to the mouth of Joseph Peakes Spring Branch; thence Eastward with Dist. Line No. 22 to W. E. Martins including all on said Line; thence to

Elviry Peaks; thence to the County Line at the Holeford old place, the same being the line between Overton & Putnam Counties; thence with said line to the beginning. Site or Location for Schoolhouse at or near the schoolhouse standing near the widow Wilmoth's.

District No. 26

Beginning on the line between Overton & Putnam Counties, at the Holeford Old Place on Spring Creek; running thence Eastward with said line to T.F. McDonal's; thence Southward to Wm. Cooper's on the Walton Road including him; thence Westward with said road to where the road leading down to the Widow Rockholds leaves the said Walton Road; thence Northward with Dist. Line No. 22 to W. E. Martin's; thence to the widow Poteet's with Dist. Line No. 25 and the Rock Island Road to the beginning. Site or Location for schoolhouse at or near Wm Rector's

District No. 27

Beginning on the County Line between Overton & Putnam Counties near L. F. McDonals running thence Eastward with said line to due North of Nathan Welches; thence Southward to the said Welches including him; thence Southward to the Walton Road near Alexander Swafford's including him; thence Southward to John Hick's; thence Westward to corner or Dist. No. 26 on the Walton Road at Wm. Cooper's; thence Eastward with the East boundary line of the same, to the beginning including Alx. West, Jerry Vaughn. Site or location for schoolhouse at or near a new house being buit on Muddy Brach.

District No. 28

Beginning on the County Line between Overton & Putnam Counties, the same being the North East corner of District No. 27 North Nathan Welches; running Sothward with said district line to Alaxander Swarfords on the Walton road. Thence a direct line to pinhook on the Dry Valley road. Thence Eastward to the Stamps Cabin on the Cumberland Mountains including that. Thence East to the Cumberland County line. Thence northward & Westwards with the adjoining County lines to the beginning. Site or location for schoolhouse at or near the widow Calahans for the one place and at or near James Fords for the other.

District No. 29

Beginning at a place called Pinhook on the Dry Valley Road the S.W. Corner of District No. 28; running thence Eastward with the South boundary line of said District to the Cumberland County line, thence Southward with said line to a point where a due West line will pass. The Icy Cove leaving said Cove on the south side of said line; thence Westward to Alexander Bohanans including him; thence a North Westward direction to J. B. Pointers including R. Roberson & excluding T. Pointer; thence Northward to James Scarberries, excluding him; thence North to J. W. Whiteacres thence a North East direction to the Beginning. Site or location for schoolhouse at or near David Farleys.

District No. 30

Beginning on the Cumberland County line it being the South East corner of District No. 27 running thence Southward with said line to the White County line; thence Westward with said line to where the road leading from Calf Killer to Sparta crosses the same thence to Abert Harris including him; thence to J. W. Pointers; thence Eastwards with District line No. 20 to the beginning. Site or location for Schoolhouse at or near Samuel Johnson's.

District No. 31

Beginning where the road leading from Calf Killer to Sparta crosses the County line the Southwest corner of District No. 30 running thence Westward with said line to the top of the ridge between the Board Valley and the Waters of Cherry Creek; thence Northward with said ridge to the Cookeville road, including the Clowses & Bumbalows thence Eastward with the said road to the Sandy Hollow; thence District line to Henderson Conely including him; thence Eastward to James Scarberries including Jessee Sherrill, Benjamin Selvy, Simeon Selery & Sam Seloy & Wm. Sparks; thence Southward with the line of Districts 29 & 30, to the beginning. Site or location for schoolhouse at or near a new schoolhouse near Thos. Clouse.

District No. 32

Beginning at Alexandra Swarfords & the Walton road running thence Southward direction with District line No. 27 to John Hixes including him; thence with said line to the George Miller place; thence a Southward directions to W. M. Grants excluding him; thence a Southward direction to Jack Howards excluding him thence a Southward direction to Abraham Walkers, excluding him; thence a Southward direction to Thomas Wilsons, including him; thence Southeast to District No. 29 and with said line to Pinhook, thence Northwest with District line No. 28 to the beginning. Site or location at or near the Jackson Lee Schoolhouse.

District No. 33

Beginning at James Scarberries Southeast corner of District No. 31 & 29 running thence Eastward to the line of District 27 to the corner of District no. 32; thence a Northwest direction to Jack Howards; thence a Westward direction to Elu Jacksons excluding him; thence a Southward direction to B. W. Wooten so as to exclude J. M. Hyder and include said Wooten; thence Southward to Francies McClouds; thence to James McCloud including them; thence South east to the Sandy Hollow on the Cookeville road in the line of District No. 31; thence with said line to the beginning. Site or location for Schoolhouse at or near Mountzion.

District No. 34

Beginning on the Walton road at W. M. Coopers the Southeast corner of District No. 26, running thence Westward with said road to the Southeast corner of District No. 27 Southwest corner of District No. 26, thence a direct line running to Gehosa Runnels excluding him; thence a direct line to John Bohanans excluding him; thence a direct lien to Eliu Jacksons excluding him in the line of District No. 23; thence Northeast with said line to Zachariah Lees thence with said line and with of District No. 32 to the George Millers place and the line of District No. 37, Thence with said District to the beginning. Site or location for schoolhouse at or near James Schoolhouse.

District No. 35

Beginning on the Walton road the N. W. corner of District No. 34 running thence westward with said road to Isaac Bucks old place including it, it being the N. E. od District No. 3 – Thence south with said District line to J. L. Huddlestons, thence a direct line to Hiram Browns, excluding him thence Eastwards to J. R. Watsons, excluding him, thence to Mira Clarks excluding her; thence to the top of the ridge Dividing the waters of Falling Waters and Dry Valley; thence Eastward with top of said ridge to Elias Whitackers; excluding him; thence Eastwardly to head of the Bear Hollow in the District line to Elius Jacksons including him, the corner of District No. 34; thence a Northwestward direction with said District line to the beginning. Site or location at or near the mouth to Hyder Spring Branch.

#### District No. 36

Beginning at John Browns on the Cherry Creek Road excluding him, running thence Southwards with said road to Harrit Willhites including her; thence to the widow Leonides Willhites including her; thence to John Williams, including him, Thence a southward directions to the White county line near William Clarks including him. Thence Eastwards With said line to the top of the ridge between Bord Valley and Cherry Creek the same being the S.W. corner of dist. No. 31 thence N. E. with the line of the same to the Sandy Hollow. Thence Westward with Dist. line No. 33 to the corner of Dist. No. 35. Thence Westward with Dist. line No. 35 to the beginning. Sight or location for SchoolHouse at or near the Dry Valley Meeting House.

#### District No. 37

Beginning where the County line crosses the Falling Water running thence Eastward with said county line opposite W. M. Clarks the Southwest Corner or District No. 36; thence Northwest with said District line to line of District No. 35 near John Browns; thence Westwards with the said District line to **J.L. Huddlestons** the line of Districts No. 3; thence a Southwest direction with said line to the rock island Road thence Southwestward with said road to Bejimans Mackies; thence with road to the Messingers Mill to the ford and falling water; thence down said Falling Water to the beginning. Site or location for schoolhouse at or near the old Bridge between J. R. Peaks & McWilhites.

#### District No. 38

Beginning at or near Zenith Nichols on the White County line running with said line to where the same crosses the Falling Water, the Southwest corner of District No. 37, thence Northward with said line to the line of District No. 3 where said line crosses the Rockisland Road; thence westward with the line of the same to the line of District No. 7; thence Southward with the East boundary line of the same & to No. 21 to the beginning. Site or Location for school house at or near or between the widow McBrides and Isaac Davis.

By agreement of Directors the District lines of school District No. 2 and 23 is so changed that H.L. C. Pearson, Nancy Phy, John Clakr & Kissiah Vick are attached from School Dist. No. 23 & attached to Dist. 2 & the schoolhouses in said dist. are located one at the Josiah Kuykenall & the other at or in the neighborhood of Eli Shiplly.

I paid official visits, as Supt., to about fifteen or twenty schools in the County, and the schools began to stop & dwindle to an insignificant number, then I ceased visiting. Close of b. M. Webb's Term, 31<sup>st</sup> Dec 1874.
