Huddleston Joel Burgess and his wife Ruth Burgess Isaac A Huddleston and John Campbell Heirs at Law of the estate of John Ellison Deceased have this day bargained and Sold and do hereby transfer and convey to James Ellison, Jr and for his heirs forever for the consideration of one hundred and Eighty Dollars to us in hand paid the following described tracts of Land in the State f Tennessee White County and in District #____containing by estimate one hundred and forty acres be the same more or less lying on Cane Creek and bounded as follows:

Beginning at a chestnut and pointers The South West corner of the original fifty acre tract granted to the Said John Ellison Dc'd by Grant No 6766 runing thence North one hundred and forty nine poles to a chestnut and pointers the North west corner of Said Ellisons Thirty acre tract thence East ninety Eight poles to a Black oak and pointers thence South Eighteen poles to a Stake and pointers the corner of a conditional_____between the Said John Ellison Deceased and William Ellison thence East sixteen poles to the North west corner of Said William Allison thirty acre tract to a black oak thence South ninety Eight poles to a sassafras to the south west corner of Said thirty acre tract thence East forty nine poles to a Hickory the South East corner of Said thirty acre tract thence South fifty two poles to a white oak on the South bank of Cane Creek William Allisons South west corner Thence west fifty Eight poles to a post oak and Black oak the north west corner of Joseph Allison one hundred and fifty acre tract thence South eleven poles to a Hickory Thence west with James Allison, Sr north Boundary line in all seventy nine poles to a Black oak and Hickory the South west corner of Said Joseph Ellisons Dc'd Twenty acre tract thence North with the west boundary line of said Said twenty acre tract thirty five poles to a post oak the North west and Beginning corner of said twenty acre tract thence west Thirty poles to the Beginning including the mansion house and all the improvements of the Said John Allison Dc'd together with the tracts and parts of tract of Land Saaid John Allison Dec'd seized or possessed of to have and to hold the same to the Said James Allison Jr his heirs ad assigns forever we do covenant and bind our selves our heirs and representation to warrant and defend the title of the Said land to James Allison, Jr his heirs and assigns forever against any claims to be made by our selves or any person Claiming through or under us but no further this the 24 Day of November 1847. Executed and delivered in our presents Nov. 1847
