In the early 1800's, two brothers, **William Joseph Henry** and **Elijah Kerr**, moved from Virginia to Silver Point, Tennessee. There is some disagreement among local historians on the birthplaces of these men and facts about their lives before they settled at Silver Point, but it is generally agreed that their father was a Revolutionary War soldier of the English-Irish descent.

These two men eventually adopted the English spelling of their name, C-A-R-R. Regardless of this, some of their descendants chose to keep the original spelling (K-E-R-R), while others used both spellings at different times during their lives.

William Joseph Henry was married to Naomi Jared, daughter of Revolutionary War hero Joseph Jared. He was influential in establishing Putnam County from the existing surrounding counties and served as its first Circuit Court Clerk in 1842.

William Joseph Henry and Naomi raised six sons and three daughters. The oldest of their sons was James R. Carr who was born in 1811.

James R. married **Caroline Allen** of the Carroll County, Virginia Allens. Caroline was from a prestigious family of which some had moved to Tennessee about the same time as the Carrs. Caroline had an aunt, **Sophia Allen**, who was the wife of **George Washington's** nephew, **George Lewis** and a cousin, **Eliza Allen**, who was **Sam Houston's** first wife.

James R. was a farmer and **Caroline** was a seamstress. James R. and his ten sons worked the family farm in Silver Point, Tennessee. The two oldest boys, **Joseph** and **William** joined the Confederate 5th Calvary




in 1861 to protect their homeland from the invading Northern Armies. Joseph was shot in the foot in battle and contracted smallpox, so he had to return home in 1864. William fought throughout the duration of the war.

Another of James R.'s sons was Sidney Franklin Carr, the youngest who served as a Putnam County State Representative for several terms. Sidney's son, Joe C. Carr, Sr. served as Secretary of the State of Tennessee for several terms. Joe C. Carr pictured left.

Still another of James R.'s sons, **Winfield Scott** (alias Kerr), became a career soldier after the Civil War, serving during the Spanish American War. **Winfield Scott** married **Nancy Carter** in 1871. They had four sons and five daughters, **Eliza Jane**, **Ettno Amanda**, **Solan Stephen**, **Andrew Frank**, **Bradley Lorenzie**, **Mattie**, **Arzonie Hattie** and **Pearl Avo**.

Because of Winfield Scott's travels in the army, he was away from their Silver Point farm most of the time. Forrest Lee, the oldest, played an important role in raising the family. Winfield Scott's pension certificate describes him as 5'6" tall, fair complexion, with blue eyes. He contracted tuberculosis while in the army and was admitted to the Tennessee National Home for Disabled Veterans in Johnson City, in 1907. He died there the same year.




When Winfield Scott's oldest son, Forrest Lee, matured, he became a carpenter and moved to Carthage, Tennessee to practice his trade. He helped with construction of the Carthage Bridge and many structures still standing in Carthage today. After the construction of the Carthage Bridge, Forrest Lee traveled throughout Tennessee with his trade, sending money back home to Carthage to his wife, **Bettie Pemberton** Carr and their seven children. Forrest Lee worked up until he was seventy-one years old at which time he was killed in a mysterious auto accident in 1943 in Lebanon. Forrest Lee and Bettie Carr's oldest son, Thomas, born 1897, was the only one of their children to remain in Smith County. Thomas married Gertie May Stallings and moved to Kenney's Bend, near the Rock City community of Smith County, to farm. Because they did not receive any government aid during the Great Depression of the 1930's, they were eligible for an agricultural loan after the Depression which they used to purchase a farm on Plunkett's Creek, also near Rock City. They raised five sons and a daughter on this farm. Gertie Carr was a member of the Plunkett's Creek Missionary Baptist Church. She was a caring mother and grandmother and was loved by all who knew her.

There are many descendants of this couple residing in Smith County today.

GRIGG ASKS CONVENTION SEAT IN '65

Letcher Carr Grigg of 2918 McNairy Lane, today announced his candidacy as a delegate to the 1965 Constitutional Convention.

Grigg, 27, has served at various levels of state government almost 10 years as an employee of the State Democratic Executive Committee and the Secretary of State's office staff four years.

A graduate of Peabody College, Grigg is a member of the Fall Public School faculty and has taught at West End High School and the Wills Center School of Vanderbilt University.

In announcing his candidacy Grigg stated:

"If elected a delegate to this Convention, I will give honest consideration to the proposed amendments to the Constitution of the State of Tennessee. As a teacher

and past employee of several departments of State Government, I feel that my background would enable me to serve adequately as a delegate representing the people of Davidson County.

"I am of the firm opinion that the people of Davidson County deserve a more equalized basis for representation in the state legislature and that a state senators' term of office should be extended from two to four years and run concurrently with that of the Governor's term of office.

Frequency of session and compensation for elected representatives is a matter which will require careful evaluation in view of the fact that tax payer's money is directly involved."

Notes: Letcher Carr Grigg is the s/o Hugh Letcher Grigg & Dimple Carr. Dimple Carr was the sister of Joe C. Carr who served as Tennessee Secretary of State. They were children of Sidney Franklin Carr & Laura Burton. Sidney Franklin Carr, s/o James R. Carr & Caroline Allen. Hugh Letcher Grigg, b. 17 November 1890 – d. 9 April 1972 md Dimple Carr, b. 18 February 1900 – d. 1 May 1997. Hugh Letcher Grigg, s/o Hugh Grigg & Kate Graham. Letcher Carr Grigg, b. 12 November 1936 married Linda Gillem.
