<u>KILLS MAN AS RESULT OF MULE ARGUMENT</u>: Virgil Petty Shoots "Uncle" Matt McDonald to Death Friday Morning:

Virgil Petty, 25, is being held in jail here prior to a preliminary hearing on the admitted charge of shooting "Uncle" Matt McDonald to death with a .32 caliber pistol at 7 o'clock Friday morning on Petty's farm in the twelfth district of Putnam county after an alleged argument over the feeding of a mule.

Petty, who lived on McDonald's farm, was said to have carried a new pistol with him when he went to work in a tobacco field, and that he shot the old man from a distance of about thirty yards. He shot six times, three of the bullets taking effect. McDonald was killed instantly. Petty had been taking care of the dead man's stock and they had had some argument over a mule, it was reported, which arguments resulted in bitter enmity between the two.

Petty was brought to Cookeville by sheriff Warren shortly after the murder and will be given a preliminary trial before Squire J. H. Hodge next Wednesday. A number of the citizens from the prisoner's district came to Cookeville Friday to make his bond, which was denied until after the hearing.

McDonald was under bond for the shooting on April 12, this year of John White, a farmer of the twelfth district, who is still in a serious condition resulting from his pistol wounds.

Burial will take place today or tomorrow, pending the arrival of McDonald's children, three boys, Young, Howard, and Edgar, and two daughters, who are in Montana, and Dillard, who is in Michigan. He will be buried in the family cemetery at the home.

Petty surrendered to Sheriff Warren shortly after the shooting and was brought to Cookeville and admitted to jail. At the preliminary hearing before Squire J. H. Hodge on Wednesday afternoon. Petty was admitted to bail to await the action of the Grand Jury next September, and ten men of the 12<sup>th</sup> district signed his hand.

McDonald was under bond for the shooting on April 12, this year of John White, a farmer of the twelfth district, who is still in a serious condition resulting from his pistol wounds.

McDonald was buried in the family cemetery at his home.

### VIRGIL PETTY GOES ON TRIAL IN MURDER OF MATT MCDONALD: Crowds Fill Court:

Virgil Petty, 25, went on trial Wednesday afternoon in criminal court here for the killing on June 13, 1930, of "Uncle" Matt McDonald at McDonald's home in the 12<sup>th</sup> District of Putnam county.

The widow of McDonald, sitting behind a brilliant array of counsel, is the foremost prosecutor of the case with the state. Attorney-General Boyd is being assisted by Judge O. K. Holladay, John Holladay and Howard Vaden. A large part of Wednesday afternoon was consumed in the selection of a jury.

#### Has Able Counsel:

Behind an equally brilliant array of counsel sits Petty, youthful killer, who says that he killed the old man because he feared him following an argument over the feeding of a mule that Petty was keeping for McDonald. At the time he was killed, McDonald was under bond for the shooting of John White on April 12, 1930. White will be used as a witness in the case. Attorneys for the defense are Worth Bryant, Keith Bohannon, and Solon Fitzpatrick, of Carthage.

#### PETTY, HANCOCK MURDER HEARINGS, BUCKNER CASE FEATURES COURT DOCKET:

Two-Hundred Eleven Cases Scheduled For Three Weeks' Session Beginning Tuesday: Camp, Holladay To Preside.

Virgil Petty, avowed killer of "Uncle" Matt McDonald, aged 12<sup>th</sup> district farmer, and Willie Hancock, youthful slayer of Ridley Carr, and John Buckner, held on charges of incest and rape, will occupy the spotlight of Putnam county's sensational criminal court session which will begin Tuesday for a three weeks' duration.

Petty faces his second trail on the murder charge, his first hearing last October resulting in a mistrial. Petty killed McDonald in April, 1930, following an alleged argument over the feeding of a mule. According to testimony offered at the first trial, Petty used a 32:20 caliber pistol. Petty contended that his act was in self defense.

# JURY PICKED FOR MURDER CASE IN HANCOCK HEARING:

**Bulletin**: Virgil Petty was acquitted by a jury which reported at 8:45 this morning. He was charged with the murder in June, 1930, of M. T. "Uncle Matt" McDonald, aged 12<sup>th</sup> district farmer.

The Virgil Petty murder case went to the jury early Wednesday afternoon after brilliant arguments on both sides had been made. The jury reported just before court adjourned at 4:30 that it would take further deliberation to reach an agreement.

All the details which led to the killing of "Uncle Matt" McDonald were re-hashed during the three-day trail, Petty contending that his act was in self defense. The state contending that the murder was cold-blooded.

Jury in the Petty case was made up of J. M. Lovelady, Luke Smith, Dudley Walker, George Hudson, Alex Hunter, J. O. Lowe, Hamp Brown, Stant Dillon, J. L. Colvert, Quinn Robinson, Bob Johnson, and Herbert West.
