Although there was some migration from the northeastern counties of North Carolina, old Granville County received its heaviest flow of early settlers directly from Virginia. From a historical standpoint, it is important to know its exact geographical boundaries within the period covered by the present abstracts, beginning with the creation of the parent county of Edgecombe in 1732, and terminating with the formation of the now extinct Bute County in 1764.

Edgecombe Precinct began its official operations with August Court 1732, under such extraordinary complications that we cannot explore them here, and embodied a huge and imprecise area lying west of Bertie Precinct and the Roanoke River between the Virginia line on the northwest, Beaufort Precinct on the southeast, and Craven Precinct whose eastern line extended nebulously to the Virginia border on a rough parallel with the aforesaid River. The population was obviously quite small and extended only a few miles from the Roanoke and Tar Rivers.

The situation remained unchanged until the North Carolina General Assembly convened at Edenton on April 4, 1741, passed an "Act to Confirm" Edgecombe County and Parish, and defined more clearly its boundaries with Northhampton, Bertie, Tyrrell, Beaufort, and Craven Counties: "Beginning on Roanoke River, at Jenkin Henry's Upper Corner Tree, from thence a straight Course to the Mouth of Cheek's Mill Creek, on Tar River; and from the Southside of the said River, opposite to the said Creek, a straight line into the Middle grounds, between Tar and Neuse rivers; … and from thence up as nigh as may be, keeping the Middle between the said two Rivers, which shall be the dividing Line between the Counties of Craven and Edcomb."

Granville County and St. John's Parish came into being at a General Assembly begun at New Bern on June 28, 1746. It was divided from the upper part of Edgecombe County and Parish "by a Line beginning at the Mouth of Stonehouse Creek, on Roanoke River, to the Mouth of Cypress Swamp, on Tar River, and from Thence across the River, in a direct Course, to the Middle Grounds between Tar River and Neuse River, being the dividing Line between Craven and Edgecomb Counties.

The first Granville County Court was convened in 1746 "at the Dwelling-house of William Easton" until the Justices could select a suitable location and erect the required public buildings. Shortly before the General Assembly convened at New Bern on October 15, 1748, they had selected "a Place where-on to build a Court-house, Prison and Stocks; which said Place, upon examination, is found to be within Six or Seven Miles of the Northwest Corner of the said County, to the great incommodity and Detriment of the Inhabitants of the said County attending the said Court."

After this criticism a new Commission consisting of William Eaton, Edward John, and Jonathan White were appointed and authorized to sell to the best advantage "the Courthouse, Prison, and Stocks already begun to be built" and to apply "the Monies arising by such Sale...for and towards the building of the Court-house, Prison and Stocks...for the said County of Granville" that were to be "erected on or near a Branch of Tar River, commonly called or know by the Name of Tabb's Creek." This location was on the north side of the River, a short distance west of the present corner of Vance and Franklin Counties.

The same General Assembly of 1746 that created Granville County also created Johnston County and St. Patrick's parish from all that part of old Craven County lying northwest of the present Jones, Craven, and Pitt County lines.

The new seat for Granville County was to be "at the Place in the said County known by the Name of Oxford." Under other terms of the Act of 1764, Solomon Alston, William Johnston, and Julius Nichols were the Commissioners appointed to erect "a Court-house, Prison, Pillory, and Stocks, for the use of the said County of Bute" while Samuel Benton, Robert Harris, and Philip Taylor were named to perform a similar service for Granville County. The present volume of deed abstracts ends about the time this transition was accomplished. Hugh Buckner Johnston, Wilson, North Carolina, November 20, 1973.

Several criteria were used in selecting the deeds to be included in this book. The most important was to include all deeds proving or indicating relationships. Another was to select all deeds in which either the grantor or grantee, or both, lived in another county. This could indicated the counties from which people emigrated or to which they removed, many to other states. Also included are deeds in which both the grantor and grantee had the same surname. While this does not necessarily mean that they were related, it is a likely place to begin searching.

In many cases people sold land to their relatives in order to keep a tract from being divided. And there were many deeds of gift in which a normal price was stated. Since it was necessary to have a consideration named for the land or personal property, a high price would certainly make the gift seem more attractive.

Granville County has been found to be quite different from some other eastern North Carolina counties, namely, Edgecombe, Nash, and Halifax, in one respect. There were a very large number of merchants in Granville County from its beginning and they bought and resold quite a bit of the lands. They were noted, to a great extent, buying land at Sheriffs' sales and buying from persons who removed to other states. This also applied to the buying of slaves for resale. In the other counties mentioned, the merchants had very little to do with the buying and selling of land and personal property.

Another difference between Granville and the above named counties is that the boundaries of Granville County at that time were mostly artificial and many tracts of land lay in two counties and quite often in two states. Many person who inherited part of a home tract found that their part, when divided, lay in another county. So there were a great many of these "border line" sales and others by people living in a county which was actually only a few yards away.

All of the deeds in this book were abstracted by the late Zae Hargett Gwynn and the Tax List for 1769 was also copied and typed by her. This material would have filled at least three books of noraml size. Therefore, it was though best to select the deeds for inclusion in this book which seemed to give the most positive information for all genealogists. Joseph W. Watson – 198 March 1974.

Introduction:

Publishing a book containing abstracts of Court Minutes of a county is an extirely new experience for me, having previously dealt with wills, deeds, marriages, estate records, guardian records, and petitions. County Court Minutes are one of the least used sources of information that we have, primarily because there is no index and every word has to be carefully read or something inportant could easily be missed. They quite often contain information not found elsewhere, but the task of reading them is too great for the average researcher.

One of the things that makes this book different from most research volumes is that it contains about half again as many names. Frequently names have been observed in these records that have not been noted in the wills or deeds of this county. Great numbers of children had guardians appointed when their parent of parents died intestate, leaving no will naming them. Other children were bound out to learn the art and mysteries of planting, saddlery, bricklaying, cooking, weaving, and other crafts. Many illegitimate children were bound out, giving their ages and one or more parents.

There is much local history contained herein. An additional attraction is proof of service of many soldiers both in the Revolutionary War and the War of 1812.

The title of this book is inclusive but not entirely factual. A few Court Minutes do exist for the year 1746 and then, for all practical purposes, they skip to 1786. There are many Court Minutes for the period 1754-1770, but these consist mostly of court cases. The author has abstracted these quite thoroughly through 1762 and briefly thereafter. *Pg. 14*

Notes: This book continues the work begun in North Carolina Taxpayers 1701-1786. It includes most of the remaining tax lists, from the earliest known to 1790, except for a few (most of which are redundant) which were recorded shortly before or after the tax lists in this and the first volume.

Most of the names included in this book were found in the microfilmed tax lists at the **North Carolina State Archives** in Raleigh (Roll S.50.10), or in photocopies of some records not on microfilm at NCSA, or in tax lists published in The North Carolinian, later titled the **Journal of North Carolina Genealogy**, and still later titled North Carolina Genealogy.

Names of taxpayers are given in alphabetical order for quick reference. The name of the county of residence of each taxpayer is provided as well as the date of the tax list. This volume includes the names of about 29,000 taxpayers.

Note: This work lists the names of the taxpayers resident in about half of the North Carolina counties formed before 1786. A second volume, it is hoped, will deal with the remaining counties. The object of this present volume is to set down in writing, while research is fresh, a list of those persons paying poll taxes or property taxes sometime between the years 1701 and 1786. For genealogical purposes, of course, the intent is to identify individuals in relation to a specific time and place, and to make public a class of records likely to assist in the advancement of research.

The majority of the names given here were copied from tax lists microfilmed at the North Caroline State Archives in Raleigh (roll numbers, 155.108 and 115.49). Supplementing this basic list, and integrated throughout the text, are names which have been extracted from The North Carolinian, afterwards called the Journal of North Carolina Genealogy and then simply North Carolina Genealogy, from which journal have also been taken names of person owning headrights and landrights.

For ease reference the names of taxpayers are given in a single alphabetical sequence. In all cases taxpayers are listed by county of residence and date, and in some cases additional data is supplied. The combined lists, with repeat entries for those people who appear in more than one tax list, contain approximately 28,000 names.




