October Sessions 1792: Page 5

At the Court of Pleas and Quarter Sessions opened and held for the County of Jefferson at the house of Jeremiah Matthews on the fourth Monday in October 1792. Present Geo. Doherty, Adam Meek & James Roddye Esq. The following inquest appeared in Court were qualified and received their charge to wit:

John Renne paid into office five shillings collected of William Miller for profane swearing, and also five shillings collected of Phillip Laymon for the same offence. Ephraim Dunlap Esq. Produced a commission to practice the law, was qualified and admitted accordingly. Spencer Clack paid into office five shillings collected of Benj. W. Wallace & Wesley White for profane swearing.

A Bill of sale from Gideon Smith to Nenian Chamberlain for a negro man slave Israel was proven & Court and recorded. Nenian Chamberlain hath leave to record his mark of cattle, Hoggs, & sheep which is a crop on the left ear and slit in the right.

A Deed from Charles Gentry to Adam Willson for 400 acres of land was proven in Court and recorded.

A Deed from Joseph Garrison to Duke Kimbrough was proven in Court and recorded. A Deed from James McCuistian to Jesse Gentry was proven in Court and recorded.

Page 13 – May Sessions 1793

The following grand inquest appeared in Court was qualified and received their charge Vix: Abednego Inman foreman, James Hill, **Robert Gentry**, George Edgar, George Evans, Joseph Prignore, Caleb Witt, David Murphy, Joseph Witt, Hugh Kelso, Abraham Slover, Richard Rankin, Samuel Lyle, John McRoberts, Ezekiah Henry, Samuel McCalanhan, Adam Willson, David McClanahan and Thomas Vance.

Page 32 – November Sessions 1793

A Deed from Jesse Gentry to Robert Gentry was acknowledged in Court and recorded. A Deed from Jesse Gentry to Abraham Hughes was acknowledge in Court and recorded. Benj. Longacre surrendered the body of Thos. West to Court in discharge of himself as bail at the suit of William Donelson.

A Deed from Jesse Gentry to George Graham was acknowledged in Court and recorded.

Page 68 -

Robert Gentry hath leave to record his mark which is a crop and two half pennys in the right ear and a swallow fork in the left.

Page 69 –

A Deed from **Henry Haggard** to James Scott was acknowledged in Court and recorded.

Page 97 –

A Deed from **Robert Gentry** to Alexander Kelso was acknowledge in Court and recorded.

A Deed from George Douglass to **Robert Gentry**, **Bartlett Gentry** Ex and Sarah Randolph Executrix was acknowledge in Court and recorded.

Den on Demise of A. Meek – Pltf. Vs The Heirs of Joseph Bullard dec'd – Deft.

A Jury towit: James W. Lackey, Samuel Weir, Thomas Kincaid, James Walker, John Henderson, William Morrow, **Bartlett Gentry**, Peter Fine, John Counts, Goe, Wilcockson, John Balch and Joseph Robinson elected tried and sworn do say the Defendants are not guilty of the trespass laid in the Plaintiffs Declaration of Ejectment. It was therefore considered by the Court that the Plaintiff take nothing by his plaint but that he be in mercy and c. Whereupon the Plaintiff prayed and appeal which was granted entered into Bond and Security and filed reasons for his appeal.
