Jeremiah Whitson, His Wife, With Mrs. Mary Whitson Barnett, And Her Two Boys Are Victims: Three Others Narrowly Escape

WERE ON AFTERNOON PICNIC OUTING

Two of Dead Children Of Judge and Mrs. H. D. Whitson Of Cookeville: Mrs. Barnett Wife Of Nashville Mail Carrier, And Former School Teacher Here

PARENTS, FAMILY AND FRIENDS GRIEF STRICKEN

Tragedy stalked the placid waters of Falling Water River Wednesday at dusk when five persons, a man with his wife, and a mother with her two children, were drowned at Burgess Falls as a motor boat sank in water 18 feet deep. Three other occupants were saved.

Jeremiah Whitson, 35, and his wife, Alice Smith Whitson, 33, residents of Cookeville, and Mrs. Mary Whitson Barnett, of Nashville, and her sons, Robert, 2, and James, 5, are dead. Annie Pearl and Lucy Whitson and Beecher Cass, the other occupants, narrowly escaped.

The party had entered the boat at the hydro-electric power dam, and had motored up the river for perhaps a half mile. They were on an afternoon picnic outing. Most of them were standing on the front end of the boat, Mr. Cass said, and when it started sinking it went down quickly, almost before warning could be given. The boat was about 24 feet long and was of the cabin type, with a top, doors being located at front and rear, the sides being screened. Mr. Cass was forced to swim from the rear of the boat, where he was piloting, to the front end, a box and barrel having blocked the rear entrance. He was pulled from the river later by Lucy Whitson.

FISHERMAN HELPS

J. Cole, resident of Burgess Falls, was fishing near the scene of the tragedy when he heard screams for help, and when he got to the scene saw Annie Pearl Whitson struggling near where the boat sank. He called instructions to her, and went after her in his boat. She swam for the first time in her life.

News of the tragedy sent thousands hurrying to the scene. Cookeville boys, and residents of Burgess Falls worked together in recovering the bodies. The boat was lifted at about 11 o'clock Wednesday night, about four hours after it sank. Three bodies, those of Mrs. Whitson and the two Barnett children, were recovered with the boat. Dr. John Q. Owsley made an attempt at resuscitation, but was unsuccessful.

CURIOUS GATHER

Crowds of morbidly curious milled around the spot where the bodies lay as they were taken from the river, making orderly recovery work almost impossible. The scene was ghastly in the light of a full moon almost directly overhead.

Bodies of Jeremiah Whitson and Mrs. Barnett were not recovered until after midnight.

CITY EMPLOYEE

Jeremiah Whitson and Mrs. Barnett were children of Judge and Mrs. H. D. Whitson of Cookeville. Mr. Whitson was for many years county Judge of Putnam County and later served as road supervisor.

Mrs. Barnett was a former teacher in the Cookeville City school. She was the wife of J. P. Barnett, Nashville mail carrier.

JOINT FUNERAL SERVICES HELD FOR FIVE DROWING VICTIMS AT HOME FRIDAY

Thousands Gather At Whitson Home to Hear Last Rites For Figures In Burgess Falls Tragedy; Steel, Edwards, and Jarvis Conduct Service

Joint funeral services for Mr. and Mrs. Jeremiah Whitson, Mrs. J. P. Barnett and her two sons, Robert, 2, and James, 5, were held at the residence of Judge and Mrs. H. D. Whitson on Sparta road Friday afternoon. Burial took place in the City Cemetery.

A crowd of approximately 4,000 people gathered at the home to pay their respects to the quintet who were drowned when the boat in which they were riding at Burgess Falls sank on Wednesday night.

Services were conducted by the Rev. E. M. Steel, pastor of the Methodist Church of Cookeville, assisted by the Rev. Sam Edwards, of the First Baptist Church, of Nashville.

A motorcade, extending for more than a mile followed the three funeral coaches which carried the bodies to their graves.

Cookeville merchants, in response to a proclamation issued by Mayor Ezra Davis Friday morning, closed their places of business for two hours Friday afternoon.

DROWNED AT BURGESS FALLS

Four of the five members of the Whitson family who were drowned at Burgess Falls last Wednesday when the motorboat in which they were riding sank in 18 feet of water.

Pg. 330 - In 1875 about 40 years after Putnam County was added to the State of Tennessee, in 1854, and



recovering from the Civil War turmoil, people wanted to be taught all matters of life and its progress.

Education was the main topic that people preferred. Schools were built in various places in Putnam County and elsewhere. In the Cookeville area and surrounding communities, three young men became the teachers. The teachers were, Ernest Boyd (who later became an attorney), Monroe Hatfield (who later became a college professor), and Harve Whitson (who later became Judge of Putnam

County Court for two terms, a period of sixteen years).

Harve Whitson was presiding Judge in 1913; this was in the same year that the photo of his family was taken. The names of the Whitson family in the photo seated, wife Etta Farley Whitson, daughter Lucy Whitson, daughter Annie Pearl, father Harve Whitson, daughter Alice Whitson. In the back row, son Jeremiah Whitson, daughter Mary Lee Whitson, and son Howard Whitson.

During a summer season, Mary Lee and her two children were visiting the family in Cookeville. Jeremiah Whitson, his wife, and sister Annie Pearl took Mary Lee and her two children to Burgess Falls Lake for an evening of enjoyment riding in a boat on the lake. Jeremiah was an employee of the Cookeville Electric Department and was well trained about its condition and operation. The boat had a top cover with wire mesh over it and around it to protect anyone from falling overboard. When they were cruising along the lake, something happened to the boat that caused it to take on water. The boat was far from the shore, and it was in deep water.

Annie Pearl was the only one to free herself from the boat and she swam to the shore. The other five family members were unable to get out of the boat before it sank, and they all sank with the boat.

It was a great shock for the family, their relatives, neighbors, friends, and the Cookeville community. In those days there was not a funeral home that could handle that many bodies at one time. They took the five caskets to the lawn on the south side of the Cookeville Courthouse, for public viewing and funeral services.

My father, John Hollis Riddle, was an employee of Harve Whitson's farm, and I was a high school student at the time. We attended the funeral service, that took place seventy-five years ago.

The remaining Harve Whitson children went onto the following pursuits in their lives. Lucy and Annie Pearl became teachers, Alice worked in various offices when needed. Howard worked for the City of Cookeville.

Harve Whitson went onto be a farmer and livestock dealer after his two terms as being a judge.

The Whitson families lived one or two blocks apart from each other. They all lived very close to the Cookeville courthouse. The Whitson family was many in numbers, located throughout Putnam County. They were the foundation, growth, leaders, and developers in many areas of Putnam County's History. *Story by: Hurshal Riddle.*

BOAT IN WHICH FIVE MET DEATH IS HELD UNSAFE BY EXPERTS

J. P. Barrett Sues City For \$150,000 In Death Of Wife, Two Children:

HARD LEGAL FIGHT SEEN:

A motor boat in which five members of one family were drowned at Burgess Falls July 29, 1931, yesterday was declared unworthy and not built according to government specification by three government boat experts ir the \$150,000 damage suit against the city of Cookeville brought by J. P. Barnett, of Nashville, whose wife, Mary Lee Whitson Barnett, and two children, Robert and James, were victims.

The experts, J. D. McKenzie, C. I. Lamb, and A. G. Hill, testified that the boat was not properly equipped or constructed for use on a river and that it was unworthy for the purposes for which it was intended.

The suit, one of the larges damage cases ever tried here, was begun Tuesday, and it was indicated late yesterday that it would not go to the jury before Saturday. It promises to be one of the hardest fought legal battles in Tennessee.

Barnett is represented by Col. Worth Bryant, Judge F. E. Harris, former Governor A. H. Roberts, and Wade, of Nashville, while Holladay and Clark, of Cookeville, and Bradley McGinnis, of Carthage, represent the defendant city.

Went Straight Down:

Jeremiah Whitson and his wife were also drowned when the tragedy occurred. The boat sank in eighteen feet of water shortly after eight o'clock Wednesday night, July 29, 1931. Beecher Cass, driver of the boat testified Wednesday. Other survivors of the tragedy said that the boat was being driven up the river, and that water suddenly began pouring over the bow. Lucy Whitson, last witness Wednesday, said her brother, Jeremiah, called to the driver to turn the boat toward the shore. "Could you feel the boat turning?" she was asked. "No," she answered, "it just went straight down."

Miss Whitson saved Cass' life and her sister swam to the shore.

The city in its answer to the plaintiff's charges said it was "not guilty" in all three cases.

CITY WINS DAMAGE SUITS IN BURGESS FALLS DROWNINGS

Judge Gives Directed Verdict in Favor of Defendant Saturday Afternoon:

NO NEGLIGENCE SHOWN:

A directed verdict of "not guilty" was ordered by Judge R. W. Smartt of McMinnville, in Circuit Court here Saturday in the three damage cases of \$50,000 each against the City of Cookeville brought by J. P. Barnett of Nashville in the drowning of his wife, Mary Lee Whitson Barnett, and his two children, James and Robert in the power lake at Burgess Falls in July, 1931.

Judge Smartt ordered the directed verdict on the grounds that there was no evidence on which to predicate a verdict, and that the proof had not shown the City guilty of actionable negligence.

FILE APPEAL:

Attorneys for the plaintiff immediately filed an appeal to the State Court of Appeals.

The three suits were tried jointly and were one of the largest damage proceedings ever brought here. Barnett sought to recover damages on the grounds that the boat in which his family, with two others, sank to the bottom in eighteen feet of water after a picnic outing was unsafe and unseaworthy. The boat is owned by the City.

Witnesses for the City declared that the boat was intended for use only of employee in doing their work at the dam, and was constructed mainly to use in spreading oil on the lake to kill mosquitoes. In holding the City liable Judge Smartt said no negligence was shown by which damages could be granted.

Holladay and Clark, of Cookeville and Bradley McGinnis, of Carthage, defended the City, while attorneys for the plaintiff were former Governor A. H. Roberts, of Nashville, Col. Worth Bryant and Judge F. E. Harris, of Cookeville.
