
# **Recycling a Building**

BAXTER -- The Baxter Mayor and Board of Aldermen bought a building this week that will house and protect city vehicles and equipment as well as provide office space for city employees.



"It's the old Sewell Wholesale Grocery Building," said Baxter Mayor Jeff Wilhite. "It's located right off the parking lot of city hall and it's something we've been looking at for several years."

The old 16,000 square-foot two-story building has had two additions over the years and those are the areas where city board members envision city vehicles sitting protected and dry.

"We need space for all our vehicles including tractors and back hoes," the mayor said. "There's so much the town can use the land for. It's probably worth more to us than to anyone else," Wilhite said.

The old brick building was built in the 1920s -- just in time for the Great Depression. **W.G. Anderson** built the **W.G. Anderson Mercantile Store** which provided hardware and incidentals to customers until 1933 when the bank holding the note on Anderson Mercantile went broke and the depression wiped out the store.

"My grandfather, N.S. Maxwell and his friend William Tecumseh Sewell bought the building from an Ohio insurance company for \$3,500," Dan Maxwell said.


"They opened W.T. Sewell and Company, a wholesale grocery. In 1975 W.T. Sewell's son-in-law, James Austin, Sr. and his grandson Jim Ed Austin, Jr. along with N.S. Maxwell's grandson James Daniel Maxwell, bought the building and took over the company.

"It was all in the family," said Dan Maxwell.

In 1997 due to competition from companies like Wal-Mart and Kroger, the family-run business closed its doors and the old building became a temporary home to a number of smaller businesses.

"We sold our equipment and customer base to L. R. Shanks in Crossville. They offered jobs to all of our employees. That made it so much easier for us to close," Dan Maxwell said.

"We didn't have to put any people out of work," he said.



Then the building pretty much stayed empty.

"We tried to sell it, but there was no interest in this monstrosity in Baxter, Tenn.," Maxwell said. "We didn't even have a loading dock. We always did the things the hard way with fork lifts and strong backs."

The three owners of the building approached the city because city hall was so close.

"We didn't need the old building. And we thought we could do the city a service by making the old building both affordable and available," Maxwell said.

The owners agreed this week to sell the 90-year-old building to the City of Baxter for \$60,000 to be paid in ten annual installments of \$10,000 each. And there's no interest due.

"There's so much the city can do with the building. They could move the library to the new building. They could move their office spaces or give the senior center more room. The Baxter rural clinic is hard pressed for space and when the fire department moves some of its vehicles, that may open up space for the clinic."

Wilhite agreed.

"This is going to mean so much to the city," said the mayor. "We're growing now and this is going to help with that growth."

# William Grover Anderson Dies Herald – Citizen Newspaper, March 30, 1970

William Grover Anderson, 81, died Thursday at Master's Nursing Home on the Algood Road, following a long illness.

Funeral services were held Saturday afternoon at 2:00 at the chapel of Hooper – Huddleston Funeral Home with Rev. Andrew Albert officiating. Burial was in the Cookeville City Cemetery.

Mr. Anderson was a native of Putnam County, the son of the late Lewis and Matilda Wallace Anderson and was reared in the Silver Point – Baxter area.

His wife whose death occurred several years ago was the former Lillian Lee also from Putnam County. Mr. Anderson was once a merchant of Baxter, was a chairman of the Putnam County School Board and for a number of years served as a trustee of Baxter Seminary.

He served as representative at large in the Tennessee Legislature for some years, and was instrumental in getting various appropriations for Tennessee Tech during its initial year. He also held the position as secretary of the Putnam Chamber of Commerce.

Mr. Anderson was a Mason. The Excelsior Lodge of Baxter conducted a service in his memory Friday night at the funeral home.

Survivors are a son Joe Anderson, Washington D.C.; 4 sisters, Mrs. Addie Gill, Cookeville, Mrs. Audra Denny of Silver Point, Mrs. Floyd Shanks of Silver Point, and Mrs. Ollie Julian, Baxter, and a grandson, and 2 grandchildren.



## William Thomas Sewell Baxter Civic Leader Dies

**W. T. "Bill" Sewell** longtime business and civic leader in Putnam County, died Friday in Cookeville General Hospital after an extended illness. He was 78.

At the time of his death, he was **president of the W. T. Sewell Wholesale & Supple Co. of Baxter**, the town in which he lived with his wife, **Winnie Maxwell Sewell**, who survives, and where he had severed a number of terms as mayor. (*William Thomas pictured left*).

A Masonic service will be held tonight, Saturday, at the Hooper & Huddleston Funeral Home in Cookeville at 8 o'clock.

The funeral will be conducted from the chapel of the funeral home Sunday at 2 p.m. with burial in the Odd Fellows Cemetery.

A native of Tennessee, Mr. Sewell was the son the late Dr. William T. and Nancy Elizabeth Nixon Sewell.

During the long and active life in the affairs of the county, Mr. Sewell had held many positions. Besides the leadership of the firm he headed at the time of his death, he was vice chairman of the board of directors of the Citizens Bank, where he also served as president, and was a member of the board of directors of the Cookeville Federal Savings and Loan Association.

In public service positions, Mr. Sewell had also served long and well. In addition to his terms as mayor of Baxter, he had served on the board of Baxter Seminary and on the board of the Cookeville Housing Authority. At one time he was chairman of the Putnam County school board.

He was a past president of the Cookeville Rotary Club. He was a member of the United Methodist Church.

In addition to his wife, he is survived by two daughters, Mrs. Jim Austin of Baxter and Mrs. Robert Baldwin of Winchester, TN. He was the father of the late Tom Sewell.

Other survivors include a brother, James Nixon Sewell of Baxter, and seven sisters: Mrs. Falby Collier and Mrs. Mildred Hyder, both of Nashville; Mrs. Melinda Gordan, Mrs. Molly Vickers, Mrs. Alverta Chaffin, Mrs. Berta Randolph, Detroit, MI; and Mrs. Melissa Bradford, Ft. Worth, TX. There are seven grandchildren.
