Huldah L. Jernigan to Will:

I, Huldah L. Jernigan, being of sound mind and disposing memory, do make and publish this as my last will and testament, hereby revoking and making void all others by me at any time made.

First, I direct that my funeral expenses and all my just debts be paid as soon after my death as practicable out of my moneys that I may die possessed of or may first come into the hands of my executrix.

Second, I give and bequeath to my son Joseph Whitley Jernigan, and to my daughter, Angie Birdie Jernigan, all my property, both real and personal, that I may own at the time of my death, after paying the debts and expenses provided for above and the cost of winding up or administering on my estate, each to share equally in said property.

Third, I hereby nominate and appoint my said daughter, Angie Birdie Jernigan, sole executrix of this my last will and testament, and hereby will, direct and request that she be permitted to serve as such executrix without being required to give bond as such for the faithful discharge of her duties as such executrix.

In witness whereof I have hereunto set my hand, this the 14th day of September 1918.
