This could possibly be part of Matilda Selby's headstone as the birth year fits with Matilda's from census records. The birth year also matches John Johnson Selby from census records. Matilda is listed as head on 1880 census in Putnam County and I did not find John Johnson Selby on any 1880 census which leads me to believe he was deceased before 1880 census. There is a possibility he could have gone to Texas in preparation for the move and was just not enumerated - or he died in Putnam County - or this entry has nothing to do with Matilda's headstone.

Thomas S. Chambers is buried next to Matilda L. Selby, wife of John J. Selby.

Celina Peek is buried 4 graves away from Thomas. Celina (Bennett) Peek was the mother of Lucy Peek who married William Burton Selby (son of John Johnson Selby and Matilda Louis Harp).

Prissilla (sic) M (Moore). wife of John B, Norris is buried next to Celina Peek and 5 graves away from Thomas.

Rachel C. Moore is buried 14 graves away from her sister Priscilla Norris.

Widow's Application for Confederate Pension

THE STATE OF TEXAS, County of Rockwall

I, Mrs. M. E. Moore, do hereby make application to the Comptroller of Public Accounts for a pension, to be granted me under the Act passed by the Thirty-third Legislature of the State of Texas, and approved April 7, A.D. 1913, on the following grounds:

I am the widow of D. C. Moore, deceased, who departed this life on the 4 day of Dec, A.D. 1921, in the county of Rockwall, in the State of Texas.

I have not remarried since the death of my said husband, and I do solemnly swear that I was never divorced from my said husband, and that I never voluntarily abandoned him during his life, but remained his true, faithful and lawful wife up to the date of his death. I was married to him on the 14th day of October, A.D. 1869, in the county of Putnam, in the State of Tenn.

My husband, the said D. C. Moore, enlisted and served in the military service of the Confederate States during the war between the States of the United States, and that he did not desert the Confederate service. I have been a resident of the State of Texas since prior to January 1, A.D. 1910, and have been continuously since a citizen of the State of Texas. I do further state that I do not receive from any source whatever money or other means of support amounting in value above the sum of \$300.00 per annum, nor do I own in my own right, nor does anyone hold in trust for my benefit or use, estate or property, either real, personal or mixed, either in fee or for life, of the value of one thousand dollars, exclusive of the home of the value of not over \$2000; nor do I receive any aid or pension from any other State, or from the United States, or from any other source, and I do further state that the answers given to the following questions are true:
