## ARCHIBALD PAUL

Archibald Paul was born between 1720 and 1730 and died in Winnsboro, South Carolina, in 1802. He had four girls and three boys. One of the sons was Moses F. Paul, born between 1770 and 1780, who came to Roane County, Tennessee, by 1819 He moved to Rhea County about that time and acquired 230 acres on Piney River.

## ARCHIBALD DUNCAN PAUL SR.

One of Moses F. Paul's sons was Archibald Duncan Paul, born January 8, 1799, in Camden District, Fairfield County, South Carolina, who married on May 15, 1823 Cynthia Breeding, daughter of Byran and Jane Breeding. He married, second, Rebecca Edgemon Clark on October 29, 1854. Archibald was a Justice of Peace for the 1837-1840 and 1845-1846 terms. The children of Archibald D. and Cynthia were as follows:

MARGARET JANE PAUL, born March 30, 1824, married Nicholas H. Long (1818-1872) on November 5, 1843. Margaret died February 17, 1884.

CYRENA ANN PAUL, born October 7, 1825, married James P. Hines (see below).

NARCISSA KATHERINE PAUL, born January 26, 1833, married Cornelius Wissener on November 16, 1855.

NANCY ELIZABETH PAUL, born July 5, 1835, married William J. Owens on November 24, 1864.

VANN ALPHONSO PAUL, born October 6, 1837.

CYNTHIA ANGALINE PAUL, born June 11, 1939. SAPHRONA ADALINE PAUL, born February 24, 1841, married James D. Gilliam (1824-1907) about 1858. She died January 16, 1884.

SON, died January 31, 1844.

AMANDA FRANCINA PAUL, born June 6, 1845.

SON, died May 4, 1847.

ARCHIBALD DUNCAN PAUL JR., born November 19, 1855, died 11 April 1937.

SAMUEL EDGEMON PAUL, born December 22, 1857, died November 29, 1925 – md 1 December 1897, Minnie Heiskell – b. ca. 1868 – d. 7 January 1948.

By the time of Archibald D. Paul Sr.'s death on December 12, 1864, he had acquired much land where he and Rebecca lived on the old Breeding place on Muddy Creek, Toe String Valley, Archibald D. Sr., first wife Cynthia Breeding Paul, and second wife Rebecca, were buried in the Breeding Family Cemetery, along with other family members, but graves were removed by the TVA for Watts Bar Lake to Friendship Church Cemetery.

# JAMES P. and CYRENA A. (PAUL) HINDS

James P. Hinds and Cyrena A. Paul were married on December 24, 1854, by the Rev.

Pgs. 304 & 305: History of Rhea County, Tennessee

LONG by Joyce Ann Nelson Fitzgerald

Ever since I was big enough to peer over the edge of the counter, I used to watch my grandmother make bread. I watched her sprinkle flour over the board just right as she rolled the dough for a good pan of biscuits or a batch of cinnamon rolls. She made a good supper for us every night. She let me have the little bits of leftover dough to roll my own "baby" biscuits, and she baked them right along with the regular ones.

While she worked, she whistled or hummed a little tunes from a time long ago and told me stories from her life when she was young. She called her parents "Mother and Pappy." I thought that was funny. She told me about their log cabin home, and the children who lived there – about a brother-in-law, Charlie Smith, who brought her sister,

Nellie, and her children back home to Mother and Pappy to stay. She told me how Nellie later died of tuberculosis at the age of 26, leaving the babies for Mother and Pappy to raise along with their own.

One of those children, a little boy four years old, had "fits." One day he came in from play and got down behind a chair. He took his little fists and put them against his eyes (my grandmother showed me just how her did it). He must have felt one of his spells coming on. He died.

Then, when she was 18 years old, my grandmother, Angeline Long, came to work at the hosiery mill in Rockwood. She told me how my grandfather, Richard Joseph Bledsoe, rented a horse and buggy to drive to Lorraine on a Saturday in the summer of 1910 to tell Mother and Pappy their plan to be married.

Within a year, twin daughters were born to them, one was my mother, Mary Jane, the other was stillborn. When my mother grew up, she gave her stillborn baby sister the name Sarah Jean. My grandmother was 19 when she gave birth the first time. My grandfather was only 17 years old. Later, they had six more babies.

The night my grandmother's fourth child was born, her mother died.

Grandma Long had come to help out with the new baby. When the time came, my grandfather went to call the doctor. Upon their return, he and the doctor found Grandma Long sitting on the front porch in a chair. It was cold that night of January 5, 1918. She was ashen. It was her heart. They took her into the house and laid her down. The doctor gave her a shot. He said he had done all he could do.

The doctor came to my grandmother and quietly told her that if she wanted to see her mother alive, she must come now – it would be too late by the time the baby was born. Well into labor, she didn't go.

Grandma Long left this world the night my Uncle Paul was born. The Lord gave and the Lord took away.

Through her stories, I learned to love these people long departed. I wished I could have known them. I admired my grandmother, and I wanted to discover from which line of ancestors she received such good qualities. These stories gave me the interest to begin my genealogical search.

During the last three years, I learned that I am descended from Ware Long who was married in Culpeper, Virginia, in 1744. He had two daughters and eight sons. All eight boys served in the Revolutionary War. Some of them settled in East Tennessee. One was Nicholas, who died in Jefferson County in 1839. His son, Joel, married Betsy Byrd in Greene County in 1808 and settled in Rhea County. Joel was murdered on April 2, 1850, by Reuben Davis, his bound boy.

It was dusk when Reuben leaped from hiding near the fence row with an axe and repeatedly struck Joel about the head and shoulder. Leonard, Joel's youngest son, heard his father call his name, saying "Come quick!" as he received the first blows and tried to defend himself.

When Leonard ran to the end of the lane, he found his father "writhing" on the ground in the "publik" road that led from Washington to Kingston, and he saw a figure run away. Joel was still alive, but died shortly after they carried him into the house.

Joel had two sons and seven daughters. When these nine children married, they joined the names of Loden, Kenedy, Henry, **Paul**, Gilliam, Clifton, Owens, Majors, and Moore with that of Long. Many local descendants who bear these names are descended from old Ware Long in Virginia. It is said the Ware lived to be 112 years old.

It is from Joel's oldest son, **Nicholas H. Long,** that I am descended. Nicholas married **Margaret Jane Paul** in 1843. She was the daughter of **Archibald D. Paul**, local Justice of the Peace. This couple had four daughters and four sons. The oldest son was "Pappy," my great-grandfather, Zachary Taylor Long, born August 28, 1847. He married Mary Ann Ingle, the daughter of Jesse James Ingle and Mary Ann Fink. This Mary Ann Ingle was "Mother," who died the night of her grandbaby's birth in the story related above.

My name is Joyce Ann (Nelson) Fitzgerald. My mother was the surviving twin, Mary Jane Bledsoe, born August 29, 1911. She and my father, Robert Gladson, were married December 11, 1932.

About other lines:

**Archibald D. Paul** was born in 1799 in South Carolina, Jesse James Ingle, born 1824, was the son of William Ingle and his wife, Julia. They lived in Washington County, Tennessee.

Mary Ann Fink, born 1826, was the daughter of George Fink and Sarah Gibson who were married in Washington County in 1824.

Archibald D. Paul's wife is said to have been **Cynthia Breeding**, the daughter of Bryan Breeding out of Wythe County, Virginia.

## FOREWORD:

Wills and estate settlements are one of the most important sources for genealogists. Unfortunately, many individuals died intestate (no will) and/or left no estate to be settled. Obscure references to many of these people can be found in the various Court minutes. These entries are seldom indexed and can be found only through tedious reading of the minutes. Prior to 1825 in Rhea County, when the wills and settlements were entered into a special Will Book, this information was included in the minutes of the Court of Pleas and Quarter Sessions (County Court). The minutes of this Court are complete except for the first two years (1808-1809) and the period between 1815 and 1820.

The wills, inventories, estate settlements, and guardian reports found on the following pages were compiled mainly from three sources: the Will Books, the minutes of the

County Court, and the Guardian Records. Very few references to inventories and estate settlements are present in the minutes of the Circuit Court, although many cases contain lists of heirs of a deceased individual. Several of these cases were abstracted for inclusion where information was absent or incomplete from another source. The Barnes Collection from Rhea County, now housed at the University of Tennessee Library in Knoxville, contains many original documents pertaining to estate settlements, but most of them can be found in the Will Books.

# Pg. 4: **Breeding Cemetery**

The Breeding Cemetery was recorded by the W.P.A. in the 1930's and the T.V.A. in the 1940's. The W.P.A. described the location as follows: from Spring City, "go east 2 ½ miles to Rhea Springs, go east of Rhea Springs 1 mile to Toe Spring road, turn north on Toe String road and go 2 miles to the Perry Jolly farm. West of the road upon a little cedar covered hill, you will find the above graveyard." The burials listed below are from the W.P.A. record (graves 5,6,8,9,10,11,16,17,18,21,22,23,24,25, &42).

The T.V.A. placed the location on the left bank of Piney River at mile 4.3 and 600 feet north of the Rhea Springs – Iron Hill Road. The cemetery contained 69 graves, although only 17 had monuments. They executed agreements and moved the 60 graves to two reinterment cemeteries. The reinterment cemetery is indicated by (F) for Friendship or (M) for Marsh.

In 1940, the cemetery was situated on the property of W.E. and Fanny Wyatt in the 1<sup>st</sup> Civil District.

# **Marsh Family Cemetery**

The W.P.A. records indicate that this is a very old graveyard located one mile north of Wolf Creek Church in the woods. "Take the old stage road from Rhea Springs to Washington..." (from W.P.A. notes). Before Watts Bar Lake was formed, the Wolf Crrek-Rhea Springs Road merged with the old Stage Road three-fourths of a mile north

northeast of the Marsh Cemetery. The road is about 120 feet west of the cemetery. (see Map No. 6 in Appendix A).

Marsh Cemetery also was recorded by the T.V.A. in 1941 (as Marsh Cemetery No.2). The notes and map of the cemetery are missing form the files, although there was a list of the burials. Many reinterments from other cemeteries were placed in the Marsh Cemetery. The copy of the T.V.A. map would not reproduce; therefore, it was redrawn and the burials renumbered in sequence. Since the reinterments from a particular cemetery were not grouped together, they have been identified by B (Breeding), L (Leuty), and Lo (Lowe).

The T.V.A. reservoir map shows the cemetery to be on the east side of Wolf Creek inlet. The listing below combines both the W.P.A. and T.V.A. records from the reinterments and the old portion of the cemetery. Only the marked burials (headstones or fieldstones) among the reinterments are included below. For the full dates and additional information, refer to the reinterment cemetery.

# Pg. 186 & 189:

Spring City Cemetery is the largest one in the northern portion of Rhea County, TN. When it was visited by the W.P.A. in the 1930's, they noted that it was "well-kept and almost every grave has a tombstone." A total of 370 inscriptions were copied at that time. To reach the cemetery, turn west from U.S. 27 on Piccadilly Avenue, cross the railroad tracts, and turn left on Front Street. Follow Front Street southwest to McGoffin Avenue (the road curves here and the only way to turn is right). A short distance from this curve, Cemetery Road turns southwest. Spring City Cemetery is about two miles on the left (between Cemetery Road and the railroad tracks). The cemetery can also be reached from the south by turning west from U.S. 27 (a short distance north of Spring City Memory Gardens), crossing the railroad track, and turning north on Cemetery Road. The following minutes were abstracted/transcribed from a xerox copy of the original minute book. The book is also on microfilm

(State Archives Roll No. 47) and a typed copy was made by the W.P.A. during the 1930's (also on microfilm).

The 1823 to 1828 minute book is the oldest of the books presently located in the Rhea County Courthouse. Three of the earlier books are among the Barnes Collection at the University of Tennessee Library in Knoxville and will be transcribed as soon as a good xerox copy can be obtained.

The term "abstracted/transcribed" is being used because many of the entries have been copied in their entirety. Although there is some duplication, no entry has been skipped or omitted.

Prior to May 1825, wills, inventories, and estate settlements were recorded in the minute book. *Includes the names of the recorded wills*.

After May 1825, the wills, inventories, and settlements were presented to the Court for approval, but were recorded in a special Will Book. These books can be found in the County Court Clerks office in the Courthouse (also on micro-film from State Archives).

Two revolutionary War pension applications were included in this minute book: Thomas Moore (pg. 59) and Joseph Atchley (pg. 64); and two applications for the emancipation of slaves: Mary Walker (pp. 24, 36) and Rezin Rawlings (pg. 97).

The County Court was presided over by Justices of the Peace appointed by the State Legislature and Commissioned by the Governor. The Court heard cases pertaining to assault and battery, affrays, selling "spirituous liquors" without a license, disturbing public worship, gaming, bastardy, etc., many of which were tried by jury. Jurors also were appointed for the Circuit Court.

The Justices appointed various County officers (Court Clerks, Trustee, Registrar, Sheriff, etc.), administrators on estates, guardians for orphans and minor heirs, road overseers, juries of view to lay off new roads or change existing roads, committees to supervise the building of bridges and the County buildings, and authorized the establishment of ferries across the Tennessee River. Tax rates, rates of ferriage, etc. also were set by the Justices. Paupers and poor persons were cared for through appropriations made by the Justices, providing for their maintenance and burial.

The minutes of the Court of Pleas and Quarter Session (County Court) contain hundreds of names of residents in the County. The road orders not only appoint an overseer, but list the hands (men who lived along the short section of road) assigned to help the overseer.

The Court of Pleas and quarter Sessions met on the first Monday in the months of February, May, August, and November. Most sessions lasted the entire week, although the number of Justices present was reduced to three or four after the first day.

The page number at the beginning of paragraphs correspond to those in the minute book. The page numbers in the index beginning on page 153 refer to the page number in this publication.

The Hiwassee Baptist Association was organized in May 1823, at Pisgah Baptist Church in Monroe County, Tennessee. There were twelve charter members: Pisgah, Little Emory, Big Spring, Sweet Water, Hopewell, Luminary, Beach Fork of Emery, Bullock Penn., Shiloh, Eastern Alabama, Zion Hill, and Tennessee.

The first annual meeting was held at Big Emory Baptist Church in Roane County. One new church was added, Concord, making 13 churches from Roane, Monroe, Rhea, McMinn, Morgan and Bradley Counties.

1864: Minutes of the Forty-Second Annual Meeting of the Hiwassee Baptist Association held at Zion Meeting House, Rhea County, Tennessee – Printed by W.H. Wetherton, Lebanon, KY.

Minutes of the Forty-Second Annual Meeting of the Hiwassee Baptist Association, held at Zion Meeting House, Rhea County, TN, Friday before the 4<sup>th</sup> Saturday in September, 1864, and following days.
