According to the W.P.A. notes, the Thompson (misspelled Thomisson) Cemetery is located three miles north of Spring City on the Cash farm. "Here, on west side of Highway in sight of Cash home, you will find the above named graveyard. This is a very old graveyard long since abandoned. Twenty-five or more unknown graves."

The Thompson Cemetery is located north of St. Clair and west of the railroad. The property is presently owned by the Huber Company, and the cemetery has been fenced in for protection. (see Map No. 3 in Appendix A). On 16 May 1997, the cemetery was visited by Cecil B. Smith and Gary Drinkard, who noted that it was covered with briars, honey-suckles, and sumac trees. As soon as plant construction is completed, the cemetery can be cleared.

A list of the interments in the cemetery was supplied to Smith and Drinkard by Mrs. T. C. Cash. All reported headstones were located except the one of Priscilla, and one additional inscription (Thomas) was identified. Two other stones found by Smith and Drinkard were unreadable due to surface scaling. They also found one fieldstone and noted that more data probably will be available after the cemetery is cleaned.

Henry McCary married Jane Thompson, daughter of Thomas K. and Pricilla (Looney) Thompson, in Rhea County TN in 1834. They moved to Barry County Missouri in 1837 where Henry held several public offices including one term as Missouri State Representative.

Josiah McCary, minister, married Mary Hubbert in Rhea County TN and relocated to Barry Co. Missouri for a time, then moved to other sections of Missouri as a minister.

Lindsey McCary, a cabinet maker, married Mary A Peters in Rhea County TN and moved to Barry County Missouri.

Labon Stewart married Nancy A Wells in Rhea County TN in 1823, relocated to DeKalb Tennessee for the 1838 removal of the Cherokee and 1840 census, they settled in Barry County Missouri before 1845 and resettled in Williamson Co. Texas before 1870.

When eight years of age he went to East Tennessee, where he remained until 1837, at which time he removed to Barry County, Mo. He is of a family of four children. Those living are Josiah, who resides in Vernon, County, Nev., and Henry. The two who are dead are Sarah (who married William Johnson, and lived in Kentucky) and Lindsay. <u>Henry McCary was married in June, 1834, to Jane A.</u> Thompson, a daughter of Thomas and Priscilla Thompson, and to them have been born ten children, five boys and five girls. They are Benjamin Franklin, Jane, John Thompson, Frances Arabella (deceased) and Martha Cordelia. Mrs. McCary was born in April, 1816, in Rhea County, Tenn. Mr. McCary has served as constable and deputy sheriff of his county with a seat in the Legislature, and was what is known as a Benton Democrat. INTRODUCTION:

The white man steadily encroached on the Indian forcing him out of his homeland and so it was in the territory which became Rhea County, Tennessee. As early as 1787, some persons, who held North Carolina land warrants, were paddling down the Tennessee River in canoes and marking corners for locating grants in the area which became Rhea County, although the Indians held the land.

In theory as each new county was formed southwestward in East Tennessee, it reached to the southern border of the state, although the Indian line in 1799 was at the Clinch River at Kinston in present Roane County. White people, wishing to enter the Indian territory had to obtain a pass, by order of the United States Government.

In October 1805, negotiations were concluded in which much land was acquired from the Indians, including land which extended Roane County southward on the north side of the Tennessee River to a point opposite the mouth of the Hiwassee River.

December 3, 1807, Rhea County was created from Roane and was bounded much the same as present Rhea County except for some minor variations of county lines.

In 1815, Rhea County was extended southward to the southern boundary of the state and lost the same in 1819 to the formation of Hamilton County. In 1819 the Hiwassee Purchase added land to the county on the south side of the Tennessee River which was lost to the formation of Meigs County in 1836.

The 1830 Census included all the people living in the area of present Rhea County and those who had moved south of the river and were taken in by Meigs County.

In this publication, each digit of the numbers follow the names represents an age column of the census, which are: under 5, 5-10, 10-15, 15-20, 20-30, 30-40, 40-50, 50-60, etc. for both males and females.

Pg. 62) An academy of similar type, in some respects a sort of "offspring" of the older Washington school, was the Mars Hill Academy, was established at Evensville after the coming of the railroad.

Another institution similar to that at Washington was the **Mars Hill Academy**, chartered by act of the legislature in 1850. The first board of trustees was composed of Edward E. Wasson, James Robinson, Stephen Cawood, David G. Scroggins, Robert Cravens, Dr. James W. Gillespie, Dr. Addison Locke, Edward Pyott, **James I. Cash**, **Jesse P. Thompson**, and Alfred Marsh. This school, which was about four miles north of the present town of Spring City, was operated for a quarter of a century. The ensemble consisted of the academy building proper, a girls' and boys' dormitory, and a hotel. Board was \$2.00 a week. A roster shows 121 students in attendance for the year 1858-59; students came from several counties.

Academies operating on plans similar to those at Washington and Mars Hill were promoted by legislation in the various counties to a total number of several hundred in the state. Attempts were made to enact a uniform system of school laws to apply to the entire state, from time to time, but the existing formula or framework of a state system was not adopted until after the constitution of 1870 went into effect. Graded courses of study were a still later development. Secondary schools, to raise the limit of public instruction, were provided in 1891, but did not prove a success.

The family Bible of Moses Thompson, with his children, is on file in the McCubbins Collection, Salisbury, NC. Joseph's daughter, Rebekah, received money. The heir, Rachel Beard, died interstate in Rowan County in 1817.

pgs. 58 & 59: Modern Townships - Flat Creek Township was established in March, 1844, within the following described boundaries: From the fifth crossing of Flat Creek, near P. Trower's house, to William McKenney's house, including it, thence to the Taney County line near the head of Big Creek, thence south to White River Township line, thence southwest with that township line to J. J. Davis' Mill, on Roaring River, thence northwest to **Thompson's, on Washburn Prairie**, thence west to Hubbard's (Hubbert's), so as to leave **Thompson** and Hubbard in Sugar Creek Township, and west to the Newton County line, thence north to the Shoal Creek Township line, thence east to Ed. Talkington's house, thence direct to Trower's, at the ford of Flat Creek, leaving Phillip's house in Shoal Creek, and territory east of Trower's and north of the Flat Creek town line in McDonald Township. The court-house was the place of meeting, and J. O. Burton, William Kerr and Price McMurtry were judges of election.

pg. 77: War Incidents - **A. L. Thompson** was killed at his home near Washburn by a masked gang at night. At the time of this murder Thompson was holding his child in his arms.

pgs. 109 & 110: Agricultural Societies - The Barry County Agricultural and Mechanical Society was incorporated December 5, 1858, with the following named members: **A. L. Thompson**.....and many more names.

pg. 112: In February, 1840, a road from the mouth of Roaring River to the Arkansas line was ordered, with Absalom Thompson, Henry McCeary (*McCary*) and Moses Pendergast, commissioners.

pg. 113: Highways, Railroads and Navigation: Early Roads: In August 1841, Charles Haddock was appointed overseer of a road from John J. Davis' house to the first crossing of Roaring River, above Widow Burnett's and was empowered to compel all hands from Davis' field down the river, one mile below Michael Master's old farm, to labor on such road. pg. 175: Henry McCary, a farmer residing three and one-half miles southwest of Crossville, Mo., was born on November 4, 1800, in South Carolina. When eight years of age he went to East Tennessee, where he remained until 1837, at which time he removed to Barry County, Mo. He is of a family of four children. Those living are Josiah, who resides in Vernon, County, Nev., and Henry. The two who are dead are Sarah (who married William Johnson, and lived in Kentucky) and Lindsay. Henry McCary was married in June, 1834, to Jane A. Thompson, a daughter of Thomas and Priscilla Thompson, and to them have been born ten children, five boys and five girls. They are Benjamin Franklin, Jane, John Thompson, Frances Arabella (deceased) and Martha Cordelia. Mrs. McCary was born in April, 1816, in Rhea County, Tenn. Mr. McCary has served as constable and deputy sheriff of his county with a seat in the Legislature, and was what is known as a Benton Democrat. He cast his first Presidential vote for "Old Hickory" in 1832. His family residence is on a beautiful farm of

215 acres, under a high state of cultivation. At one time he owned a much larger tract of land, but he has given liberally to his five sons, **Benjamin**, **Thomas B., J. T.**, **Francis** and **Josiah**. **Mr. McCary** is a member in good standing of the Masonic fraternity.

THE CASH FAMILY

The Cash family has been a positive and wholesome influence in the affairs of Rhea County. When a Cash is confronted with a situation, his course is usually straight through. The roots of the family were planted in the state of Tennessee before it was a state. Members of the family came from Virginia to Jonesboro and thence to the present Rhea County, about 1790. They were of pre-Revolutionary stock.

After having served in the war for American independence, the first James I. Cash settled in Rhea County in 1790, long before the county was organized. He lived not far from where R. G. Waterhouse mentions having met Governor John Sevier while on a visit to Little Page Sims, whose home was on Muddy Creek.

James I. Cash, III, a son of the pioneer James I. Cash, was a farmer and Methodist preacher. He had four sons, William, James A., Thomas, and Francis Asbury, most, if not all, of whom served in the Confederate Army in the Civil War. James A. Cash was a captain in the 26th Tennessee regiment, commanded by Col. John M. Lillard of Meigs County. Capt. Cash's wife was a daughter of Stephen Spence, himself a scion of a pioneer family.

James I. Cash, IV, a son of William Cash, also a Methodist minister, until a few years ago, lived in retirement at Spring City. He was for many years editor of the Midland Methodist, organ of the M. E. Church, South, at Nashville, Tennessee. He has numerous descendants and relatives in Rhea and adjoining counties.

James A. Cash, a son of Capt. James A. Cash, served as a member of the city commission of Chattanooga for two terms. For many years he was identified with that city's commercial life. Like most other members of the family, he rarely hesitates to express his opinion on any issue of importance.

Commissioner Cash has two sons, James and Harold, each of whom is making for himself an enviable name among his fellows. The former, after obtaining the degrees of A. M. at the University of Virginia and M. D. at Johns Hopkins University and having occupied the

chair of pathology at Peking University in China, now occupies the chair of pathology in the University of Virginia. Harold is a sculptor of distinction and international reputation who has worked in France, Italy, and Belgium.

Frank Thompson, an early settler in Rhea County, married a daughter of James I. Cash, the pioneer, and the second wife of James I. Cash, III, was a sister of Frank Thompson. Jesse P. Thompson, a son of Frank Thompson, served in the company of R. G. Waterhouse, II, in the Mexican War. His sister married Frank Waterhouse, father of Bishop R. G. Waterhouse.

The **Cashes** are collaterally related to the **Boggans**, one of the outstanding colonial families of North Carolina, Anson County, especially. One of the Boggans married into the famous Davidson family of North Carolina, from whom Tennessee's great war governor and United States **Senator, Isham G. Harris**, was descended. **Boggan Cash married Nancy Jones in Rhea County in 1828.** He later moved to Meigs County.

Harold Cash, the young sculptor, has recently done a portrait of Edgar Allen Poe for the Raven Society of the University of Virginia, which is pronounced an outstanding work of art.

JOHN T. MCARY DEAD

This awful announcement went forth Sunday noon that another old and respected citizen of this section of Barry county, had passed away at a time in life, when he had promise of many years. But the reaper of time was in motion, his sickle was sharpened and the brittle thread of life was snapped and **John T. McCary** went to his reward.

John Thompson McCary was the youngest son of the late Hon. and Mrs. Henry McCary, old, highly respected and honored citizens of Barry county, who settled on the McCary homestead 4 miles southwest of this city, in 1837, coming from Tennessee that year to this county, and lived there until death summoned them to another world. John T. McCary was born in April 1852, and over 65 years, 6 months and a

few days old at his death. He had lived all his life on the McCary homestead, which he owned at the time of his death, consisting of about 220 acres of valuable land, well improved and a lot of good stock on the farm.

About Oct. 2, he was injured by his buggy turning over on him, in the Pasley neighborhood, that produced concussion of the brain from which he never recovered, but lived about two weeks. During that time, he was able to be up and around, but was never right after the accident and gradually grew worse, until Sunday, Oct 15 1916, at 11:30 a.m. when his spirit was summoned from this world.

The following are his living brothers and sisters: B. F. McCary Washburn, Josiah and T. B. McCary (*Thomas Benton McCary*) of near the old home, Asberry McCary of Powell, McDonald County and Mrs. Jennie McCary of Long Beach Cal.?

He was a member of Pythagoras Lodge A.F & A.M., of this city, and his remains were interred Monday evening with their honors in the McCary cemetery at the old home, with a large number of relatives and friends present to pay their last tribute of respect to his memory.

Having made peace with his God in early life and lived the life that is necessary to heavenly accomplishments, his spirit ascended to Hum who gave it and no doubt is now enjoying a happy reunion with those of his loved ones who had gone to the glory land before.

After a stroke of paralysis and infirmities attending old age, from which he lingered for sometime, **Benjamin F. McCary** passed from earth to a heavenly domicile, aged 83 years and 19 days, surrounded by loving relatives and friends, at his home 4 miles southwest of this city, Sunday morning, at 9 a.m., April 21.

He was born in Rhea county, Tenn., April 2, 1835 and was a son of the late Hon. and Mrs. Henry McCary who came to this county in 1837, and located the McCary farm 4 miles southwest of this city, where they lived honorable and upright lives. Benj. F., was two years old when his parents came to this county and has been a resident of the county for 81 years.

Oct. 5, 1856 he and Miss Tennessee A. Peevey were married; the bride was a daughter of the late Judge and Mrs. Isacc Peevey old and respected citizens of this county during life. To this marriage there was born 13 children, seven survive the parents and are: Osa McCary of Stark City, Newton county, the only living son, and Mesdames George Packwood of near Exeter, Mrs. E. W. Davis of near Wheaton, Mrs. Bert Davis of near Washburn, Mrs. Maud Anderson of San Juan, N.M., Ollie Burnett of Dewey, Okla., and Mrs. W.D. Pallet of near Cassville.

He left three brothers to mourn his passing: F.A. McCary of Powell McDonald county, Josiah McCary of near Exeter and Thos. B. McCary on R 1, Cassville and a sister Mrs. Mitchell of California.

2. Pioneer Citizen Dies

B. F. McCary, one of the pioneer citizens of Barry County died at his home on the Cassville and Washburn road, Sunday morning, April 21, at the age of 83 years, of a complication of troubles incident to old age.

Benjamin Franklin McCary was the oldest son of the late Hon. Henry McCary who was one of the county's oldest settlers and who served this county in a number of official positions and in the State Legislature. The McCary family consisting of Mr. and Mrs. Henry McCary and two small children, B. F., the subject of this sketch and Asbury the next brother, came to Barry county from East Tennessee in 1837. They settled the farm which was since been owned by the family and known as the McCary farm four miles southwest of the city on the Washburn valley. B. F. was born in Tennessee in 1835. Eighty-one of the eighty-three years of his life were spent in this county and within a few miles of this father's old homestead. For many years he had lived near Washburn but a short time ago he brought a farm adjoining the old original home farm to spend the last of his days.

When a young man Mr. McCary obtained a good common school education, as good as was afforded in that day, and taught school. He took an active part in public affairs and was a useful citizen. During his long life, nearly all of which was spent in this county he had seen the

county develop from a territory of sparse settlements into the county it is today. But he was not only an observer, he always took an active hand in the work necessary to its progress.

Mrs. McCary died several years ago. To them some ten children had been born, of whom seven are living. They are: Sally Davis, widow of the late Bert Davis; Libbie Davis, wife of Judge Wm. Davis; Maud Anderson, who lives in Mexico; Ollie Burnett of Dewey, Okla.; Ocie McCary of Stark City; Mrs. Nannie Pallet, who was living with her father and Mrs. Geo. Packwood of near Exeter.

The funeral was held Monday at the Roller cemetery, conducted by Rev. C. M. Smith. Following the funeral service the Masonic Lodge of which Mr. McCary had long been a member, gave his funeral ceremony.

A GOOD OLD TIME CITIZEN PASSES AWAY

Had Resided in Barry County for the Past Eighty-one Years- Was a Good Man

JOSIAH MCCARY

A worthy man has been called to his great reward in that 'holy city' where all is love and delight. Where those that had lived the good life on earth are welcomed. Where happiness, love and pure delight abound in endless quanties. Where he will bask in the sunlight of his Great Redeemer and all will be well. His splendid work on earth will follow him.

Josiah McCary was born Jan. 18, 1842 on the late Henry McCary homestead, 4 miles southwest of this city, and was a son of the late Hon. Henry McCary and Mrs. Jane McCary, old time and highly respected citizens of Barry County, who came to Barry county in 1830 (should read 1837), from east Tennessee. The deceased grew to manhood in this county and when the civil war came on in the sixties, he with his brothers, B.F., T.B and Asberry, all enlisted on the side of the Confederate states and joined Capt. Joe Peevey's Company, that was organized in the south end of Barry county and served throughout that war and returned home and went to work on the farm and in 1867, he and Miss Mary I. Barr were married, and four children were born to this marriage, two dying in infancy, and Mrs. Thos. Hodge and Cam McCary survive the father. He died Sept. 7th, 1923, aged 81 yrs. 7 months and 19 days, of infirmities of old age. During the civil war, a woman in the Southland, gave him a testament to read, which he studied during his leisure hours and obeyed its teachings in Confederate Camp and united with the Christian church at Three Camps, Ark., and was baptized by Elder J.H. Mulvy. In his younger days he was very active in church work and remained steadfast to his religious beliefs that were implanted in his mind in those trying days of warfare.

Mrs. Jennie Mithell of California, is the only surviving sister and all brothers are dead.

Josiah McCary enjoyed the high esteem of everybody that had the privilege of being acquainted with him. His integrity was never questioned and he was an unassuming man, and always stood for what he believed was right. After a scriptural reading and a prayer by Rev. Chas. Vanzadt at the late home,

Rev. C.F. Rose of Springfield, of the Christian church, preached an impressive sermon to his many relatives, old friends and many neighbors who had assembled to pay the last tribute of love and respect to this good man.

The remains were interned in the McCary cemetery, on the old homestead.

Mrs. Joseph McCary Dead: **Mrs. Mary Louise McCary, wife of Joseph McCary** of near the McMurty Spring, southwest of Cassville, died at the family home Sunday morning, Oct 29 of typhoid fever, age 66 years, 6 months and 12 days.

Mrs. McCary's health had been failing for several months and her poor physical condition made it impossible for her to withstand an attack of typhoid.

Mrs. McCary was born in Tennessee, April 17, 1845. When a small girl her parents moved to this county. She was married to Joseph McCary in 1867. To them were born four children, two dying in infancy. Those living are Mrs. Nora Hodge, wife of Prof. Thomas Hodge and Cam McCary. Cam lives near his father and Mr. and Mrs. Hodge live west of Cassville 2 1/2 miles.

Mrs. McCary was a sister of Scott, Newton and Columbus Bare all well known in this county. She leaves four sisters living, Mrs. Tennie Brisco, wife of Bart Brisco of Exeter, Mrs. John Weatherly of Joplin, Mrs. Jane Ford, wife of Thos. Ford of Exeter, and Mrs. Vesta Johnson of California.

Mrs. McCary was for years a member of the Presbyterian Church but later she united with the Christian Church in which she remained a faithful member until death. She was a devoted wife and mother and and a most excellent citizen. The funeral service was held at the home Monday and her body laid to **rest in the McCary family cemetery at the old Henry McCary home place** on Cassville and Washburn road 4 1/2 miles Northwest of Cassville.

MISS NANNIE MCCARY DEAD

Another splendid citizen has passed to the great beyond, leaving five brothers, one sister, and many other relatives and friends to mourn her passing. She was a daughter of the late Hon. and Mrs. Henry McCary, well known and highly respected citizens of this county during life. She was born May 26, 1844 at the McCary homestead.

Miss Nannie McCary died Jan. 24, 1916 of mephritis. Her family was well known to all the older families of this county and she enjoyed the esteem and respect of everybody who had the pleasure of her acquaintance. She leaves five brothers and one sister to morn her passing, as follows: B.F. McCary of near Washburn Joe McCary of near Exeter, Asberry McCary of near Fairview Thos. B. and John McCary and Mrs. Jennie Mitchell of near this city.

Funeral services were conducted Thursday at the McCary home, by Rev. E W Love of this city after which the **remains were intered in the family cemetery on the McCary homestead.** A vacancy has been made in a home where the decedant will be missed because of her many womanly graces, splendid disposition and high character that proved her great worth as a happy home maker and she will be sadly missed by her relatives.

Miss Tennie Mary McCary daughter of the late Hon. Henry and Mrs. Jane A. McCary, died at the old McCary home, 4 miles Southwest of this city. Tuesday morning, Sept 2, 1913, of paralysis and was 66 years old.

Miss Tennie was born on the farm where she lived and died, in February, 1847, and was among our oldest citizens. She was highly respected by all of her acquaintances. She was of a retired disposition and remained at home, looking after her domestic affairs, where she and her sister Miss Nannie, Thos. B. and John McCary all made their home, hardly ever leaving home and it was her pleasure to do so. She was a good citizen and was a believer in the religion of Jesus Christ.

Rev. J.W. Ennis of near this city, conducted funeral services at her late home Wednesday afternoon, where a large number of old time residents and friends had assembled to pay the last respect to a good woman, after which the **remains were laid to rest in the McCary family Cemetery.**

All her brothers and sisters were present at her funeral, excepting Mrs. Jane Mitchell of Long beach, Cal. Asbury McCary was in Oklahoma, and Eschot McKinney took a copy of last weeks Democrat to him, showing him of the serious sickness of his sister and he immediately left for the old home, where he arrived in time for the funeral.

James Truelove Thompson died Sunday morning, Feb. 11, 1906, at the home of **his father Wm. R. Thompson** of Washburn Prairie, of lung trouble, aged 22 years and 2 days. Trudy, as he was familiarly called, had been in declining health for several months, and had gone to New Mexico to see if that climate would not five him relief. But in vain, health gone, his condition greatly weakened, his father was notified of his changed condition and went after him and returned home just a few days before he passed away. His greatest desire was to get home, as he knew death was near, so that he might die at home. Rev. Pyke of the M.E. Church, South, conducted **funeral services at the Truelove Cemetery** Sunday afternoon, before a large crowd of sorrowing relatives and friends who had known Trudy from childhood. It is especially had to give up an only son, yet a pleasure to know that they can mingle together in a better world.

William Thompson, a prominent farm and highly respected citizen so near Washburn, died at his home Saturday morning, Dec 18 at 6 o'clock of hart trouble and a complication of troubles.

Mr. Thompson had been in ill health for several months and very low for several weeks, word was received here two or three times during the past month that he had passed away.

William Thompson was born in Johnson County, Missouri in 1850. When about seven years old his parents moved to this county where he had ever continued to live. He was married to Miss J. Truelove and to them two children were born, Trudie, deceased and Mrs. Fannie Reed, who lives on the old home place.

Mr. Thompson was twice married, his second wife being Mrs. Mary Kirk Stringer. No children were born to them. He leaves three brothers, Frank Thompson of this city, Henry and Joe Thompson of Newton County.

William Thompson was one of this county's best citizens. He was an industrious and enterprising farmer, upright and honorable in all of his dealings and held in high esteem. The funeral was held Sunday afternoon at the Truelove church, conducted by Rev. Chas. Vansant. **The body was laid to rest in the True Love Cemetery nearby.**

BEGINNING on a blackoak running due North 132 poles to a Birch & Spanishoak then due West 121 ½ poles to a whiteoak and chestnut, then due South 132 poles to a chestnut; then to the beginning. Surveyed March the 24th day 1832.

BEGINNING on a chestnut tree near Fultons trace running South 30 degrees West Ninety poles to Wm M. Stevens corner; then North Sixty West thirty poles to a Stake on Said Stevens line; then South thirty degrees West 196 poles along with James A. Darwin line to a Stake, then Arthur Fultons and Joseph Daniel line of 300 acre entry; then North twenty Nine degrees East 122 poles to Stake on Arthur Fultons and Joseph Daniel line of 300 acre entry; then North twenty Sixty degrees West 288 poles to a Chestnut tree; then North Sixty degrees West ninety two poles to the beginning, and by virtue of a deputation to me given by Crispin E. Shelton Surveyor for Said County, I have Surveyed the Said entry lying and being in Said County on both Sides of the trace that leads from Fultons Gap. Surveyed the 10th day of October 1833.

(pg. 160): CC-B: 347 & WB-A: 246 5 May 1834 – Fourth annual inventory by Exrs; total valuation \$80,361 (substantially the same as previous year). Richard Waterhouse says he has purchased the interest of Blackstone Waterhouse and **Myra Thompson (Mrs. Gideon)** for \$3000 each and paid for same out of the estate and will be therefore responsible for that amount and interest on same.
