Absalom 2 Looney was, almost certainly, born after 1726, because his name is not on the Augusta County muster roll of 1742 with those of four of his older brothers. Since Absalom had a "family" in 1753 or 1754 (as we shall see later), he was certainly older

that Peter 2 Looney who was born in Philadelphia in 1734. There may be a question as to whether Absalom or John 2 was the older because a John Looney was taxed in Augusta County in 1748. This tax, however, may have been merely for ownership of a horse, perhaps by a youth of 16 years, and John, as we shall see, married a girl born in 1739 or 1740. Thus we estimate that Absalom 2 Looney was born about 1729 +/- 3, before his parents came to America.

He probably lived with them on the upper Potomac River not so far from Hagerstown but on the south bank, and the school books that are referred to by some of the descendants of Michael Looney probably belonged first to Absalom who, rather than Michael, may have had brief schooling at Hagerstown at the age of 8 or 10 years.

Absolom Looney must have married in or very near 1750. He was living with his family on the Bluestone, a branch of New River, in 1753 or 1754 when his father Robert sent for him because of danger from the Indians at the outlying settlement and offered him part of the home place. Absalom and his family came and settled in the "Draft", on Draper's place, on land where his brother Daniel

had been living. Daniel 2 Looney made to Absalom (Abraham according to Chalkley's book) a deed dated 10 September 1754 (delivered in August 1763) for this place of 180 acres on Long Run, a branch of James River. Absalom bought 248 acres on the south side of James River in 1754. In 1759 he may have, for a short time, been in Carolina with his older brother Adam 2 Looney. This statement is based on the following evidence: On 11 October 1759 when Robert 1 Looney and Elizabeth agreed with their sons Peter and David, Robert 1 proposed to buy from Absalom his claim to some of the land. Accordingly, John Buchannon testified, in August 1764, that Robert 1 had stated that he, Robert, had paid Absalom L10 on Absalom's return from Carolina.

On 15 May 1765 Absalom and Margaret Looney deeded the 180 acres on Long Run to Peter 3 Looney, heir of Peter 2 Looney, and the deed recites a "corner of another tract belonging to Peter, formerly in possession of Robert Looney, Sr. " This deed is marked delivered on 26 September 1785. (Augusta Deed Book 12, p. 185; Chalkley II, p. 430.) In 1768 Peter Looney's executors mention cash paid to Absalom ("Abraham") Looney.

Absalom and his family probably moved from the tract on Long Run, perhaps a little further west, before or about 10 September 1767 when he patented 54 acres on Stone Run, a branch of Craig's Creek. (Augusta D.B. 37, p. 94) He must have lived here during much of the latter part of his life, "near Ripley's reference to his ancestor. On the same date Absalom 2 had a grant of 166 acres on Craig's Creek (according to Kegley). (Did he also

have a grant of 60 acres on 25 January 1769 on the south side of James River? See Kegley, page 348, at seq. This 60 acres was surveyed for Robert Looney in 1762.)

Absalom Looney and Amos Potts were appointed to review and report on a road on Sinking Creek, 13 March 1771. It is stated concerning early settlements in Tazewell County, Virginia, that Absalom Looney, "the hunter", discovered Abb's Valley on the Bluestone and settled there in the valley in 1771, but the evidence cited above indicates that the discovery and original temporary settlement may have occurred much earlier, in the 1750's.

The Absalom Looney, assignee of Benjamin Davis, who had a grant of 114 acres on Craig's Creek 1 June 1782 might be thought identical with Absalom 3 were it not that the survey of this land was made 1 November 1754 when the land lay within the limits of Botetourt County, Virginia. (Va. Grants Bk. F, 509.)

Concerning the wife of Absalom 2 Looney, the records yield only the name Margaret from the deed of 15 May 1765 when Absalom and Margaret conveyed the 180 acre tract on Long Run to Peter 3 Looney, heir of Peter 2. At this time 8 or 9 of Absalom's 11 children had been born.

William 6 Gaines Looney, in his manuscript on this branch of the Looney family, refers more than once to a second marriage for Absalom 2, but not with desirable clarity. First, he states that Michael 3 was son of Absalom 2 and "Peggy" of Craig County, Virginia (out from Botetourt Co.). Later, after the statement: "Michael was the eldest," he inserted a note "and 1/2 brother to all the other children." Again: "in the meantime Michael's half

brother and sister, Benjamin (known as Big Ben) and Mrs. Priscilla (Peggy) Caldwell settled in East Tenn., Ben in Stanley Valley, Hawking Co., and Mrs. Priscilla (Peggy) Caldwell in Knox Co., "

Among papers left by William Gaines Looney there is a reference to Mike as Absalom's eldest child "by Murldeen," or something like that.

From William gains Looney's remarks it is possible to make different assumptions concerning the wives of Absalom 2 Looney:

- 1. His 1st wife, mother of Michael, possibly named Murldeen, d. ca 1752. H m. (2) Margaret called "Peggy" who became mother of all the other children.
- 2..He m. (1) Peggy who d. at or shortly after the birth of Ann ca 1767 (and the removal from Long Run to Stony Run), and m. (2) the mother of Priscilla and Benjamin.
- 3. He m. (1) Murldeen, mother of Michael; m. (2) Peggy, mother of 8 children, Elizabeth to Ann, incl., and m. (3) the mother of Prescilla and Benjamin.

Aside from the reports b William Gaines Looney, no evidence has been found that Absalom 2 Looney married more than once.

Absalom 2 Looney's wife (or wives) must have died before 28 September 1791 when Absalom Looney of Botetourt County marked his will with an A, leaving 5 sh. to each of 4 sons and 7 daughters, and all else to son Benjamin without mention of his own wife. John Smyth and Stephen Holstine were named executors and he witnesses were Dan'l Givens, John Summerfield, Rich's Summerfield, and Will Givens. The will was proved at June Botetourt court 1796. (Will Book A, 426)

A deed was made in December 1791 by an Absalom Looney to Dan'l Givens for land on Craig's Creek and same was recorded in June 1792. An examination of Craig County records should yield something of value concerning this transaction.

Concerning Absalom's death, William Gaines Looney says: "Later he sent for his son Michael, then in Tennessee, to come to him, that they (meaning his son Ben's wife and her sister) were not good to him and when he got there he found him dead and buried him there."

An inventory shows Absalom's estate was appraised 20 July 1796 by Henry Holstein, Hugh Caldwell and John Taylor.

The children of Absalom 2 Looney were all born either on Long Run, a branch of the James River at the present Buchanan, a few miles southwest of Natural Bridge in that part of old Augusta County that became Botetourt County in 1770, or somewhat further west on Stone Run, a branch of Craig's Creek. The daughters, except Ruth and Catherine, were all married when Absalom made his will. No Bible record has been fount. Michael's birth date is known only as 1755 + or - from his listing in the 1850 census. The only complete birth date is that of Peter, as given by the family records of his descendants. Benjamin, as listed by census enumerators in 1830 and in 1840, was b. within the limits 1775 + or - 3. Birth dates for the other children as given below have been estimated to agree with what is known about those above mentioned and with the order in which their names are mentioned in their father's will.

(Reports of a son Donellson in the Absalom 2 Looney family have not been confirmed) Reports of a son John "killed by Indians" may have arisen because Jonathan often wrote his name Jon and Probably was killed by Indians. However, such a John 3 Looney could have been born ca 1760 and have been the John Looney who signed the Cumberland

Compact 1 May 1780 with his paternal first cousin Peter 3 Looney, Jr. and the latter's step relative James Cain, all three of whom may have been near the age of 20 years at that time. In any event, such a John 3 Looney had probably died without issue before 28 Sept. 1791 when Absalom 2 Looney made his will without mention of John or of his heirs.

(Query: Who was the John Looney with Robert Looney, both privates in Capt. Beard's Company of Guards, Territory south of the Ohio, in 1791?)

Third Generation (Absalom 2 Branch)

Michael 3 Looney, first child listed in the will of his father Absalom 2 Looney, was born say 1751. From the 1830 census of Hawkins County, Ten., he was born 1765 +/- 5 and his wife was listed in the same age group and it must be remembered that his father had a family in 1753 or 1754.

Michael was in Captain Henry Pauling's Company as No. 30 on the list of those present at the Battle of Point Pleasant, W. Va. in 1774; also in Lord Dunmore's Wat, [War wbl] 1775. Descendants say he claimed Revolutionary War service. His name on the monument at Point Pleasant is spelled Mical Luney. (Hist. of W. Va.): D.A.R. Nos. 287313 and 290259.)

(William 6 Gaines Looney, son of James 5 Gaines Looney, in his MSS says Michael 3 reported himself born in Hagerstown, Md. in 1743. It is established that Robert 1 and Elizabeth Looney lived on the Virginia side of the Potomac River not far from Haberstown from ca. 1735 to ca 1740, and it has been reported that Michael possessed one or more old school books that appeared to have been used at Hagerstown. This may be the source of a tradition that the family came to Virginia from Maryland. Some of Michael's

uncles may have attended a school at Hagerstown, but in view of census records the idea that Michael was born as early as 1743 must be rejected.)

Descendants say Michael m. in 1890 [1790 wbl] in Botetourt Co, Va., Temperance Cross, daughter of Brittain and Miss____(Cole) Cross, the mother of Brittain Cross being a Miss____Lane. Tempa is said to have told a different tale: That she ran away from home and followed her lover on a later boat from Ireland but never found him. She worked 3 years at 12 1/2 cents a day to pay for her passage and after that soon met Michael. They

probably married somewhat earlier that 1780, say ca 1778, because their 2d child was born 14 January 1781. It is said that Michael brought from Virginia only his gun, and "Tempa" her spinning wheel. They settled on the east fork of big Creek, ca 13 miles east of Rogersville in Stanley's valley, Hawkins County, in what is now East Tennessee. In August 1788 he purchased from Michael Edwards, at 12 1/2 cents per acre, a Stanley claim of 250 acres and a cabin, adjoining McMurray and David Gamble. Some say the purchase price was "a span of horses" or "a spotted horse and a long butcher knife.") Hawkins Deed 1, p.) The old 2-story log house is said to date from 1782 or 1784.

In 1783 Michael with his younger brother Jonathan and their 1st cousin Benjamin 3 Looney (Robert2), aged ca 32, 22, and 35 years, went on a long hunting trip in Kentucky on which Jonathan was captured and Benjamin killed by Indians near Cumberland Gap. (See Robert 2 Looney, Jr. Branch.)

In 1793 Absalom 3 and Michael 3 Looney testified in a suit,

Simmons vs Tillery and Wilson, Washington District of Tenn. The land in question was on big Creek, Hawkins County, and they proved that Wilson paid 2 horses, seemingly on 1 Sept. 1787 (Bk, 1, page 276, Overton Co., Tenn., records).

In November 1779 Wm. McGraw's judgement vs. Benjamin Looney (Michael's youngest brother) was recorded, and his 158 acres on the north side of Holston river and north side of Big Creek, adjoining Evan Shelby, was sold 22 February 1800. In May 1800 Michael 3 Looney received sheriff's deed for the place.

On 16 April 1808 land on Big Creek was deeded to Michael Looney and the witnesses were Benjamin Looney and A. Looney, Probably Michael's kinsmen Benjamin 4 and Sheriff Absalom 4, sons of Benjamin 3 (Robert 2 Jr), both of whom lived in Stanley Valley at that time.

Michael made a deed to his son John in 1827, to son Absalom 18 May 1829, and to Benjamin Jr in 1830.

Michael 3 is said to have been 5 feet 10 inches in height and to have braided his hair in a queue. James 5 Houston Looney (1828-1900), grandson, said he remembered Michael's death about 1836 to 1839. Miss Sallie Eugenia Brown said he died 1 January 1839. She further says that he died at the home of his son Benjamin on the old home place where Michael had gone to live after Tempa's death. They are buried in the "old Looney grave yard, high up the mountain, on the old place."

Upon reference to census records one finds that in the a 1830 census Michael and a female in same age group are listed as 70-80 (i.e. b. 1755 +/- 5) and are living alone except for a male slave.

They are not found in the 1840 census.

Peter 3 Looney, third child, should have been born, it would seem, on the 180-acre tract where his Uncle Daniel 2 Looney had lived, and the year 1755 is reasonable in time. It seems probable that this Peter 3 of Absalom 2 is the Peter Looney of Sumner County, Tenn., who was "born 24 Nov. 1755 in Botetourt Co., Va., " according to family records of descendants. In Sumner County he often wrote a capital H after his name and sometimes Harmon. This Peter Looney, we think, was probably he who in June 1776 signed a petition from the inhabitants of the western part of Fincastle County asking for a division of same. (Peter 3 of Adam 2 Looney enlisted 25 March 1776 in 6th S.C. Regt. and died in service 24 Sept. 1776.) Peter Looney (H) is probably he who worked 67 days under Capt. John 3 Looney (Robert 2), Bullock Master, about August to December 1776. probably in southern Washington Co., Va., or in western N.C. (including pre-Tennessee) after the men under Co. Wm. Christian

returned from the Cherokee expedition. Also Peter (H) probably signed on Nov. 1776 a petition from the inhabitants of Lower Washington Co., Va., Protesting the erection of a court house.

(Peter 3 of Peter 2 Looney was b. 1 Oct. 1760 and therefore only 17 at this time,) It seems of possible significance that this Peter (H) Looney, when signing the petition of 1777, signed just after James Brigham who had m. Lovice, daughter of Thomas 2 and Jane (Harmon) Looney. Perhaps, for example, Rachel, the wife of this Peter 3 Looney (of

Absalom 2), who later is found writing H or Harmon after his name to avoid confusion with Peter 3 or Peter 2 Looney, may have been Rachel Harmon and related to Margaret Harmon, mother of Lovice (Looney) Brigham, the daughter of Thomas 3 Looney.

It will appear elsewhere, in the account of Peter 3 of Peter 2 Looney, that said Peter 3 could not be the Peter 3 Looney (H) who settled and remained in Sumner Co., Tenn., but that he was indeed the Peter Looney (P) who left Sumner Co., and lived later in Lincoln and Marshall Counties, Tenn. Also, it will then appear that Peter Looney (P) and not Peter Looney (H) accompanied Robertson in 1779.

Descendants say that Peter and Rachel Looney of Sumner Co. came there as a young couple and that all their children were born there. Unfortunately, no record of the date of their marriage has been found and no complete list of their children. From the census records and all presently available data, the writer has reconstructed the family (see below) with adjusted estimated dates of birth. There may have been an older child of whom no evidence has been found, but otherwise the date of their marriage appears to

have been ca 1783.

If indeed Peter and Rachel Looney came to the Davidson area as a young married couple, it does not seem likely that they came as early as the Donnelson "Adventure" flotilla 1779-80. Certainly Peter and perhaps Rachel may, however, have been on Donnalson's flotilla but not yet married. Certainly Haywood's Hist. of Tenn, states that Peter Looney was with Donelson, whereas the pension papers of Peter 3 Luna (Peter 2) state that he arrived 2 days before Christmas 1779. This means that he came overland with Robertson.

In this connection, it should be remembered that Peter 3 (H) (Absalom 2) had an older sister Mary who m. (1) ca 1776 Edward Carvin (who was killed 1780) and m (2) in 1781 at Nashborough, Edward Swanson. Concerning this, Mr. Robert M. McBride of Nashville, in a letter of 3 Sept. 1960 to Elizabeth Looney, says: "The records do show that Edward Swanson came with Robertson and I would imagine that Carvin did also, his wife and sons being additionally accompanied by her brother, Peter, whom Donelson lists." McBride says further: "There are also per-emption (residence) grants to Peter Looney in Davidson County in 1783." This is shown by the Davidson County Pioneer Roll of Honor which Colonel Robertson presented to the North Carolina Legislature-North Carolina Cumberland Roll--January 7, 1783. Entry was made in 1783. (To L.W.T. it seems that this pre-emption was granted to Peter 3 Luna, son of Peter 2 Looney.) The original of the Cumberland Compact should be examined, also the land grants, to see if there were two Peter Looneys who signed the Pact and if, correspondingly, two pre-emptions were granted.

It is necessary to consider very carefully the two men named Peter Looney who for several years lived in Sumner County and used letters or names after their own to distinguish themselves: one using H or Harmon and the other using P or Pitman. Occasionally the added name was inserted as if a middle name. Peter, whose wife Rachel, appears early in time in the particular area that became Sumner Co. in 1786. Both Peters recorded their stock marks at the 1st court for Sumner in 1787. Peter (P) who came at about the same time afterwards moved to Lincoln and Marshall Counties and continued to be styled Captain. An important record for distinguishing these men is found in Sumner, called the Record of taxes, 1787-1794. Peter Looney (P) is there entered for 440 acres in 1787 and 1789, but for only 249 acres in 1791. On 14 July 1792, a Peter Looney of Sumner Co. was commissioned Captain of Militia of Sumner Co. and the tax list of 1792, 1793, and 1794 in which we find the Looney names entered are headed "Capt. Loonys Caompany." ("Capt. Looneys Company" wbl) The designation P is missing from the name of the Peter Looney who still is taxed on 249 acres in 1792 and the P does not again appear in these similar lists for 1793 adn1794. On the other hand the designation H appears as usual with the name Peter Looney, taxed for 640 acres in 1787, 1788, 1789, 1790 and 1793. It is thus directly inferable that Peter Looney (Pitman) was the Captain. In agreement with this, some of the entires (entries wbl) of Peter Looney (P) in the Sumner Co. Count Minutes are indexed as Capt. Looney. Further, it will be noticed below that Peter Looney (H) is closely associated with James Brigham, husband of Lovice, and with the families of Latimer and Briggance whose members intermarried with

descendants of Peter and Rachel Looney. therefore, in these pages we will refer to Peter 3 who m. Rachel as Peter (H) or Peter of Sumner Co., whereas Peter 3 (Peter 2) will be called Peter (P), Peter J., Peter of Nashborough, Peter of Lincoln, or Capt. Peter.

On page 1 of volume 1 of the Minutes of the first Court of Sumner Co, the name of Peter Looney, Harmon, appears among the jurors for the July term of 1787. On page 2 is a notation that he recorded a stock mark. He was on the Grand Jury in January and in April of 1789. an early document that applies to Peter Looney (H) of Sumner is land record 1313 in the State Library at Raleigh, N.C., concerning entry 476, 7 June 1785, for 640 acres on the E. branch of Drake's Creek on north side of Cumberland River in Davidson Co.; Wm. Montgomary's line; Henry Turney's line. This land seems to have been entered by Henry Hardin and assigned to Wm. Clarey, and then assigned to Peter Looney. The land was on the trace from Gaspers to Asher's Station. since it was "2 miles above Drake's Creek" on an eastern branch thereof, it may not have been distant more that 2 to 5 miles from certain lands, to be mentioned presently, that were on the west fork of Station Camp Creek. North Carolina grant No. 279 for this 640 acres was not issued to Peter

Looney until 10July 1788. This land was included in Sumner County in 1786 and Peter Looney (H) is found on the Tax List of 1787 for 640 acres.

Peter Looney (H) of Sumner may have been in Davidson County earlier than his purchase of the 640 acre tract, but no evidence is at hand. The Peter Looney on jury 6 July 1784 at Nashborough (Davidson Co. Minute Book a. 1783-1790, Pt. 1, p. 20, 29) may have

been Peter (3).

In October 1788 Peter Looney (Harmon), Robert Looney, and others were appointed (probably for jury duty) on the Superior Court. again, in January 1789 Peter Looney (H) was appointed with John Brigham and Robert Looney and others for April 1789.

In 1789 James McKain transferred lands on the west fork of Station Camp Creek to Peter Looney (Grant Book, p. 308), but neither Peter Looney (H) nor Peter Looney (P) seem to have been taxed for 640 acres each year from 1787 to 1793, inclusive, and for 970 acres in 1794.

Land record 1018 at Raleigh concerns entry of 6 Jan. 1790 for 40 acres on a branch of west fork of Station Camp Creek, Sumner Co.; Robert Cartwright's line; Jas. Franklin's line. This was entered by M. Armstrong, assigned to Wm. Nash, then assigned to Peter Looney. Grant No. 203 was issued 27 Feb. 1795. This is probably the same land mentioned in Davidson Co. Land Records 1788-1793, page 20, as grant to Peter Luna, "joining south bounds of Cartwright."

On 9 Aug. 1792 when Justinian Cartwright sold land on Station Camp Creek to James Gambling the witnesses were Peter Looney and Rachel Looney. (Sumner Deeds 1, p. 13(when administration on the estate of David Scoby, deed., was granted to ester Scoby in January 1794, the securities were Robert Looney and Peter Looney. On April 29 following, John Hamilton for L200 deeded land to Peter Looney (H). (In 1795 the acreage taxed to Peter Looney (H) increased 330 acres) On July 8 of the same year 1794 it was ordered {>>by hand at bottom of page 16<'James Gambling sold to Whitman Leggett Mar 31, 1851'}

that Robert Looney, Peter Looney (H), and Archibald Martin appraise the estate of Nath'l Latimer, decd. On 23 Jn. 1795 Peter Looney (H) deeded land to Patrick Mooney for \$300.

At the January court of 1801, John Looney, Peter Looney (H), and Issac Baker were on jury. In June 1805 Griswold Latimer, Peter Looney (H), Archibald Martin, rube Edwards, and Wm. Edwards were commissioners to lay off dower to Elizabeth Briggance, relict of Wm. Briggance, deed.

Peter 3 Looney represented Sumner county in the state Legislature in 1811-1813 and again in 1817. (Clarion and Tenn. State Gazette 10 June and 15 July 1817).

There are other Sumner county deeds to and from Peter Looney, but the writer has not examined them. Peter 3 Looney of Sumner County was living at the 1820 census, over 45 years of age, and one female, Rachel of course, was in the same age group. Two boys were 16 to 26 and two girls were 26 to 45 and 16 to 26. There were 3 male and 2 female slaves. At the 1830 census Rachel Looney was head of the household, aged 60 to 70; that is, born 1765 +/- 5.

This agrees with family records which give her birth as 26 June 1761, in Maryland. With her in 1830 were 2 males 20 to 30 to 40 and one female 20 to 30. Family records give the death of Peter 3 Looney or Sumner county as 1 Jan. 1830. At November court 1830, Charles Watkins, Jesse Gambling, Bright B. Harris, John H. Franklin, and Wm. Shaw were commissioners for dividing the lands of Peter Looney. (Deeds 12, p. 453). For dower, 137 acres and 25 poles were assigned. the other assignments from the same tract were: To Mary Looney 75 acres; to E. C. Looney 77 acres 1 rod 1

perch; to Jonathan D. Looney 77 acres 1 rod 1 perch; to Joseph Scoby and wife Elizabeth 77 acres 1 rod 1 perch; to Porter Baker and wife Martha 77 acres 1 rod 1 perch.

The family records give the death of Rachel Looney as 31 Aug. 1835. Her signed will is dated 16 June 1835, Sumner co.; probated November 1835. (Recorded in will Bk. 2, p. 199) Polly Looney, daughter, received the use of negro woman Sucky; Elizabeth Scoby, daughter, 1 bed and some furniture; Polly Looney and Jonathan Looney, son, 1/2 the proceeds of sale of Negroes, etc.; Isaac Looney, son, Edward C. Looney, son, and daughter-in-law Caroline Looney, 1/2 the proceeds of sale of Negroes, etc. Josiah Walton was names executor; Charles Watkins and Jesse Gambling were witnesses.

Peter 3 and Rachel {hand scribed>(Harmon)} Looney had at least 8 or 9 children:

Elizabeth Looney b. say 1784; m. Joseph Scoby, b. 1785 =/- 10, listed in 1820 census Sumner Co., Tenn., apparently with 11 children. In Nov. 1830 at the division of the real estate of Peter Looney, Joseph Scoby and wife Elizabeth received Lot No. 4, 77 plus acres. from Rachel Looney's estate in 1835 daughter Elizabeth Scoby received

1 bed and furniture and granddaughter Caroline Scoby received 1 bed and furniture.
Michael 4 Looney b. say 1786. See 4th Gen.
Isaac 4 Looney b. 1788. See 4th Gen.
Polly 4 Looney b. 1790 (Census 1850) received Lot No 1, 74A, from her father's estate in November 1830 and 1/4 of the Negroes from her mother's estate in 1835. she was still living in Sumner and alone at the 1850 census.

William Looney b. say 1793 was a member of this family according to Mrs. B.A.. Fowler of Brownwood, Tex.; she was a great-granddaughter of Isaac 4 Looney. There was a William E. Looney in Henry co., Tenn., in 1830 living near Jonathan D. Looney. this Wm. E Looney was born 1795 =/-5.

Jonathan 4 Davis Looney b 23 Jan. 1796. See 4th Gen. Possibly a child b. say 1799. Must have c. ante 1820 census. Martha H. Looney b. say 1802, m. 16 Feb. 1830 Porter Baker. In Nov. 1830 Porter Baker and wife Martha received Lot No. 5, 77 plus acres. They had no children. Martha died soon, or at least before 1835 when she is not mentioned in Rachel's will.

Edward 4 Carven Looney b. 1804. See 4th Gen.

(Mrs. B.A. Fowler includes a Jesse among the children of Peter and Rachel Looney, but it is possible that this was the eldest son of Michael 4 Looney and Caroline, who were m. 14 April 1804. It has been reported that their eldest son did not go to Missouri with his mother but remained in Sumner County. Who was Elizabeth Looney in Sumner Co. 1830 b. ca 1785 with daus. 20/30 and 5/10 and no males; also there 1840, with neighbor Moses Looney b. 1805 =/- 5?)

Jonathan 3 Looney was born say 1761, probably in Augusta County, Va., on the 180-acre tract. It is said that Jonathan 3 signed his name Jon and it is rational to believe that he came to Nashborough with his 1st cousin Peter 3 Looney Jr. on the Donelson "Adventure" and signed the Cumberland Pact on 1 May 1780 in such

way that it has been read and reported as John Loony. The earliest record seems to be in Botetourt County deed Book 3, page 177, On 2 Jan. 1780 odd (context suggests 1783) Jonathan Looney and Wm. Merchant witnessed an agreement between John Meguff and Catharana, widow of Isaac Barfield, concerning the distribution of her estate her children. The next record that may refer to him is the entry 297 on 16 Feb. 1784 for 640 acres of

land on the west fork of Station Camp Creek, in Davidson co., Tenn. Was this entry made on pre-emtion rights for Jonathan's early presence at Nashborough? This land was assigned by Jonathan Looney to David 2 Looney. his uncle, and N.C. grant No. 71 was issued 17 April 1786. (David Looney himself entered 640 acres, adjacent thereto, as entry 295 on the same day in February 1784, and N.C. grant No. 21 was issued to David on the same 17 April 1786. David paid L10 for every 100 acres of grant No. 21. see also No. 43 in N.C. grants, Sumner co., and Nos. 1097 and 1053 in N.C. Land records at Raleigh.)

Jonathan 3 Looney married in Lincoln county, Ky., 17 March 1786, Jane Harbeson; Rachel Harbeson was bondsman. (Doubtless Jane was related to Wm. and Mary Harbison of Botetourt Co. Wm. Harbison's will, pro. 1775 mentions day. Jean.) It is not unlikely that Jane was a sister to James Harbison who served in the Revolutionary War with absalom 3 Looney, brother to Jonathan 3, and married Ann Looney, sister to Jonathan 3 and absalom 3 Looney.

On 3 May 1817 Jonathan Looney and Jane (or Jean) Looney, his wife, conveyed 22 1/2 acres of land to John Silvertooth, all being of Lincoln Co. the land was on E. fork of Mulberry Creek, E. of Fayetteville. (Linc. Co. deeds D. 387). Witnesses were Thomas E.

Shaw and Thomas Whitworth. The description mentions Wm. T. Lewis, James Clark's line, and Wm. Brown's line; and Thomas H. Shaw relinquished rights and title to said land.

In the 1820 census of Lincoln Co., Tenn., Jonathan Looney is found, over 45 years of age with 1 female in same age group, and 1 male 16 to 26; no slaves. He was a farmer. A Tenn. Grant to a Jonathan Looney was made in Giles County in 1821 (book R, p. 200, Nashville)

An inventory of the personal estate of Jonathan Loony was recorded in Lincoln Co. on 9 Jan. 1824, as made by John Enochs, Admr.

An axe was sold to Jane Loony for \$1.00. (Line, Wills and Inventories 1810-1824, p. 383.)

It is not unlikely that Jonathan Looney was killed by Indians. According to William 6 Gaines Looney (Absalom 2 Branch), Jonathan was captured by Indians in 1783 when his cousin Ben 3 (Robert 2) was killed near Cumberland Gap. (See account under Ben 3 (Robert 2) Looney). William 6 Gaines Looney also says near the beginning of his "Genealogy" which he wrote for his children, "Jonathan Looney was reported to his brother Michael Looney to have been killed by Indians..."

On 31 May 1827 for \$700. Jane Looney sold to David Rhoten 110 +/- acres on E. fork of Mulberry Creek where Wm. Brown lived, mentioning corner of a 20-acre tract sold by John Silvertooth to Anthony Crowford. Witnesses were J.H. Shaw and F.G. Landers. (Linc. Deeds H, p. 75).

On 11 June 1827 Thomas H. Shaw conveyed to Jane Looney 110 +/- acres on E. Fork of Mulberry Creek, the consideration being the surrender of a bond which Jane "held on Shaw" for her maintenance during

life. Witnesses: F. G. Landers and J. Landers. (Link, Deeds H, 76)

No record evidence has been found to show who were the children of Jonathan 3 and Jane (Haberson) Looney. Circumstantial evidence suggests that among them were:

probably on the 180-acre tract on James River in Augusta Co., Va. (Mrs. Oscar Hughes Looney gives his birth as 1769, but this would make him only 11 when he enlisted in 1780.) He doubtless moved with his parents to the stone Run place on Craig's Creek when he was a young child. from the pension application of James Harbison (W 7707 BlWt 71, 190-160-55), it is known that both he and Absalom Looney volunteered in Botetourt Co., Va., in "the faul before the battle of the Cow Pens" (that is, in the fall of 1780) and served 6 months.

On page 201 of White's Mountain Men there is reference to an Absalom Looney as present at the Battle of King's Mountain. It is there stated or suggested that this Absalom was a son of Major David Looney, but David 2 Looney of Sullivan Co., N.C., has no son Absalom. David 2 did have a son Abraham born at about that time. There is no trace or suggestion that Adam 2 had a son Absalom, and Abraham 4 (Robert 3, Adam 2) was not over 5 or 10 years old in 1780. Therefore, an Absalom Looney, if at the Battle of King's Mountain, could be no other that Absalom 3 of Absalom 2 of Abb's Valley (unless we are to believe that Absalom 2 Looney at the age of

about 51 was there himself with his brother David 2 aged 44).

James Harbison, born 1763, was later to marry Absalom's younger sister Ann, born ca 1767. Others who, according to Harbison, volunteered at the same time and

served with them and were discharged at the same time were John Hawkins, James Mathers, Michael Shaw, William Reynolds, and William Walker. Harbison says they entered the service under Capt. James Robinson (Major David Campbell) and marched to South Carolina and were within 6 days' march of the battle of Cow Pens (17 Jan. 1781). They passed over through King's Mountain and thence to Ramsour's Mill, crossing on the dam in the night. Near the Mill they joined Morgan's Regiment and marched the Island Ford on Catawba River; and marched down the river to the Horse Ford. They heard the guns when General Davidson was killed on Catawba River, then marched to Salisbury in North Carolina, thence to Bland Ford on the Yadkin River. There were in a small battle with the British and Captain Henley was taken prisoner. They then marched to Virginia on the Dan River where they were discharged. His application was dated 13 Nov. 1832. This, of course, is also a statement of the service of Absalom 3 Looney.

The reference to Harbison's application is probably a satisfactory reference for the Revolutionary service of Absalom 3 Looney. It seems very unlikely, however, that he was at the Battle of King's Mountain for which the date is 7 Oct. 1780. Additional pertinent information may be obtained from other pension application papers: John Hawkins, Va., S5451; Wm. Reynolds, Va. S5982; Wm. Walker, Va., S6340, S7800, and S14780.

After the Revolution Absalom 3 Looney may have gone to Western North Carolina. In 1783 the Commissioners Absalom Looney, Isaac Shelby, and Anthony Bledsoe came to the Cumberland District to survey the lands set apart by the legislature of North Carolina for its soldiers of the Continental Line and others. (Tenn. Cousins, p.673). It is difficult to see how this could be other than Absalom 3 Looney unless it was David 2 Looney rather that Absalom who was the Commissioner.

On 7 Aug. 1789 Absalom 3 Looney acquired from Wm. Lee a claim to 640 acres on Little War Creek, near the mouth of Was Creek, on the southeast side of clinch river. (the entry, No. 2189, had been made by Stephen Williams in 1779.) North Carolina Grant No. 311 was issued 27 Nov. 1792 to absalom Looney and it recites, "where he now lives." (Nashville Book 3, p. 232; Case 423, N.C. Land Records, Raleigh, N.C.)

In 1793 Absalom 3 Looney and his brother Michael 3 Looney testified in a suit of Simmons vs Tillery and Wilson, Washington District of Tenn. the land in question was on Big Creek in Hawkins County. Absalom and Michael et al proved that Wilson paid John Bishop 2 horses, seemingly on 1 Sept. 1787.

Absalom Looney is mentioned as Justice of the Peace as early as September 1790. Gov. William Blount's Journal shows that he was reappointed for Hawkins Co. on 27 Sept. 1794. (territorial Papers of the U.S. IV, 462.) On 15 Aug. 1797 Absalom Looney and

William Elsey witnessed a deed from Wm. McClean to Wm. Vaughan for \$400 for 250 acres on Little War Creek on the north side of Clinch Mountain. (Hawkins Deeds 2, 433). Also on 15 April 1800

Absalom Looney and James Cope witnessed a deed from Wm. Vaughan to John Helton (\$200) fir 100 acres on north side of Clinch Mountain on a branch of Little War Creek; same was proved February 1801 by Absalom Looney. (Hawkins Deed 1, 353.)

John Seveir's Journal, November 1802, shows that the Commissioners on the night of Sunday, 21 November, staid at Michal Looney's (on big Creek in Stanley valley) and on Monday 22d he and General Rutledge crossed Clinch Mountain at Looney's Gap and traveled down the lower creek (probably Little War Creek) to Abs. Loony's.

Either Absalom 3 Looney (b. ca 1763) or Absalom 4 b. ca 1782 (son of Benjamin 3 and Mary (Johnson) Looney) was a member of a Masonic Lodge in Hawkins Co., Tenn., in 1805. (Tenn. Cousins, p. 58).

The Track Book in the Land Office at Huntsville, Madison Co., Ala., shows an entry on 18 Sept. 1809 by Absalom Looney for the southwest 1/4 of Section 12, township 4 South, Range 1 west, 160.19 acres in Madison County. The land records in Washington, D.C., however, indicate that Looney was an assignee of John Hunt who had entered 28 Aug. 1809 and it was a re-entry by Looney on 18 Sept. 1809.

Meanwhile, Absalom 3 was still in Tennessee where the tax list for 1810, Captain Looney's Company (probably Captain John), Hawkins County, included John Looney, 300 acres, 1 white poll; and Absalom Looney, Esq. 640 acres, 1 white poll and 1 black poll. Soon, on 27 Nov. 1810, by dead registered 6 May 1811 (Hawkins Deeds 6, 296), Absalom 3 Looney of Hawkins County sold to Mathias Click of same, for \$1000, 640 acres in Hawkins on north side of Clinch Mountain and south side of Clinch River, including the mouth of War

Creek, the same land granted by N.C., No. B, 311, to Absalom 3 Looney, The witnesses were Richard Mitchell, Samuel Wilson and Thomas Gillenwaters. No further, that is later, records of Absalom 3 Looney are found in Tennessee.

Further investigation shows that Jon. Hunt made his first installment payment at Huntsville, Ala. on 9 April 1810 as assignee of Jas. Manning. On 19 Aug. 1811 Absalom 3 Looney made the second installment payment as assignee of John Hunt. Therefore, it is

clear that Absalom 3 purchased John Hunt's interest between 9 April 1810 and 19 Aug. 1811.

There is a tradition that Absalom 3 Looney came to Alabama via Petersburg, Lincoln Co., Tenn. This is probably because Absalom must have known that his brother Jonathan 3 (and wife Jane) lived near there, and also that his cousin big Petter 3 Luna (Peter 2) was settling near there at about that time. (In 1810 Petter 3 Luna purchased a lot in Fayetteville.) It should be remembered that Jane (Harbeson) Looney may have been a sister to James Harbison who served in the revolutionary War with Absalom 3 Looney and m. Ann Looney, sister to Jonathan 3 and Absalom 3.

If Absalom 3 and family traveled via Lincoln Co., Tenn., on their move to Huntsville, Ala., they did not remain long there because on an 1811 tax list for Madison Co., Ala., Absalom was listed for 160 acres on Indian Creek, with 2 polls and 6 slaves. In 1812 he had 1 poll and 5 slaves.

Absalom 3 Looney made final payment on his 160 acres, about 2 miles south of Huntsville on Indian Creek, on 19 April 1810 and the Grant was issued, Certificate 75. On 23 Dec. 1816 Absalom

Looney was a purchaser at the sales of the effects of Jacob Sively of Madison Co., Ala. (bookCD,1,89).

Absalom Looney served on a jury for the week beginning 18 Nov. 1816. (Circuit court Min. 1815, book 2.) He was also names as a juror 17 May 1817, 11 and 12 Nov. 1817. (Orphan's Court book 1).

On 27 June 1817 the southeast 1/4 of Section 11, township 5 south, Range 1 east, 160 acres was granted to Absalom Looney. this quarter section was about 8 miles southeast of Huntsville. On 26 Feb. 1818 Absalom Looney purchased the northern half of Section 14, township 5 south, range 2 west (Certificates 1748, 1785); 320 acres. These 320 acres were about 10 miles southwest of Huntsville on or near Indian Creek and nearer Triana, onetime called Looney's Landing on the Tennessee River.

When Jacob Fuqua had license to marry Margaret Looney, on 25 Aug. 1818, Absalom Looney was surety.

No record evidence of the name of Absalom Looney's wife has been found. Mrs. O.H. Looney of Nashville reported in 1963 that Absalom 3 Looney m. 21 Sept. 1791 Peggy Wills.

The estate of Absalom Looney was appraised 19 Nov. 1818 by Robert Beaty, William Thompson, and Archibald McDonnell. John Looney was administrator. (wills and Inv. 208). The effects were sold at auction on 4 Jan. 1819 by John W. Looney; total receipts \$8,425.94. The list of sales recorded 22 June 1819 mentions 1 hog as having been killed for use of "the family." (Wills and Inv., 198.)

In the Huntsville republican of 28 Dec. 1821, John W. Looney, admr. of the estate of Absalom Looney, decd., advertised for rent

the plantation of 100 (160/ wbl) acres where Absalum (sp wbl)Looney lived, 2 miles south from Huntsville on Indian Creek; likewise the plantation belonging to the Looney estate at Big Cove. This may indicate that Absalom's wife survived him and, accordingly, that the real estate was not sold and divided immediately. In the notice of sale, accordingly, it was stated that the plantation would be rented for 1 year and possession given the same week.

Absalom 3 Looney died possessed of his home plantation of 160 acres near Huntsville, 320 acres, southwest, near Triana, and 160 acres about 9 miles southeast of Huntsville.

The widow may have died just before John W. Looney, admr., sold the home plantation to the Brandons on 3 Jan. 1825.

The children of Absalom 3 Looney were:

John 4 Warren Looney b. say 1793, Tenn. See 4th Gen. Margaret Looney b. say 1797, Tenn., m. (lic) 25 Aug., 1818, Madison Co., Ala., Jacob Fuqua. Absalom Looney was surety. About 1827 Ailas Fuqua was administrator or Jacob Fuqua, Franklin Co., Ala. and John W. Looney was guardian of Stokley and Perrine Fuqua. (Was Margaret Looney's name Mary Margaret and was she the one called "Polly" by tradition?)

Martha Looney (called Patsy) b. say 1801, Tenn., m. Col. Fleming Hodges (who d. ca1828) by Jo. Smith, J.P., 14
Apr. 1823 as 2nd wife. (Morgan Co., Ala., lic.)
Absalom 4 Looney b. 1809, Tenn. see 4th Gen. (according to tradition, there was a "Susan" in this family. Is there any connection with Elijah Looney b.

Benjamin 3 Looney was born ca1774, say, perhaps on the 54-acre tract on Craig's Creek, Augusta Co., Va., which his parents had purchased 10 Sept, 1767. Benjamin married in Botetourt co., license of 22 July 1793, Elizabeth McClure. By his father's will dated 28 Sept., 1791, proved in June of 1796, Benjamin received all the estate except 5 shillings to each of his brothers and sisters. On the 27th of October following proof of the will, Benjamin Looney sold to Isaac Taylor, both being of Botetourt co., the 54-acre tract on Stone run, a branch of Craig's Creek. (Botetourt Deeds 7, 317). Stoney run was the name of the stream when the land was in Augusta Co.; much later and after it became Botetourt CO/ the falls became known as Buttermilk falls and then Meadow Creek and fall. After 1851 the land was in Craig Co., VA.

On 25 Feb. 1798 William McGraw deeded to Benjamin Looney for \$666 2/3.; 58 acres on north side of Holston river and north side of Big Creek, adjoining land surveyed for Evan Shelby. Gabrial McGraw and Drury Holt were witnesses (Hawkins Co., Tenn., Deed 2, p. 375.) But Wm. McGraw sued Benjamin Looney 10 Dec. 1799

for \$218.90 and obtained judgment, recorded Nov. 1799. Sheriff Alexander Nelson of Hawkins sold the 158 acres to Michael 3 Looney 22 Feb. 1800 at public auction to satisfy a judgment of \$218.90. (Hawkins Deeds 1, p. 307).

At the 1830 census of Hawkins Co., Benjamin 3 Looney (b. 1775 \pm) wife in same age group are listed with 1 boy b. 1812.5 \pm (probably Absalom), 2 females b. 1805 \pm 5, 1 girl b. 1822.5 \pm 2.5, and 1 girl b. 1827.5 \pm 2.5.

At the 1840 census of Hawkins he is listed as Benj. Looney Sr. (b. 1775 +/- 5), with 1 female in same age group and with 1 female b. 1805 +/- 5), and another b. 1837.5 +/- 2.5. Benjamin 3 Looney is not found in 1850 in the census of Hawkins Co. It is presumed that he died between 1840 and 1850. Benjamin 3 Looney was known as "Big Ben" according to tradition. The children of Benjamin 3 and "Bettie" (McClure) Looney are given by collected family accounts, census records, land records, etc., as:

William 4 Looney left Hawkins Co., Tenn., at an early age and about all his Tennessee relatives seem to have known about him is the report or tradition that he went to Arkansas, married there, lived on Red River, and was drowned in it. However, from local histories in Arkansas, it is found that he came there about 1802 and "was the first white man to settle on Elevenport River," Randolph Co., Ark. With him or soon thereafter came at least one of his "cousins", the Stubblefield brothers. (Memoirs of N.E. Ark., Goodspeed Publishing Co. 1889, p. 408; Hist. of Randolph Co., Ark., P.____, by Lawrence Dalton). It is said that William 4 Looney brought 3 negroes with him and that he had to travel 135 miles to Cape Gerareau to buy groceries.

Some accounts of the family of Michael 3 Looney append the names of Andy, Coleman and Bob who were children of Polly Stubblefield and some of these Stubblefields or Looneys were early in Arkansas with William 4 Looney. Concerning these three, W. 6 G. Looney says that Michael gave them money and they went down the Tennessee River to the Purchase, Sweetwater Valley, Tenn.

William 4 Looney and his wife and Arkansas family are listed in the 1830 census of Lawrence Co., Ark. A Theny Looney was also listed there in 1830 as head of a household. They are both listed in 1840 in Randolph County (which was taken from Lawrence). Thus They may have been the relict of a son born early to William 4 Looney after his arrival in Arkansas.

From Arkansas census records of 1830 and 1840 (Davidson Twp.). it is possible to deduce approximate birth dates for some of the family of William 4 and from the 1850 census to suggest the names of three of his sons. Caroline Latimer, bond 4 or 14 April 1804; Joseph Scobey (Michael's brother-in-law) was security. Caroline b. May 1785 was the daughter of Charles Latimer (Sumner Wills Book 1, 63).

Michael Looney enlisted in Sumner Co., Tenn., on the first day of Sept. 1813 for 3 months in the War with the Creek Indians and Great Britain, and he was discharged at Ditto's Landing in Madison Co., Ala. The U.S. Treasury Department certified that he served in Capt. Wm. Edward's Company, 2d Regt. of Tenn. Volunteers under Col. Newton Cannon, from 24 Sept. 1813 to 9 Jan. 1814. Caroline's application for Bounty Land was dated 29 May 1851 in Shelby Co., Mo. Her marriage to Michael was certified by Isaac Looney and Nicholas Latimer of Sumner Co., Tenn., on 27 June 1851. (Caroline gives the date of her marriage as 19 April 1805 by Col. Edward Douglass, J.P. See date of Sumner marriage bond above).

Michael was a slave holder and trader and lived in Sumner Co. in 1820 with wife, 5 boys, and 2 girls. In April of 1825 or 1826 he started for New Orleans upon a flatboat loaded with slaves

and bacon. His family never heard of him again except for a report that he had been robbed and murdered in or near Baton Rouge, La.

Before 1830 Caroline Looney and her children moved to Missouri (perhaps with some of the Latimers) and settled on what was later called Looney's Creek, about 30 miles west of Palmyra, Mo., in what was once Ralls Co., then Marion Co., and became Shelby Co. in 1835. At the census of 1830 for Marion Co., Caroline Looney is listed with 4 boys and 3 girls. In Ralls Co. there was a land patent issued to Caroline Looney on 14 Oct. 1835 for the N.W. 1/4 of the S.E. 1/4 of Section 6, Twp. 58, of Range 9 W. (This land may have been "entered" long before the patent was issued.)

In 1840 Caroline is listed in Shelby Co. with 2 boys and 2 girls. At the 1850 census of Shelby Co., Caroline has only Isaac 29 and Mary M. 26 still with her, and it is recorded that Caroline was born in Connecticut.

On 14 May 1855 Caroline Looney of Shelby Co., Mo., made an affidavit for the purpose of assisting Sarah (Latimore) McKetchan in obtaining bounty land for services of her husband, Robert Mcketchen, in the War of 1812. On 17 Oct. 1879 Sarah McKetren of Shelby Co., Mo., made affidavit that Caroline Looney was dead. The children of Michael 4 and Caroline (Latimer) Looney were:

Charles Looney. Probably d.y. and buried in Tenn. if indeed there was a child of this name in this family. Jesse 5 Looney b. say 1805. Relatives in Shelby Co., Mo., thought that Jesse remained in Tenn. The 1820 census of Sumner Co. shows that a son existed in this family of about that age.

Mary M. Looney b. 16 July 1824, d. 24 May 1905; unmarried; buried on lot of William T. Looney, Mt. Zion Baptist Cemetery, Shelby Co., Mo.

(Five of the ch. of William 5 Carroll Looney (listed at the 1850 census) were: Caroline b. 1842, Mary f. b. 1844, Louisa b. 1846, Malissa b. 1848, and Sarah C. b. 1850.)

Much of the above data on the children of Michael 4 and Caroline Looney was supplied by Miss Elizabeth Looney of Washington, D.C., who has also collected information of the descendants of William 5 Carroll Looney for several generations.

Isaac 4 Looney (Peter 3) was born in 1788 according to the census of 1850, his pension papers, and his affidavit of 1871. (Mrs. Fowler says b. 1780-d. 1879.)

During the War of 1812 Isaac 4 Looney enlisted at Gallatin, Tenn. 10 Dec. 1812 in Capt. John W. Byrne's Company of Tenn. Militia and served as a Sergeant until discharged 9 Feb. 1813 at Nashville. He enlisted again 4 Oct. 1813 and served as a Lieutenant in Capt. W. McCall's Company, Col. Wayne's Regiment of Genl. Robert's Brigade of Tenn. Militia until discharged 4 Jan. 1814 at Fayetteville, Tenn. His declaration of 1855 regarding services was witnessed by Whitmell Leggett and James L. McKain; other declarations in 1851 and 1871.

Isaac 4 Looney m. (bond, Sumner Co.) 29 Feb. 1810, Betsey Briggance, and Joseph Scoby, his brother-in -law, was bondsman. Betsey was b. 1792 (1850 census of Sumner Co.) and died ante 1871 when Isaac was "not married."

On Aug 15, 1818, Isaac Looney and Elizabeth Looney conveyed to John Mitchell for \$140 117 1/2 acres on the waters of the Middle Fork of Station Camp Creek. (Sumner Deeds 10, 305.)

When the paternal lands were divided in 1830, Isaac did not participate, but in 1835 after Rachel's death Isaac, Edward C., and their niece Caroline)of Shelby Co., Mo.) received 1/2 of the proceeds of sale of the Negroes, etc.

On 15 Jan. 1830 Isaac Looney made entry (No. 718) of 50 acres on head waters of Station Camp Creek, beginning at a hickory in the line of Peter Looney, decd. Similarly, on 12 March, 1841 he made entry (No. 968) on 50 acres beginning at the N.W.

Dr. Jonathan 4 Davis Looney (Peter 3) was Born in Sumner Co.,

Tenn., January 23, 1796. He was educated as a physician and married in Sumner Co. November 9, 1819 to Harriett Hassell, born January 23, 1804. The clergyman was Reverend Hardy M. Cryer.

Dr. Looney went to Limestone Co., Alabama, and practiced there from 1822 to 1825.

Then in 1826 he moved to Henry Co., Tenn., where he practiced till he died in 1867.. His wife Harriett died Oct. 6 1861.

The following list of the children of Dr. Jonathan 4 Davis Looney and his wife Harriett (Hassell) Looney was furnished in 1939 by Miss Corrine Diggs of Paris, Tenn., from the Bible in possession of Miss Emma Looney, granddaughter of Dr. Jonathan 4 D. Looney.

Edward 4 Carven Looney (Peter 3) was born in 1804 in Sumner Co. Tenn. He married 5 Jan. 1834 Sally Dempsey b. 1809. (Sumner records say he m. 1 Jan. by Jessee Gambling, J.P.) He was evidently named for Edward Carven, first husband of Mary 3 Looney who was next younger sister to Peter 3 Looney. (this Carven name here confirms the

conclusion reached in studying the two Peter Looneys of Sumner Co., namely that Peter 3 who married Rachel was son of Absalom 2 Looney.)

Edward 4 Carven Looney was living with his parents in Sumner Co., Tenn., in 1820 and 1830. In 1840 he was listed in Sumner Co. (age overstated as 40/50 with wife's age understated as 20/30, 1 dau. 10/15, i.e. Bennetta 6, and 1 son 0/5, i.e. Peter Davis 2). In 1850 they had moved to Henry Co., Tenn., and all 6 children are there listed with correct ages. (Mary had died even before the 1840 enumeration.) Edward 4 Carven Looney d. 11 June 1862. Sallie Looney d. 26 Aug. 1891.

Jonathan 4 Looney (perhaps Jonathan 3) was born say 1789. He married May 1809 Mary Holstine, daughter of Henry Holstine Jr. and Margaret his wife.

The 1810 census of Botetourt Co., Va., shows wife and 1 child, the 1820 census of Wayne township in Champaign Co., Ohio, shows wife and 5 children; the 1830 census there shows wife and 7 children, but 4 of them were under 10. Therefore, they had at least 9 children. Botetourt Co., Va., records show, sometime after 1807 (see Deeds 9, p. 317), a power of attorney from Jonathan Looney to

T. Anderson of Botetourt to sell interest in lands or Henry Holstine that descended to Johnathan's wife "Mercy." Her birth is fixed by the census records as 1785 +/- 5.

Joseph 4 Looney (perhaps Jonathan 3) was born say 1792. He was certainly of age in Dec. 1815 when in Giles Co., Tenn. he was appointed with John Colewell as administrator of estate of Wm. Colewell. Joseph Looney of Lincoln Co. Tenn. made will 18 Oct. 1817; proved 4 Nov. 1817 by Thomas Henly and John Acuff. Wife Caty and unnamed children. Abner Buckley Executor. Witnesses: Thomas Henly, John Acuff, Sarah Acuff. Account of sales signed by Joab Buckley, Executor. (Line. Wills and Invs., 210, 231.)

John 4 Warren Looney (Absalom 3) was born ca 1793 on the 640-acre tract which his father on 7 Aug. 1789 acquired from William Lee. It was on Little War Creek, near the mouth of War Creek, on the southeast side of Clinch River. The grant, N.C. No. 311 issued on 27 Nov. 1792 to Absalom 3 Looney, recites "where he now lives." The land was then in Hawkins Co., but now is probably near Treadway in Hancock Co., Tenn.

John Warren was probably the eldest child and was about 17 when the family moved to Alabama. Descendants of John Warren Looney have a tradition that the Absalom Looney family came to the Huntsville, Ala. area from Petersburg, Lincoln Co., Tenn. John Warren Looney had an uncle, Jonathan 3 Looney and wife Jane who were living just southeast of Petersburg on the E. Fork of Mulberry Creek at that time and a cousin, Peter 3 (Peter 2) was just moving

from Sumner to Lincoln Co. and had bought a lot in Fayatteville nearby. Possibly, then, Absalom 3 moved his family from Hawkins Co. to Alabama via an overland route and visited relatives in Lincoln Co. Incidentally, there were several families named Warren in the early census records of Lincoln and John Warren Looney may have had maternal relatives there.

He married, license 8 Feb. 1815, at Huntsville, Madison Co., Ala., Nancy Campbell b. 1794 Va., daughter of Elizabeth Campbell and granddaughter of Owen and Elizabeth Cammel who moved from Culpepper Co., Va. to Gallatin, Tenn., to Huntsville, Ala. The sureties on the marriage license were Jacob Fuqua and Absalom Looney. Owen Campbell lived on 160 acres which he purchased 18 Sept. 1809 about a mile south of Absalom Looney's first purchase - his home plantation on Indian Creek.

John Warren Looney, aged about 25 and married 3 years, made his first land entry 4 Feb. 1818 for 82 acres, the W 1/4 of the NE 1/4 of Section 35, Township 4, Range 2W. This land was about 8 miles west southwest of the Absalom Looney home plantation on Indian Creek and was probably John W. Looney's first homestead. (When he sold it in May 1829 to his brother Absalom 4 Looney, Nancy the wife of John w. Looney signed the deed.)

After the death of Absalom 3 Looney, John W. Looney was appointed administrator with a bond of \$10,000 signed by John Hogan and James Neeley on 25 Oct. 1818. When the personal property of Absalom Looney was sold on 4 Jan. 1819, John 4 Warren Looney was the principal purchaser--to the extent of \$ 932.50. The plantation was rented at the same time to Thomas Cain for \$ 610.00. No account of

settlement of the estate has been found.

In Sept. 1819 John Warren Looney was a witness to the will of Abner Tatum and also one of the appraisers. He was appointed Justice of the Peace 21 April 1821.

The home plantation where the Absalom Looney family lived, or at least 100 acres of it, was again offered for rent in the Huntsville Republican, 28 Dec. 1821; also the plantation of the Looney Estate at Big Cove. In March 1825 John W. Looney seems engaged in horse breeding and had a stable 1 1/2 miles west of Mullen Creek and 5 miles from Traina.

On 13 April 1824 John W. Looney sold to Edward H. Vann all that 1/4 of section 11 which was granted to Absalom Looney by Grant dated 27 June 1817. (Madison Deeds IJ, 31.) On 8 Jan. 1825 John W. Looney and wife Nancy sold to Thomas and William Branden the SW 1/4 of Section 12, the original Looney homestead in Madison Co., purchased by Absalom Looney, assignee of John Hunt, and granted to said Looney, Cert. No. 75, in 1814. (Madison Deeds IJ, 400.)

During the years 1820 to 1826 there were a number of lawsuits by John W. Looney against various persons indebted to him and some against him for like cause.

John W. Looney was a miller and millwright and in 1825 he wished to build a water grist mill and other water works on his land on the waters of Indian Creek at Lanier's Ford. He owned land on both sides of the creek, but the dam might cause part of the land of Isaac Jackson, John C. Ayers, and the Burwell C. Lanier estate to be overflowed. A court action was taken to have 7 freeholders meet on the premises and assess possible damage to the

above mentioned and any other parties, and to report in August. At February court 1827 Looney was granted permission to erect his mill upon paying Isaac Jackson \$ 2.00 per acre for 5 acres what might be overflowed.

In the Democrat of Huntsville on 20 Feb. 1827 Looney's warehouse at his mill on Indian Creek was announced as partly finished and ready for storage of cotton.

On 23 Nov. 1827 the state brought action against John W. Looney for maintaining a common nuisance. The action was continued from time to time and on 19 Nov. 1828 a jury found the defendant not guilty. (John W. Looney himself was a juror at the fall term of court in 1828).

In the Democrat of Huntsville, Ala., for 28 Nov. 1828, John W. Looney announced that his mills were in complete order and ready for the reception of cotton. After the death of Owen Cammel in 1824 in Madison co., Ala. (will dated 5 April and proved 6 May, Minutes of Orphans Court 3, 72), John w. Looney was named sole executor. He gave bond of \$ 6,000 on 7 May 1824. The goods and chattels were sold on 5 Dec. 1826 on 12 months' credit, and 1/4 section of land was sold on like credit on 4 Aug. 1828 by John W. Looney, Executor, to Stephen S. Ewing for \$ 455.00. (Madison Deeds L, 519). Settlement was made 13 May 1834. (Minutes of Orphans Court No. 3, p 494, 495.)

During the years 1831 to 1837 John W. Looney entered and purchased land at least 5 times, a total of 520 acres. With wife Nancy he sold the "mill tract" on 21 Nov. 1834 to Thomas Fearn, George Fearn, Alfred Howell, and Thomas Patterson. This sale included

mill, mill house, etc., on 240 acres entered by J.W. Looney in 1818 and 1831. (Madison Deeds P, 263). On 13 March 1848 John Warren Looney and wife Nancy sold to John Ward and Hamilton G. Bradford for \$ 6,240 a total of 520 acres including 320 acres purchased by Absalom Looney 26 Feb. 1818. (Madison Deeds W. 583). This probably included the plantation on which they were living, about 5 miles N.E. of Trians, just before the family removed to Texas.

John Warren Looney made trips to Texas in 1845 and in 1846 to purchase lands, chiefly on both sides of the San Antonio river in Goliad, Victoria and Regugio Counties; also southward in the San Patricio Co.

(Insofar as the writer knows, no systematic searches have been made in Texas to locate these lands. At least one deed is recorded in Austin, Texas, from Isaac W. Johnson to John W. Looney of Alabama, dated and acknowledged at Goliad, Texas, on 22 Jan. 1847, for 1'3 of a league of land--that is, about 1480 acres. At least 3 surveys to Jno. W. Looney in Refugie Co. have been brought to the writer's attention, for 1,342, 800 and 133 acres.)

In 1848, after selling all lands in Alabama, he started for Texas with most of his family and all moveable possessions. Mrs. Mary Ellen (Campbell) Capen, a granddaughter, has given traditional accounts as follows:

Mrs. Nancy Looney and her mother Elizabeth rode all the way in a handsome carriage with silk lining, tassells, folding steps, and glass doors "similar to but finer" than the one that she had seen late in life at Mt. Vernon! (Years later the carriage was used by some of the grandsons on hunting expeditions

A slave called Uncle Steve sat on a high front seat and drove the span of horses that led the caravan. Next came a 3-seated back or "ambulance" driven by son-in-law Harrison Campbell, with his wife Susan (Looney) Campbell and their 6-month-old twins; also 2 slave girls to care for the babies. The furniture, etc., and other children and grandchildren followed in "covered wagons"; and there were 17 other slaves to drive the horses and cattle. (Census records show that John W. Looney owned 7 slaves in 1830 and 17 in 1849).

The well-traveled trail led through San Augustine and/or Nacegdeches where John warren Looney died and was buried after an illness (dysentery) of very short duration. His last words in answer to Nancy's questions were, "By all means go on to Goliad." This they did and finally they saw in the distance, shining in the sunlight, the (deserted) white adobe dwellings of the once populous Mexican town of La Bahia, not far beyond Goliad. they had stepped at a small stone store near a few picket houses and log cabins. "How far to Goliad?" they asked, the answer was. "You're in Goliad now." At his Mrs. Harrison Campbell, mother of the twins, exclaimed, "My God, and we've traveled this far to such a hole." Whereupon it is said she cried day and night for three weeks.

They moved into log cabins with dirt floors. Some of the group returned soon to Alabama. It was years before they saw the first frame house built in Goliad. Mrs. Looney knew nothing about her land or their value. She signed deeds from

time to time to get money to live on. A lawyer obtained custody of her box of deeds. courthouses were easily burned in these days and in some cases possession of the land could be taken without title.

Mrs. Nancy Looney died in 1868 at Goliad, probably without realizing the benefits that John Warren Looney had expected through removal of the family from Alabama to Texas. At the 1860 census, however, she was listed in Goliad, Texas, as having real estate worth \$30,000 and personal property of like value.

Absalom 4 Looney (Absalom 3) was born ca 1809 probably in western Hawkins Co. (now Hancock), Tenn., on Little War Creek. He married (lic. 25 Feb.) on 1 March 1826 by A. Bransford, J.P., in Madison Co. Ala., to Alsaderah A. Will who was born ca 1810 in Virginia (Tishomingo Co., Miss., census of 1850). (Possibly Alsaderah was a young sister to Richard Will of Tishomingo Co. Miss. (census of 1840 and 1850) who was b. in Va. 1802. She was a dau. of Benj. Winn and Creasy (Andrews) Win.)

Absalom Looney received title to the west 1/4 of the N.W. quarter of section 35, township 4, range 2 west by deed dated 7 May 1829 from John W. Looney and wife Nancy. (Madison deeds M. 326).

Although a consideration of \$ 800 was specified, it is probable that his land was transferred in connection with the settlement of the Absalom 3 Looney estate.

At about the same time Charles Betts sued Absalom 4 Looney and John 4 W. Looney and obtained judgment for \$67.86. Then in the same month Ferney and Pike obtained judgment and costs against Absalom 4 for \$189.42. Consequently the sheriff sold Absalom's land on 19 Nov. 1829.

Absalom 4 Looney is not found listed in the 1830 census of Madison Co., but the listing for his brother John W. Looney indicate that an extra male, 20-30 years, was there, possibly Absalom 4 Looney. No entry that can be considered that of Alsadorah Looney in 1830 has been noticed. Later census records indicate that Absalom 4 continued to live in Alabama until his 3d child was born ca 1836.

At the 1840 census Absalom 4 was in Tishemingo Co., Miss., with wife and 5 children. He was still there in 1850, a farmer holding real estate worth \$32,000. From the census records and a letter written by Mrs. J.O. Looney of Nashville, their children were as follows:

He then took his eldest son William to Miss. and Texas. At the 1860 census of Goliad Co., Texas, he is listed as T. Looney, Trader, age 40, born Ala., living in a hotel or boarding house. At the same time in the family of his brother A.5 J. Looney, trader, 27, born Ala., one finds W. Looney 17, Trader, born Ala. (also the cousins Tom, Robert T., and Sam Grantland).

Meanwhile, in Madison Co., Ala., grandmother Sarah F. Bailey had custody of the 2 children James B. and Henry H., but John B. was kept by an aunt Elizabeth Smith. After the death of grandma Sarah F.
